

## Voluntary Demographic Questionnaire Data

In compliance with Business and Professions Code section 26244(c) of the California Cannabis Equity Act, the Office of Cannabis Management (OCM) has collected voluntary, deidentified, aggregate demographic data on equity applicants and permittees, as well as other applicants and permittees in the jurisdiction. From February 2021 to December 2024, a total of 159 individuals provided their voluntary responses to OCM’s demographic questionnaire.
