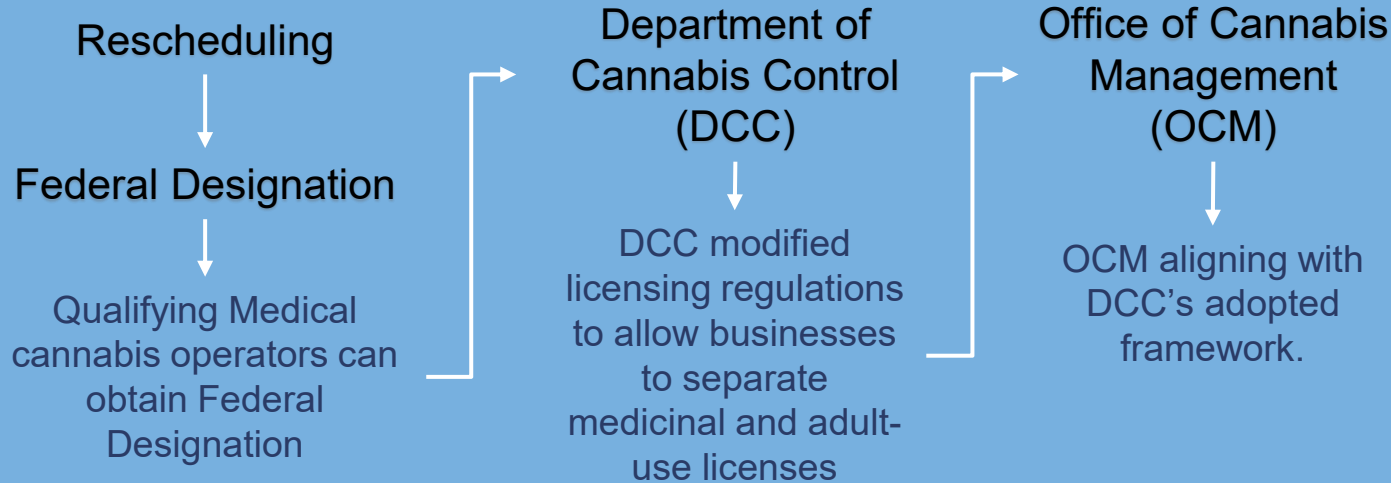
2025-26 Supplemental Distribution Grant

❖ Approval from State (CEG) for grant to distribute remainder of grant funds

- Approximately \$500,000
- Qualifications:
 - Current on loan payments
 - Received a grant in 2025-26 (Fall/Winter/Spring cycles)
- OCM will provide an application link
 - Keep an eye on your email for the link *****YOU MUST APPLY VIA LINK TO RECEIVE GRANT*****
 - Self-attestation of your current BOP application (tier) status
