Highlights

Survey Background

National Research Center, Inc. (NRC) at Polco worked with the City of Sacramento on a survey of residents about Animal Care Services provided by the City. The results will be used for planning important programs and decisions on animal care services for the City.

The survey was hosted on the City's Polco online civic engagement platform and was open from July 23, 2021 through August 27, 2021. A total of 695 responses were received. With non-probability surveys such as this one, the precision of the estimates applying a Baysian credibility interval for a sample of 695 surveys is ±7%. Results were statistically weighted to represent the greater population of Sacramento. (For more information on the survey methods, see *Appendix C*.)

Key Findings

- When asked about important focus areas for the City of Sacramento, Animal Services scored high. Only safety and openness and acceptance of residents were given higher priority ratings.
- Many of the survey respondents reported using Animal Services previously. About 8 in 10 had visited Sacramento's Animal Services-Front Street Shelter with the most common reasons to adopt or license a pet. About three-fourths preferred appointments to walk in services.
- Dealing with stray and injured animals and providing lost and found services were considered the most essential programs
 offered by Animal Care Services. Picking up or investigating dangerous animals also were considered essential or very
 important by nearly all residents surveyed.
- Access to affordable veterinary care was rated as excellent or good by fewer than 40% of survey respondents, and 9 in 10 rated services related to increasing the affordability of care to all residents and services for pets of low-income residents as essential or very important.
- Investigating animal neglect was a high priority of residents, although opinions were mixed on prosecution versus alternative programs. A majority of residents felt that action should depend on the seriousness of the neglect.


Community Perspective on Importance of Animal Services

About 8 in 10 respondents considered animal services essential or very important as a community focus in the next 2 years.

Of the 10 items rated, Animal Services was considered the third most important from the list.

(Percent rating as essential or very important)






Visits to Sacramento's Animal Care Services – Front Street Animal Shelter

About 8 in 10 respondents had visited the City of Sacramento's Animal Care Services – Front Street Animal Shelter at least once.

The most common reasons for the visits were to adopt a pet, or to license a pet.
About 3 in 10 respondents who had every visited the shelter had done so to drop off a stray animal.




Pet Adoption and Pet Ownership

About half of survey respondents had ever adopted a pet from one of Sacramento's local animal shelters. Most commonly the pet had been adopted from the Front Street Animal Shelter (see Table 14 in *Appendix A: Frequency of Responses to All Questions*).

About three-quarters of respondents reported currently owning one or more pets.

Have you ever adopted a pet from one of Sacramento's local animal shelters?






Preferences for Interacting with Shelter

Most survey respondents (about two-thirds) would prefer that if their pet became lost, the person who found their pet temporarily house and attempt to bring the animal directly to them rather than have their pet be taken immediately to the shelter.

If they needed to conduct business at the shelter, three-quarter of respondents said they would prefer to make an appointment than wait on a first come, first served basis. If your animal became lost, would you rather the person who found your animal temporarily house and attempt to help return the animal to you without bringing it to the shelter? Or would you rather your pet be immediately transported to the shelter?






Preferences for How the City Deals with People Who Neglect Animals

Respondents with a definite opinion on how the City should deal with people who neglect animals had a small preference for criminal prosecution (25%) over an alternative program (20%). However, more than half of respondents felt the choice should depend on the severity of the neglect.

There are a number of ways the City can deal with people who neglect animals. (Pet owners who fail to provide reasonable care such as food/water/shelter/veterinary care). One option is to prosecute these people through the criminal justice system. A second option is to create a training and educational program offenders would be required to attend similar to traffic school. Which of these options do you think the City should pursue?






Importance of Services Provided by the City's Animal Care Services

The services shown in the chart to the right are those that were considered essential or very important by more than 85% of respondents.

Virtually all respondents felt that responding to stray, sick and injured animals and providing lost and found services were important services.

About 95% believed it was essential or very important for the Animal Services to investigate (and prosecute, if appropriate) cases of animal neglect and cruelty; to respond to stray dangerous and vicious animals, and to investigate complaints about dangerous animals.




Importance of Services (continued)

The services shown in the chart to the right are those that were considered somewhat less important by respondents compared to other animal care services. However, many of these were considered essential or very important by 60% or more of respondents.

The two services considered least important by respondents were responding to neighbor complaints related to owned animals and providing pet behavior training to any interested resident.






Ratings of Access to Affordable Veterinary Care in Sacramento

When asked to rate the access to affordable veterinary care in Sacramento, one-quarter of respondents gave a poor rating. An additional 4 in 10 gave a grade of fair. Fewer than half (4 in 10) respondents gave a rating of excellent or good.

Appendix A: Frequency of Responses to All Questions

The full set of responses to each survey question from respondents to the City of Sacramento COVID-19 Resident Survey are displayed in the tables in this appendix. Some of the survey questions included a "don't know" response option. The analyses in the body of the report were for respondents who had an opinion as eliminating "don't know" responses allows for easier comparison between evaluative responses. For questions that included a don't know response, two sets of tables are provided in this appendix; the first with the "don't know" responses excluded, to show the proportion of respondents with an opinion giving a response; and the second with the "don't know" responses included, to allow examination of the magnitude of unfamiliarity with certain items. These tables show the **weighted** percent and **weighted** number of respondents (see Table 60 in the **Error! Reference source not found.**).

- I have called many times about loose and aggressive dogs, and no one is ever at the shelter when this happens, usually weekends. The Front Street Shelter should have staff 7 days a week, extended hours, and much much more funding. Additionally, TNR programs are detrimental to local ecology and wildlife, and should be phased out in favor of adopting out (when possible) and euthanizing (when FIV+, etc.) feral cat populations. Feral cats kill wild animals and spread diseases! Get them off the streets and get the numbers under control.
- I have delivered 3 dead animals this year alone. All found alongside the road by Broadway & Front Street or Miller Park (right down the street from the shelter) after animal control & park rangers would not respond. I have delivered numerous injured/sick cats trapped from a hoarder's yard, many are still suffering inside the house & after several reports, the only thing the city wanted was licensing fees, they would not take these cats or have them fixed. I found an abandoned, declawed senior cat dumped in the bushes with litter box, bowls, etc. & became her emergency foster. Despite Front Street's claims that all supplies would be provided (at their volunteer orientation, in their foster brochure, & in emails), I was told by staff that they "never provide supplies" once fostering for Front Street.

That's ridiculous! I think you need stronger spay neuter incentives. People must PAY for the privilege of breeding their dogs. ALL UNALTERED PETS SHOULD BE CHARGED A MINIMUM OF \$500 A YEAR FOR THEIR LICENSE OR TICKET THEM FOR AN UNALTERED PET! I know you're always struggling for money at animal control and this is a great way to get it!

Appendix B: Breakdowns of Selected Survey Responses by Respondent Characteristics

Understanding the Tables

The tables in this appendix contain the crosstabulations of the survey questions by various respondent demographic characteristics. Chi-square or ANOVA tests of significance were applied to these breakdowns of survey questions. A "p-value" of 0.05 or less indicates that there is less than a 5% probability that differences observed between groups are due to chance; or in other words, a greater than 95% probability that the differences observed in the selected categories of the sample represent "real" differences among those populations. As subgroups vary in size and each group (and each comparison to another group) has a unique margin of error, statistical testing is used to determine whether differences between subgroups are statistically significant.

Each column in the following tables is labeled with a letter for each subgroup being compared. The letters start over with "A" for each different characteristic. (For example, see Table 38 where Female and Male are marked with A and B, 18-34 years old, 35-54 years old, and 55+ years old are marked with A, B and C, etc.)

For each pair of subgroup ratings within a characteristic within a row that has a statistically significant difference, an uppercase letter denoting significance is shown in the cell with the larger column proportion. The letter denotes the subgroup with the smaller column proportion from which it is statistically different. Subgroups that have no uppercase letter denotation in their column and that are also not referred to in any other column were not statistically different.

For example, in Table 27 on the next page, residents living in Council Districts 1, 2, 4, 5, 6 and 8 (Columns A, B, D, E, F and H) were statistically significantly more likely to consider economic development essential or very important compared to those in Council District 3 (Column C, 52%). This is denoted with a "C" in the cells for Districts 1, 2, 4, 5, 6 and 8. However, in the cells for Districts 2, 3, 4, 5, and 8, no other letters are shown, so these ratings were not different than from each other. But for Council District 1, the cell also contains the letters E, G and I, meaning the proportion in that District considering economic development essential or very important was statistically significantly higher than in Districts 3, 5, 7 and those outside a District or unsure in which District they lived.

Appendix C: Survey Methodology

Polco's National Research Center, Inc. (NRC) worked with the City of Sacramento on a survey of residents survey designed to be administered to residents about the Animal Care Services provided by the City. The results will be used for planning important programs and decisions on animal care services for the City, and to provide assistance to the community members assigned to the Animal Care Commission provide advice and recommendations to the Mayor and City Council.

The survey was hosted on the City's Polco online civic engagement platform and was open from July 23, 2021 through August 27, 2021. A total of 695 responses were received. When a survey is administered to a sample of randomly selected recipients of the larger population being studied (known as a "probability sample"), a margin of error can be calculated that estimates the precision of the survey results based on that sample. This margin of error quantifies what is known as the "sampling error," A margin of error at the 95% confidence level can be calculated for any sample size, and indicates that in 95 of 100 surveys conducted in a similar manner, a result would be found that is within the "margin of error." However, for nonprobability sample surveys such as the City of Sacramento Animal Care Services Survey, a margin of error should technically not be calculated, as survey respondents were not recruited using a random sample approach. For non-probability samples, precision is generally described with a credibility-interval and there are a variety of approaches to its calculation. Practically speaking, the error bands are wider than a margin of error from a probability-based sample of a similar size. A common method uses the same margin of error calculations would be used for a simple random sample and multiplies this margin of error by an inflator. With 695 responses, the traditional margin of error at the 95% confidence level would be ±3.7 percentage points around any particular estimate. The credibility interval might be considered to be twice as wide, so could be considered ±7.4 percentage points.

The dataset of survey responses was analyzed using the Statistical Package for the Social Sciences (SPSS). The demographic profile of respondents was compared to that for the adult population of Sacramento as described in the 2018 American Community Survey (ACS) conducted by U.S. Census Bureau. The table below shows the ACS for Sacramento, followed by the unweighted demographic profile and the weighted profile. The full frequencies of responses to each survey question are presented in *Appendix A: Frequency of Responses to All Questions*. Breakdowns of selected survey results of by respondent characteristics can be found in *Appendix B: Breakdowns of Selected Survey Responses by Respondent Characteristics*.
