Activity highlights for April through June 2022:

- ➤ The Office of the City Auditor issued the City Auditor's 2022 Diversity and Workplace Climate Survey Results.
- > The Office of the City Auditor issued the City Auditor's 2021 Audit of City Employee's Workforce Diversity and Salary Trends.
- The Office of the City Auditor issued the **2022 National Community Survey**.
- ➤ The Office of the City Auditor issued the Whistleblower Hotline Activity Report for the period of October 2021 through March 2022.
- ➤ The Office of the City Auditor issued the Quarterly Activity Report for the period of January 2022 to March 2022.
- ➤ Jordan Sweeney and Jorge Oseguera were designated Certified Internal Control Auditor's by the Institute for Internal Controls.
- ➤ The Office of the City Auditor released three interactive dashboards that allow users to analyze the 2022 Diversity and Workplace Climate Survey Results by department, gender, and ethnicity/race. The Office of the City Auditor created a Dashboards webpage on our website to centralize all dashboards in one easy to find location.
- ➤ The Office of the City Auditor updated and expanded the recommendation follow-up and whistleblower hotline activity dashboards.
- ➤ The Office of the City Auditor added a "Suggest an Audit" button to the website. Users can submit ideas for audits of City operations or programs.
- ➤ The Office of the City Auditor streamlined our internal training approval and tracking processes to improve efficiency and further reduce the use of paper.
- ➤ The Office of the City Auditor participated on the hiring panel for Office of Public Safety Accountability's most recent recruitment.

- > The Office of the City Auditor initiated a recruitment for the recently vacated Utilities Auditor position.
- ➤ The Office of the City Auditor presented the results of the *Audit of the Sacramento Community Police Review Commission: Renewed Focus on Cooperation is Urgently Needed* to the Sacramento Community Police Review Commission.
- > The Office of the City Auditor investigated a number of whistleblower allegations.
- > The Office of the City Auditor continues to partner with Missionmark, Inc. to develop audit software that will streamline audit processes.
