On August 13, 2019, the City of Sacramento adopted the Tenant Protection and Relief Act (TPRA). The TPRA provides tenants with protections related to rent increases and evictions. Additionally, the TPRA established the Tenant Protection Program (TPP). In accordance with the TPRA, landlords are subject to the TPP Rental Property Registry and must pay program fees. You are receiving this notice based on information obtained from the County of Sacramento Assessor's Office.

REGISTERING YOUR RENTAL PROPERTY

ONLINE RENTAL PROPERTY REGISTRY RENEWAL

If the rental property is not exempt and/or there are no corrections needed to the Rental Property Registry form, included in this packet, you may register online. An Online Rental Property Registry form must be completed for each rental property. Please do not mail or email, a copy of the online form as this will delay processing. The enclosed form must be completed and returned unless requirements are met to register online.

REGISTRATION FILE NUMBER

A property Registration File Number (e.g., 21-xxxxxx) is assigned to each rental property address. Please do not use or copy the forms contained in this packet for other properties. If a packet was not received for a property please contact TPP@cityofsacramento.org or phone (916) 808-8121.

CORRECTIONS

If corrections need to be made to the information contained on the Tenant Protection Property Registration Form included in this packet, notate the corrections in the section on the form labeled "Corrections", and submit to the Tenant Protection Program (TPP) for processing.

EXEMPTION REQUEST

Exemption requests must be completed and renewed on an annual basis. In accordance with Sacramento City Code Section 5.156.030, units may be exempt from the Tenant Protection Program (TPP). Qualifying exemptions may apply to individual units. If any of the exemptions noted in the code exist, please submit the Exemption Request form for each exempt unit. You must provide the address and/or unit number and identify who resides in the unit.

If the property contains non-exempt and exempt units, please submit an Exemption Request only for the units that are exempt.

AUTHORIZED AGENT/REPRESENTATIVE

If there is a designated authorized agent/representative to receive the Tenant Protection Property Registration Packet and program fee invoice, please be advised that the update will become effective the next registration cycle. Registration occurs on an annual basis. Correspondence and invoices will continue to be sent to property owner until the file is updated. Property owners are responsible for ensuring registration documents are completed and program fees are paid.

PROGRAM FEE

All property owners with units subject to this Program must pay the annual Tenant Protection Program (TPP) fees. The fees fund administrative and enforcement costs for the program. Program fees are invoiced based on the number of rental units on the parcel. The invoice will be mailed to the address on file. It is the responsibility of the property owner to ensure all program fees are paid. If you did not receive an invoice, please contact TPP@cityofsacramento.org or phone (916) 808-8121.
