

**CITY OF SACRAMENTO
NOTICE OF INTENTION TO AMEND
THE CONFLICT-OF-INTEREST CODE
FOR CITY DEPARTMENTS AND
BOARDS AND COMMISSIONS**

NOTICE IS HEREBY GIVEN that the City of Sacramento intends to amend the existing conflict-of-interest code for city departments and boards and commissions. Revisions to the existing conflict-of-interest code include: revisions to the code to remove provisions covered by Fair Political Practice's model conflict-of-interest code; revisions to Appendix 1 of the code (Designated Positions) to modify the list of designated employees who are required to file statements of economic interests; and revisions to Appendix 2 of the code (Disclosure Categories) to expand the categories required to be disclosed. A full copy of the proposed amended conflict-of-interest code is available in the Office of the City Clerk for review and inspection.

NOTICE IS FURTHER GIVEN that the City of Sacramento has established a written comment period for interested persons to submit comments pertaining to the proposed amended conflict-of-interest code. Comments must be submitted in writing to the Office of the City Clerk no later than March 6, 2026, at 4:30 p.m., to be considered by the City Council when it takes action on the proposed amended conflict-of-interest code. The City Council is scheduled to take action on the proposed conflict of interest code on April 14, 2026, at 2:00 p.m. The meeting will take place in the Council Chamber located at 915 I Street, 1st Floor, Sacramento, CA 95814. Adopting the Conflict-of-Interest Code of the City of Sacramento and Repealing Resolution 2019-0119

BACKGROUND

- A. The Political Reform Act, Government Code § 81000, et seq., requires state and local government agencies to adopt and promulgate conflict-of-interest codes; and
- B. On April 23, 2019, the City Council adopted Resolution 2019-0119, which adopted the City's conflict-of-interest code; and
- C. The City Council has determined that it should update the City's conflict-of-interest code because of changed circumstances, including the creation of new positions that must be designated in the conflict-of-interest code; and
- D. The Fair Political Practices Commission has adopted a regulation (Cal. Code Regs., title 2, § 18730), which contains the terms of a standard model conflict-of-interest code, can be incorporated by reference, and may be amended by the Fair Political Practices Commission to conform to amendments to the Political Reform Act after public notice and hearings.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The conflict-of-interest code adopted by Resolution 2019-0119 is hereby repealed in its entirety; provided, however, this shall not affect or excuse any act or omission or any other penalty or forfeiture incurred or accrued under the conflict-of-interest code adopted by Resolution 2019-0119; nor shall it affect any prosecution, suit, or proceeding that is pending or may be commenced or any judgment rendered in connection with the conflict-of-interest code adopted by Resolution 2019-0119.
- Section 2. The conflict-of-interest code attached as Exhibit A is hereby adopted and is made part of this resolution.
- Section 3. This resolution takes effect immediately upon adoption.

EXHIBIT A

THE CONFLICT-OF-INTEREST CODE OF THE CITY OF SACRAMENTO

SECTION 100. This is the conflict-of-interest code of the City of Sacramento. The conflict-of-interest code consists of the following: Sections 100-1300; the terms of title 2, California Code of Regulations, section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, which are hereby incorporated by reference; Appendix 1, which designates positions; and Appendix 2, which sets forth disclosure categories.

SECTION 200. Designated employees shall file their statements of economic interests with the City Clerk of the City of Sacramento to whom the City Council hereby delegates the authority to carry out the duties of filing officer.

SECTION 300. Every person who is required to file a statement of economic interests with the City Clerk shall file the statement using only the electronic system prescribed by the City Clerk unless otherwise directed by the City Clerk.

SECTION 400. The statements of economic interests that the members of the City Council file by virtue of their positions as members of the City Council shall suffice for the statements of economic interests they are required to file as members of the governing boards of the Housing Authority of the City of Sacramento, Sacramento City Redevelopment Agency Successor Agency, Sacramento City Financing Authority, and the Sacramento Public Financing Authority.

SECTION 500. The statements of economic interests that the City Treasurer, Director of Finance, City Attorney, and City Clerk file by virtue of their positions with the City of Sacramento shall suffice for the statements of economic interests they are required to file in connection with their positions with the Sacramento City Financing Authority and the Sacramento Public Financing Authority.

SECTION 600. Positions that manage public investments for the purposes of Government Code section 87200 include: (a) the members of the Administration, Investment and Fiscal Management Board, and (b) the following positions in the City Treasurer's Office: (1) Chief Investment Officer and (2) Senior Investment Officer. These officials shall file their statements of economic interest with the Fair Political Practices Commission as provided in Government Code section 87500.

SECTION 700. The City Attorney, or designated representative, shall make the initial determination as to whether individuals are consultants, as defined in title 2, California Code of Regulations, section 18700.3. An individual may be a consultant whether they

are compensated or are an unpaid volunteer. The requirements of this conflict-of-interest code must be included in every contract between the City and a consultant. No later than ten days after an authorized City representative signs a consultant contract, the department head (or designee) of the department responsible for the administration of the contract shall submit to the City Clerk a completed Fair Political Practices Commission Form 805 (Agency Report of Consultants), which identifies the consultant and disclosure categories.

SECTION 800. Any filer required to disqualify themselves under this conflict-of-interest code shall give notice of disqualification to the City Clerk, to their immediate supervisor and to their division or department head, if there is no division head. The notice must be in writing and must be made part of the official records of the City Clerk. The filer shall then refrain from participating in the matter and shall in no way attempt to use their official position to influence any other person with respect to the matter.

SECTION 900. Upon request by the Office of the City Clerk, the Human Resources Manager for labor relations shall assist the City Clerk in fulfilling the City Clerk's duties with respect to any employee in a designated position who fails to file a statement of economic interests as required by this conflict-of-interest code.

SECTION 1000. If the head of a department determines, as provided in title 2, California Code of Regulations, section 18734, that it is not necessary for a person in a newly-created position that is not yet covered by this conflict-of-interest code to file under the broadest disclosure category in this conflict-of-interest code, then the head of the department (or designee) shall complete and submit to the City Clerk a Fair Political Practices Commission Form 804 (Agency Report of New Positions). The head of the department shall consult with the City Attorney and City Clerk before making their determination.
