# General Conduct for the Public Attending Ann Land and Bertha Henschel Memorial Fund Commission Meetings

- Members of the public attending commission meetings shall observe the same rules and decorum applicable to the Members and staff as noted in Chapters 3 and 4 of Council Rules of Procedure.
- Stamping of feet, whistles, yells or shouting, physically threatening conduct, and/or similar demonstrations are unacceptable public behavior and will be prohibited by the Sergeant-at-Arms.
- Lobbyists must identify themselves and the client(s), business, or organization they represent before speaking to the Committee
- Members of the public wishing to provide documents to the Committee shall comply with Rule 7D of the Council Rules of Procedure.

# Members of the Public Addressing the Ann Land and Bertha Henschel Memorial Fund Commission

- Purpose of Public Comment. The City provides opportunities for the public to address the Committee as a whole in order to listen to the public's opinions regarding non-agenized matters within the subject matter jurisdiction of the City during Regular meetings and regarding items on the Agenda at all other meetings.
  - Public comments should not be addressed to individual Members nor to City officials, but rather to the ALBHMF Commission as a whole regarding Commission business.
  - While the public may speak their opinions on Commission business, personal attacks on Commission members and City officials, use of swear words, and signs or displays of disrespect for individuals are discouraged as they impede good communication with the Commission.
  - Consistent with the Brown Act, the public comment periods on the Agenda are not intended to be "Question and Answer" periods or conversations with the Commission and City officials. The limited circumstances under which Members may respond to public comments are set out in Rule 8D2 of the Council Rules of Procedure.

#### **Speaker Time Limits**

In the interest of facilitating the Committee's conduct of the business of the City, the following time limits apply to members of the public (speakers) who wish to address the Committee during the meeting.

- Matters not on the Agenda Two (2) minutes per speaker.
- Consent Calendar Items the Consent Calendar is considered a single item, and speakers are therefore subject to the two (2) minute time limit for the entire Consent Calendar. Consent Calendar items can be pulled at a member's request. Such pulled Consent Calendar items will be considered individually and up to two (2) minutes of public comment per speaker on those items will be permitted.
- Discussion Calendar Items Two (2) minutes per speaker.

Time Limits per Meeting In addition to the above time limits per item, the total amount of time any one individual may address the Committee at any meeting is eight (8) minutes.

- Each speaker shall limit his/her remarks to the specified time allotment.
- The Presiding Officer shall consistently utilize the timing system which provides speakers with notice of their remaining time to complete their comments. A countdown display of the allotted time will appear and will flash red at the end of the allotted time.
- In the further interest of time, speakers may be asked to limit their comments to new materials and not repeat what a prior speaker said. Organized groups may choose a single spokesperson who may speak for the group but with no increase in time.
- Speakers shall not concede any part of their allotted time to another speaker.

The Presiding Officer may further limit the time allotted for public comments per speaker or in total for the orderly conduct of the meeting and such limits shall be fairly applied

**Total Number of Clients** 

ACC Rides provides door-to-door service, assists riders with their mobility devices and makes sure clients reach their destinations safely and on time.

The Ann Land and Bertha Henschel Memorial fund helps support ACC Rides Transportation Services by providing transportation Monday through Friday to clients attending senior meal programs at the following sites: Sam Pannell Community Center, Fruitridge Community Center, Eskaton Monroe, and Ethel Hart Senior Center. ACC Rides provided 7,532 one-way rides (at \$5.00 per ride amounts to \$37,660.00) to 30 unduplicated clients, \$4,000 of which was supported by the Ann Land and Bertha Henschel Memorial Fund. Most program participants have limited incomes and cannot afford the \$5.00 one-way ride suggested donation, let alone make a donation for their meal. Having a hot, nutritious meal at least once a day, socializing with friends they"ve met while attending the program, attending exercise classes, playing bingo and other activities each site offers is what they look forward to.

In addition to providing transportation to café sites, ACC Rides provided transportation to older adults residing in the low income apartments in the downtown area (Gibson Oaks, Washington Plaza, River View, Edgewater, Comstock, Capitol Terrace, Sierra Vista, and Sutterview Senior Apartment). ACC Rides provided 252 one-way rides (\$5.00 round trip \$1,2600.00) \$500.00 of the cost was supported by the Ann Land and Bertha Henschel grant to 21 unduplicated individuals from January to June 2018. Getting out of the house is one of the main reasons residents have signed up to go shopping.

#### **Program Challenges**

Having enough volunteer drivers and accessible vehicles are the two major challenges we are experiencing. Volunteer drivers are transitioning tasks other than driving and according to them, they are getting too old to help ACC Rides clients whose mobility has changed from the time they started volunteering. Most of the ACC Rides volunteers have been volunteering for about 16 years.

Having wheelchair accessible vehicles is another challenge we face as riders are aging and are now needing assistive devices such as wheelchairs and walkers.

#### Certification

I certify that the Ann Land and Bertha Henschel Memorial Funds were used only for the purpose stated in our 2018 Funding Agreement with the Commission and that these funds were used to assist only destitute residents of the City of Sacramento.

Our total grant award for 2018 was \$3,000 and this year we exceeded this amount just with Sacramento Food Bank for the year which exceeded \$3018.57 in invoicing. This amount doesn''t take into account groceries stores, supplies/toiletries or transportation which was submitted in our original grant proposal. One of the reasons for the increased food expenses is due to our partnership with His Streets Ministries, they are an inner city community/homeless outreach group that we partner with in our community outreach events and services, specifically during the summer months and winter activities. Their primary function with us was food distribution for underserved community neighborhoods and community outreach events.

#### **Program Challenges**

Our food budget doubled in expenses this year but we also received additional donations and funds to assist us in these endeavors. We are making adjustments for 2019 for additional funding sources and grateful of the ALBH grant for assisting us in meeting 2018 needs.

#### Narrative Report - describe the program the funds are supporting

This grant year, we were authorized to use the Ann Land and Bertha Henschel Memorial Funds for food supplies and transportation for our Center for Women participants. CASH helps women who have been commercially sexually exploited. Our program is located at the corner of Broadway and Alhambra in Oak Park, an area known for high poverty and prostitution activity. Women come to our Center to have their most basic needs met, to step away from the strain of life on the streets, and to meet with peer specialists who provide links to community resources. Our Center has a comfortable space to relax, computers, telephones, restrooms, and a clothes closet. We are open for drop-in hours to 5 days per week to meet the ongoing needs of the women we serve. We provide a basic meal to every woman that comes in and make take-out lunches available for women that are very food insecure. This year, in partnership with the Sacramento Food Bank, we've also been able to make more substantial take home sacks with nutritious food for our housed participants. We know that women prostitute to meet their most basic needs and because the women we serve are extremely poor, they usually run out of food assistance long before the month is over. We work hard to eliminate barriers that stand between a woman and a healthy lifestyle. During this grant period, we provided 1800 meals to 171 unduplicated women, many with children in the home, during this grant period. When we first meet a woman, we are often the only place that offers enough nutritious food to meet their needs. We are proud to report that women look forward to receiving juice and other nutritious food, when available.

We also provided 231 bus passes to 40 unduplicated women. Transportation is offered to obtain benefits, usually SNAP and General Assistance, to make medical appointments, attend mandatory classes, meet legal requirement, and to enroll in employment programs.

#### **Program Challenges**

The only challenge we encountered this grant term was a slight interruption in the processing of our reduced fee bus tickets which left us very low for over a month. We are very grateful for the partnership and know that administering that program has its own challenges.

#### Narrative Report - describe the program the funds are supporting

Our combined shelter programs, Pilgrimage and Winter Sanctuary, continue to provide shelter, warm dinners, breakfast, and a sleeping bag to adult members of the homeless community in Sacramento.. We strive to provide a safe and quiet environment where our homeless guests can find peace and rest each evening without fear of violence. We consider our shelter programs to be emergency programs, taking those off the streets who are left outside after traditional 24-hour shelters are full. During the summer months we served approximately 300 meals per month and during the fall when winter sanctuary starts we increase that to 200+ meals per day or approximately 6800/month. We continue to work with 40+ church congregations across Sacramento County.

This combined effort allowed us to serve approximately 13,500 meals during the second period. That is slightly lower than the first period because the winter sanctuary operates more months during the first period. We also provided over 6750 shelter-bed-nights which if valued at the cost of motel vouchers, another program, would bring a value of approximately \$506,250.00 to the community not counting the meals value.

The faith-based community has been a partner in these programs for the last 10 years, supplying room for 100+ to sleep. The Winter Sanctuary hosts 100/night from November to April. The Pilgrimage program has merged operations into the Winter Sanctuary and on off months continues to supply approximately 300 shelter bed nights per month and 600-800 meals per month. Food costs are supplemented by use of the Sacramento Food Bank, and use of church kitchen facilities reduces transport efforts. Shelter costs include sleeping bags that have strong enough zippers and seams to withstand the frequent washing required, We also have to maintain a ready supply of incontinence supplies for adult guests and clean up supplies and clothes for guests when problems of this nature occur. We have reduced our cost to store equipment by creating an equipment room in our existing facility that serves as an intake center for the shelter and case management center for rehousing.

We have also been able to open the doors of our intake center 12 hours/day, 7 days/week for restroom usage. In the first two months there were over 10,000 uses of these facilities.

#### **Program Challenges**

The challenges that we face are always evolving as we find new or modified solutions. Currently many of the 40+ congregations we depend on are feeling the fatigue of providing 10+ years of support to the programs. We are finding new and creative ways to work with them, providing additional support from our organization in the form of additional labor and funds. Additionally, the faith-community is challenged with many facilities that are aging and budgets that are fading. This facility stress manifests itself in plumbing issues, kitchen issues and general maintenance issues. At the same time they are experiencing aging congregations and their volunteer teams are shrinking.

FSC has started discussing next season with Sacramento County and the faith community. We may be seeking a single physical site and shifting the faith community to providing meals in our site. This would alleviate host facility stress and still allow for participation in helping us help the homeless. Budget considerations have both negatives and positives. We would greatly reduce transportation costs but probably open 24-hours/day and increase wage expense. As the City of Sacramento and Sacramento County struggle with this growing population we are working to help by providing flexibility in our program delivery.

Narrative Report - describe the program the funds are supporting Ann Land and Bertha Henschel Memorial Funds support My Sister's House Emergency Shelter, both in terms of rent and food supplies. The funds assisting shelter needs ensure shelter for Asian/Pacific Islander and other underserved victims that typically have a difficult time finding shelter, being served, or feeling comfortable at other shelters. Specifically, unique client needs such as language, cultural systems, cultural customs and others are able to be better understood at My Sister"s House Safe Haven (emergency shelter). With this understanding and acceptance, it is easier for the victims to begin healing from their trauma and rebuilding their lives. The Ann Land and Bertha Henschel Memorial funds used for food supplies are essential in helping provide culturally appropriate food for our clients. Food is an integral part of clients' identities and cultures and is a way for immigrants to preserve their culture. For our clients who have experienced domestic violence, having familiar food brings comfort and affects their mental health in a positive way. In turn, this helps minimize stress in their current lives and allows them to focus instead on healing and rebuilding from domestic violence experiences. Examples of ethnic foods purchased these past six months include Asian egg noodles; culturally specific sauces such as soy sauce, chili, hoison sauce; Persian flatbread; halal meats (from a halal store); and Indian items such as spices, daal, and atta (flour for Indian roti). The purpose of these foods requires experience and knowledge of both the item and knowledge of where to acquire them.

#### **Program Challenges**

At My Sister''s House Safe Haven (our Emergency Shelter), our goal is to be culturally sensitive to all of our clients by providing ethnic goods for traditional cooking such as spices, grains, produce, and meats. A challenge we face would be ensuring that we continue to provide food that is traditional or familiar to our clients while also keeping in mind of dietary restrictions or preferences. For instance, our Muslim clients eat halal meat - which may add onto additional costs when buying non-halal meat for other clients.

Support from the Ann Land and Bertha Henschel Memorial Fund allows the Roberts Family Development Center (RFDC) to provide financial assistance to economically vulnerable families through our "Families in Transition Fund". The fund assists families who are in transition and/or those experiencing a crisis, by providing limited financial assistance in exchange for community service at a place of their choosing. Families may be granted a once-per-year large amount up to \$300 or may be granted small amounts during the year not to exceed \$300. Requests must be deemed a legitimate need by RFDC and may include clothing, food, personal hygiene products, gasoline, bus passes, utilities, rent, car repairs, medical expenses, and other life necessities. The amount of community service each client/family will be required to complete is based on the amount of funds requested and will not exceed 15 hours.

Throughout the year, the funds helped 113 individuals from 36 families who were in crisis and in need of financial support.

#### **Program Challenges**

As a community agency that works with directly with over 700 economically challenged families who participate in our programs and even more community residents, it is difficult to meet the needs of everyone who requests assistance from us. Narrative Report - describe the program the funds are supporting With funding from Ann Land and Bertha Henschel Memorial Fund Commission, SFBFS was able to directly purchase and distribute 23,357 pounds of produce, equivalent to 19,464 meals, in partnership with 168 Sacramento-based partner agencies. With each individual receiving three meals per day for four days, this equates to approximately 1,622 people fed through the generosity of Ann Land and Bertha Henschel Memorial Fund Commission. SFBFS leveraged this funding with additional support from the community to distribute 14,197,303 pounds of food, including 4,781,377 pounds of produce, to 154,000 people per month over July through December 2018. This is over 1.2 million more pounds of food and 470,000 more pounds of produce than we distributed over the previous six-month period.

#### **Program Challenges**

Over the last year, SFBFS has successfully converted all partner agencies to Primarius Web Windows, an online food ordering system. This uniform platform has made a tremendous impact on the ease and efficiency of order fulfillment and processing for our agencies. Another benefit to this system is that we have better ability to submit and report feeding data. Many of our agencies have very small budgets under \$5,000, rely on older equipment, and have limited volunteers or staff. While we have realized efficiencies with this system, we have found that there is a learning curve given their capacity challenges. It is important for SFBFS to build upon our momentum by offering continual support and training on proper ordering and utilization of the inventory system.

Capacity building is a continued effort and one our greatest challenges. In addition to distributing food staples and produce to our partner agencies, which the Ann Land Bertha Henschel Memorial Fund continues to generously support, SFBFS also provides technical assistance, training, and oversight. SFBFS has made considerable progress in supporting our agencies and strengthening the overall emergency food system to increase food access in our community. This involves seeking additional partnerships and funding opportunities that enable us to provide key equipment, technology, and infrastructure to our network. For example, we secured a \$75,000 grant from Walmart Foundation to purchase items such as cold storage, shelving, and pallet jacks that allow agencies to significantly increase their distribution capacity and expand food access in their neighborhoods. These efforts complement the activities provided through the generosity of Ann Land and Bertha Henschel Memorial Fund and other community supporters, so that as we continue purchasing and providing food to our partner agencies, we can create a system that better serves hungry Sacramento families.

#### Narrative Report - describe the program the funds are supporting

Loaves & Fishes provides survival services for Sacramento''s most vulnerable-- men, women, and families with children experiencing extreme poverty or homelessness. Funding from the Ann Land Bertha Henschel Memorial supports our Milk Program that provides milk at three of our meal providing programs. In 2018, these programs served milk with their daily meals/snack and accomplished the following:

Dining Room Program: 10 hardworking staff members and rotating groups of 20 volunteers in our dining room prepared and served 146,980 hot and healthy midday meals daily to 12,921 guests.

Maryhouse Program: 9 compassionate staff members and approximately 20 dedicated volunteers provided respite, resource counseling, and survival services to homeless women and families while also providing 27,706 warm breakfasts, 10,101 hot showers, and 28,644 diapers, hygiene items, and basic essentials.

Mustard Seed Emergency School: 8 highly-trained teachers and 12 dedicated volunteers provided a safe space for classroom instruction, health screenings, and academic assessments to homeless children aged 3-15 in Sacramento. 67 students successfully reintegrated back into public school with the help of our teachers and resource counseling staff. Children and their parents received a nutritious breakfast every weekday morning and students received an snack during their afternoon recess. Our outreach team will also provide food items for families when needs arise. During their time at Mustard Seed, families also received counseling, housing navigation, and survival supplies.

#### **Program Challenges**

Like many non-profit organizations in Sacramento serving the poor, disenfranchised, and hungry, we anticipate a day when our services our no longer needed. On any given day you can read the paper, scroll your social feeds, or walk along our city street and see the presence and struggle of the men, women, and children experiencing homelessness in our community. As our elected officials, community advocates, and organizations strive to find the best solutions, Loaves & Fishes continues to ensure our guests have their most basic needs met: daytime shelter, food, clothing, hygiene essentials and basic survival supplies. Sometimes relief from the desperation they feel is just hearing a yes, I can help, and I am here to listen to your story. Enough food is always a challenge. However, we continue to be filled with much gratitude for the support we receive daily, the monetary support from donors and grants, and the many hours worked by our dedicated volunteers. The support we receive from the Ann Land Bertha Henschel Memorial Fund continues to be an important funding source for Loaves & Fishes.

#### Narrative Report - describe the program the funds are supporting

The funds are supporting the EBT incentive program at the Oak Park Farmers Market and our new second Farmers Market at U.C. Davis Health. Through this program, customers that receive EBT benefits can swipe their EBT card at the Farmers Market and receive wooden tokens to shop at the Market. Through the Ann Land/Bertha Henschel Fund and other donors, we are able to match their EBT purchase dollar for dollar. This doubles their EBT benefit, and doubles the amount of produce and other healthy food they can purchase for their families.

Our EBT customers are also able to participate in other incentives and services at the Market. This includes our monthly "Market Bucks" incentive which promotes a different fruit or vegetable. We have also continued our \$5 in "Kids Bucks" for up to 25 children each week. The children receive the coupons after completing a weekly nutrition education activity that helps the child learn more about the nutritional value of the featured fruit or vegetable. The "Kids Bucks" encourages children to shop and make their own healthy shopping choices and decisions.

One of our most popular activities are live cooking demonstrations provided by local chefs and community groups. These cooking demonstrations feature seasonal produce available at the Farmers Market, and provide delicious, new ways for families to enjoy healthy produce from the Market.

Other activities include free arts and crafts, free yoga, and information table staffed by local groups, including the Oak Park Neighborhood Association and Oak Park "Fix-it" Café (community asset building network). Other groups have provided information/services on programs and services. For example, Sacramento Food Bank and Family Services has staffed an information table at the Market and provided support to help families apply for Cal-Fresh benefits. This has allowed families to learn more about CalFresh and MediCal benefits in a safe and comfortable environment.

We invite the Commission Members to visit the Market on Saturday mornings from May through October at McClatchy Park (35th St. and 5th Avenue) and at U.C. Davis Health on Wednesdays from 3 p.m. to 7 p.m. at 4610 X Street (free parking at Shriner''s Parking lot).

#### **Program Challenges**

The Oak Park Farmers Market is pleased with the growth in the EBT sales and the number of EBT individuals/families participating, and are also aware that there are thousands more families in the Sacramento area that can benefit from our EBT incentive. We are continuing to reach out to EBT families in the Sacramento area. This includes providing door-hangers door to door in Oak Park, Land Park, Tahoe Park and Colonial Heights. This spring, we distributed more than 20,000 door-hangers in local neighborhoods. We continue to use social media to reach families; and currently have more than 4,200 people following our Oak Park Farmers Market Facebook page.

Narrative Report - describe the program the funds are supporting Since 1985, Saint John's Program for Real Change has lifted more than 30,000 women and children experiencing homelessness up and out of poverty to self-sustainability by providing them with the essential tools to make REAL, transformative change in their lives. Saint John's is Sacramento's largest residential program focusing exclusively on the needs of formerly homeless women and their children, which is the most vulnerable and rapidly-growing segment of the homeless population in our region and nationwide.

The families we serve come to us overwhelmed and in a state of crisis. Many utilize our emergency supply warehouse for basic needs: a change of clothes, new socks, undergarments, diapers, toiletries and food. The women average 34 years old with two children (35% were teen mothers). All of them (100%) live below the poverty level and are dealing with multiple and complex issues that are barriers to employment and their ability to become self-sustaining: 100% lack a stable work history or have never held a job, 71% have survived domestic violence, 82% battle addiction, 61% have a criminal history, 53% lack basic reading and math skills and a high school diploma, and 66% struggle with mental illness.

Many women also have physical health problems, unaddressed dental/vision needs, a lack of money management skills, and limited, if any, knowledge of how to access community services. Saint John's offers immediate stabilization services, including housing, meals, therapy, and counseling, as well as longer-term services, including financial literacy classes, parenting education and hands-on Employment Training at one of our three social enterprises. All services are on-site and designed to centralize support ensuring the much needed accountability, efficiency and coordination.

Saint John's cost to move one person from homelessness to family sustainability is \$17,000, roughly one third of the \$50,000 it takes for Sacramento County to carry a homeless individual in its system for one year. The long-term, generational, social and financial impact of Saint John's "teaching them to fish" approach is a demonstrated and objectively measured model, documented in a yearlong study conducted on behalf of the County Supervisors Association of California (CSAC) and the League of California Cities, concluding that Saint John's is a BEST PRACTICE for homeless families.

Access to nutritious food is crucial for the women and children we serve while they work to achieve self-sustainability – the primary goal of Saint John's Program for Real Change. We provide families three nutritious meals and two snacks a day, served in our community dining spaces. We also provide nutrition education among other tools to ensure healthy living.

Meals are prepared and served each day by our staff chef and food preparation volunteers.

Women in our program are encouraged to participate in meal planning and preparation. Our healthy cooking classes include topics such as understanding food labels and the health benefits of fresh, whole foods. Nutrition classes include discussion on common preventable chronic diseases related to food and exercise, including: cardiovascular disease, diabetes, hypertension, cancer and obesity. Fitness classes include: yoga, dance, aerobics, basketball, and meditation.

Through our meal program and healthy living classes, we help our families create the good habits they need to maintain a healthy lifestyle beyond their time at Saint John's.

Providing healthy meals for women and children experiencing homelessness is strongly aligned with the Ann Land and Bertha Henschel Memorial Fund's mission to provide direct aid and assistance to the destitute women and children of the City of Sacramento. Without immediate needs (food and housing) for themselves and their children satisfied, mothers at Saint John's could not focus on the challenging work of becoming self-sustaining and transforming their lives.

#### **Program Challenges**

In August of 2017, we were notified by the County of Sacramento that our annual contract that we've held for 15-years would not be renewed due to the fact that we focus exclusively on women and children (we don't serve men), and that we are too "high-barrier"... meaning that we require too much of our clients including accountability and sobriety. This affected our 2018 funding, as well as our 2017 funding. This occurred simultaneous with our July 2017 expansion, during which we added capacity to serve an additional 90 women and children per day in an attempt to reduce our 400-family daily waiting list.

Over the past 18 months, through an aggressive fundraising campaign and through multiple fundraising events, and with the continued generous support from foundations, corporate and individual donations, we have gradually and steadily recouped the funds no longer awarded to us by the County, although it has been a difficult and at times, a daunting challenge. As we move into 2019, we are working diligently to seek out and secure all available sources of funding, both public and private, so that we can continue to grow and serve the growing population of homeless families in Sacramento.

Narrative Report - describe the program the funds are supporting Ann Land Bertha Henschel funds support snacks and meals for children and teens who have been impacted by adverse childhood experiences (ACEs), are low-income and housing-insecure, and live in zip codes 95815, 95833, 95834, 95835, or 95838.

Children ages 5-11 years participated in Day Camp during the summer months, and After School Groups during the school year. Snacks are served to the children daily.

The Teen Center is open to youth ages 12-17 years, and meals & snacks are served daily. Teens stay through the dinner hour during the school year, so a more filling snack or meal is served at that time.

Numbers reported for the six-month period from July 1 - December 31, 2018 reflect the total number of snacks and meals served (2,216). Unduplicated individuals served this reporting period totals 185.

#### **Program Challenges**

Funds from Ann Land Bertha Henschel are critical to our ability to provide food to at-risk children and teens. This is our only dedicated funding source for purchasing food for them. Food prices continue to rise, and we continue to run out of funds before the end of the six-month funding period.

This summer, we participated in the free summer lunch/snack program for Day Camp and the Teen Center, in order to stretch our Ann Land Bertha Henschel grant into the last month of the reporting period.

Narrative Report - describe the program the funds are supporting For more than twenty years, Salvation Army Citadel Campus ELEV8 After School Program [ASP] and Summer Day Camp [SDC] have had the privilege of providing extended care throughout the year before, during and after the work and/or school day as well as summer hours. The ASP and SDC are essential vehicles to deliver a critical need for quality, reliable, and safe childcare options for the Oak Park Community and surrounding neighborhoods. Our location presents our staff with the reality that many of our children are hungry, afraid to play outside, and require academic support and enrichment for constructive use of their time out of school. In this current year, we served an average of 65 students in After School and capped Summer Day Camp Enrollment to 70 Campers.

Our mission 'To Do the Most Good' is fueled by the fact that most of our population is comprised of multi-generational families typically supported by limited incomes from low - wage positions. Subsequently, more than 75% of our students qualify for Free/ Reduced State of CA Food Program. The Ann Land and Bertha Henschel Memorial Fund is designed to link this known, high-risk demographic to not only cultivate healthy eating habits, but to enrich all aspects of our student population academically, socially and emotionally.

#### **Program Challenges**

The challenges of serving a community which can be riddled with poverty and crime are endless. The basic services we provide seem to never be proportionate to our need determined. We can provide the safe harbor and a consistent 'meal' of the day for many of our students. Additionally, our ELEV8 ASP and SDC Programs have as their capstone a very structured daily agenda. Our team works tirelessly to follow and deliver routines daily as to model this key element of future success. Integrating empathy and compassion, our Program Aides build relationships and support school assignments as needed.

To continue to build capacity for our daily curriculum which includes Technology, Visual & Performing as well as Recreation, we must constantly seek out creative, cost-efficient sources to fund Continued Education for staff as well supplies and materials for activities. We are blessed to operate at capacity and frequently revisit our waiting list which perpetually lengthens. The ALBH Grant enables us to sustain and provide food supplies for all students that join our program. Our commitment remains focused on including volunteers and community leaders to present and support independent thinkers and exemplary citizens.

## **Report / Certification**

Narrative Report - describe the program the funds are supporting From July 1 - December 31, 2018 WEAVE provided safe and confidential shelter to 138 domestic violence victims, 78 adults and 60 children for a total of 9,754 bed nights. All victims staying at WEAVE's emergency shelter and transitional housing receive access to voluntary case management and an array of supportive services, including safety planning, food and clothing, housing advocacy, psycho-educational support groups, legal assistance, therapeutic counseling, financial empowerment, childcare, emergency transportation and children's services.

The emergency residential campus includes an onsite charter school, children's counseling and Psycho educational playcare activities. WEAVE's residential program consists of an emergency domestic violence shelter, cottages and transitional housing units located in two separate areas of Sacramento.

WEAVE also offers services for Sexual Assault and Sex Trafficking survivors. In FY 17/18 WEAVE provided 17,177 bed nights of safe and confidential shelter to 276 domestic violence victims (153 adults and 123 children). WEAVE also operates a 24/7 support and information line, which in 2017/18 answered 13,410 calls.

### **Program Challenges**

Some challenges faced in our residential program include overall maintenance and cleanliness of the facility and furniture, daycare, donation storage and organization, food purchasing capabilities, access to education, and ability to meet transportation needs of clients.

Client transportation in particular is a main challenge with the residential program (both emergency and transitional). For confidentiality purposes, our clients are not allowed to share the location of the safehouse (emergency shelter) with their loved ones and therefore cannot get rides to and from the safehouse when needed if they don't have their own transportation. As a result, clients have a hard time making their vital appointments. Furthermore, on days with many transportation requests it becomes much more challenging to conduct case management or address other safehouse needs.

In regards to maintenance and cleanliness, our advocates work hard to ensure the facility is tended to and that all things are in safe and working order. However, with the continual need for upkeep along with daily case management and crisis response duties, the capacity for facility maintenance and supply organization is stretched thin.

Daycare is also an ongoing challenge for clients who are seeking employment. It is very difficult for clients to keep their kids safe while they look for employment. Childcare is expensive in this area, with costs at an estimated \$400/week, and this is very much outside of our residential programs' clients' budgets.

Our donations storage room is in continual need of upkeep as well and it is challenging to access some requested items that are stored due to the organization of the donations and supplies.

On many occasions emergency food is also a challenge for clients. Some clients do not have welfare benefits and until they get them, they do not have any way to get the basics, such as eggs, milk, meat, and bread. WEAVE provides trips to food bank where they can access some of these staples; however, emergency client intakes can happen at any time of the day/night and clients often arrive during times in which the food banks are not open.

There is lack of financial assistance for more general education for clients that are not covered by FAFSA. For example, if a client is interested in certifications or classes that are not for college credits specifically, those types of educational experiences are more difficult to access because of their financial situation.

Finally, another challenge in our emergency residential program is a lack of education around access to appropriate mental health services, especially mental health crisis resources. Numerous clients struggle to find the correct mental health facilities when in crisis and there is a lack of ability for clients to receive follow-up care after crisis.

Narrative Report - describe the program the funds are supporting The Ann Land and Bertha Henschel Funds continue to be used to provide transportation assistance for guests at Wellspring Women's Center. The funds are used to purchase RT tickets (bus and light rail passes). The RT tickets are purchased at half-price through collaboration with Francis House. Tickets are distributed every Monday, Wednesday, and Friday starting at 8:00am for essential travel. In this way, a select number of tickets are given out each Monday, Wednesday, and Friday in order to stretch our supply. Guests can receive an RT ticket every other week as to assist as many as possible. The guests mainly request RT passes to get to court, dental care appointments, health appointments, drug programs, school, employment sites, DHA offices, the social security office and other social service programs.

### **Program Challenges**

The RT tickets are in high demand. The line for bus passes forms in the morning before Wellspring opens. Obviously, the guests are truly in need as they are willing to get up extra early and wait for this service. Indeed, transportation costs are very expensive and beyond the financial means of most of the individuals Wellspring serves

### Attachment 01 – Description/Analysis

**Issue:** The Ann Land and Bertha Henschel Memorial Fund Commission is responsible for the disbursement of income of the Ann Land Memorial Fund and the Bertha Henschel Memorial Fund for the benefit, aid, and assistance of the destitute men, women, and children of the City in such a manner as may be deemed proper and beneficial.

The Commission holds an annual funding meeting every November that lasts up to four hours. Applicants are required to be present to be considered for funding. Commissioner Boniwell expressed his concerns about the current process for grant funding and asked that the issue be brought forward to the Commission for further discussion.

The Commission met on May 16, 2018 and discussed the current process; members expressed a desire to revise the annual funding process from a narrative-driven review process to a metrics-based review process for 2020. Commissioners directed staff to research existing metrics for similar grants; create a ratio/score sheet based on Commission feedback; draft an anonymous survey for grantees to give feedback on application process; modify application period to earlier in the year August/September rather than during the holiday season; and develop information sessions on how to apply for funds.

The Commission identified the following as possible metrics/focus areas:

- Overall budget
- Number of people served
- Total funds requested
- Number of destitute served with funds
- Demographics

- Program design
- Outcomes
- Funding categories
- Gaps in service
- Previous performance
