GENERAL OVERVIEW

Executive Summary

On September 14, 2021, the Sacramento City Council adopted the Mayor's proposed American Rescue Plan Act (ARPA) Framework and Funding Priorities and directed the City Manager, City Attorney, City Auditor, City Treasurer, and City Clerk to implement City Council direction consistent with the adopted ARPA Framework.¹

On October 19, 2021, the City Council adopted Resolution No. 2021-0313, authorizing the City Manager to accept \$112.3 million of State and Local Fiscal Recovery (SLFRF) funding; establish the ARPA Reinvestment Fund; and allocate \$112.3 million to provide government services and budget the resulting available resources in the ARPA Reinvestment Fund to assist with the recovery and reopening resulting from the impacts of COVID-19.²

Upon completing its revenue loss calculations, the City of Sacramento (City) determined that the amount of revenue loss encountered exceeds our SLFRF award of \$112.3 million. Therefore, the City is reporting the use of funds under the revenue replacement eligible use category (EC 6.1) and used these resources for general governmental purposes.

While the scope of the City's Recovery Plan is limited to the City's revenue replacement projects, Appendix 1 is a list of programs authorized by the Sacramento City Council that reflects approved expenditures under the City's ARPA Reinvestment Fund as of June 27, 2023. Uses of Funds

The City of Sacramento's revenue loss due to the COVID-19 pandemic resulted in decreased funding for critical public safety services (Police and Fire). Using the Fiscal Year (FY) 2018/19 ending June 30, 2019, and a growth adjustment of 6.65%, the City's total estimated revenue loss was \$128,019,000 – greater than the \$112,313,331 in SLFRF funds received from Treasury.

To mitigate the negative impact on residents, the City employed a revenue replacement strategy to maintain services levels. Therefore, the City's entire \$112,313,331 in SLFRF funds were allocated toward Expenditure Category 6 – Revenue Replacement, Expenditure Subcategory 6.1 – Provision of Government Services in Fiscal Year (FY) 2021/22, as follows:

As of June 30, 2022, the City's SLFRF projects are complete, and all funds received were expended.

Promoting Equitable Outcomes

The City's revenue replacement strategy ensured that critical public safety service levels (Police and Fire) were maintained to mitigate negative impacts on the City's most vulnerable communities.

The City Council's Racial Equity Committee adopted a Racial Equity Rapid Response Tool as a racial equity lens in the design and implementation of projects funded through the City's ARPA Reinvestment Fund.³ In addition, the City's Office of Diversity and Equity deployed a Community Vulnerability Index to depict the geographic distribution of resources and vulnerability among Sacramento's communities.⁴

Community Engagement

The Mayor solicited public input in the development of his proposed ARPA Framework and Funding Priorities. On August 24, 2021, the City Council held a public workshop to discuss and receive feedback on how the City's ARPA funds should be invested.⁵

Labor Practices

No infrastructure projects or capital expenditures were funded through the City's revenue replacement projects.

Use of Evidence

No evidence-based interventions or program evaluations were funded through the City's revenue replacement projects.
