An Ordinance Amending Section 12.50.040 of the Sacramento City Code, Relating to Entertainment Zone Locations

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Section 12.50.040 of the Sacramento City Code is hereby amended to read as follows:

12.50.040 Entertainment zone locations.

Pursuant to California Business and Professions Code sections 23039.5 and 25690, the city council hereby establishes the following entertainment zones, which include adjacent sidewalks, and adjacent premises specified in section 12.50.020.C.1.

A. 17th and R Street Entertainment Zone.

R Street from the western right-of-way line of 16th Street to the eastern right-of-way line of 18th Street; 18th Street from the northern right-of-way line of R street to the southern right-of-way line of S Street; S Street from the eastern right-of-way line of 18th Street to the western right-of-way line of 16th Street; 16th Street from the southern right-of-way line of S Street to the northern right-of-way line of R Street: and all public streets, sidewalks, and public rights-of-way within in these bounded streets.

B. 20th Street Entertainment Zone.

20th Street from the southern right-of-way line of J Street to the northern right-of-way line of Kayak Alley; and K Street from the western right-of-way line of 20th Street to the western right-of-way line of 21st Street.

C. Ali Youssefi Square Entertainment Zone.

7th Street from the southern right-of-way line of K Street to the northern right-of-way line of Merchant Street; Merchant Street from the eastern right-of-way line of 7th Street to the western right-of-way line of 8th Street; 8th Street from the northern right-of-way line of Merchant Street to the southern right-of-way line of K Street; K Street from the western right-of-way line of 8th Street to the eastern right-of-way line of 7th Street; and Ali

Youssefi Square.

D. Convention Center Entertainment Zone.

12th Street from the southern right-of-way line of L Street to the northern right-of-way line of J Street; J Street from the western right-of-way line of 12th Street to the eastern right-of-way line of 13th Street; 13th Street from the southern right-of-way line of J Street to the northern right-of-way line of I Street; I Street from the western right-of-way line of 13th Street to the eastern right-of-way line of 16th Street; 16th Street from the northern right-of-way line of I Street to the southern right-of-way line of L Street; L Street from the eastern right-of-way line of 16th Street to the western right-of-way line of 12th Street; and all public streets, sidewalks, and public rights-of-way within these bounded streets.

E. Handle District Entertainment Zone.

L Street from the western right-of-way line of 18th Street to the eastern right-of-way line of 19th Street; 19th Street from the northern right-of-way line of L Street to the southern right-of-way line of Capitol Avenue; Capitol Avenue from the eastern right-of-way line of 19th Street to the western right-of-way line of 18th Street; 18th Street from the southern right-of-way line of Capitol Avenue to the northern right-of-way line of L Street; and Liestal Alley from the eastern right-of-way line of 17th Street to the western right-of-way line of the Union Pacific Rail Road tracks.
