Business Rebate Process

1. You must first call 311 to see if rebates are available.
2. To obtain a rebate, customers must agree to a Pre-Installation Survey (Audit). This service is at no direct cost to the customer.
3. Purchase and install the Incentive(s) recommended during the Pre-Installation Survey (Audit). Confirm that the device(s) is/are identified on the list of approved products.
4. Tenants must submit owner authorization letter.
5. Return the original dated receipt with the price, model and brand of each incentive individually, and the completed application. Keep a copy for your records. The Rebate Program is not responsible for materials lost or delayed in the mail, including misdirected mail.
6. Applications will not be processed without a copy of the water bill from the participating water agency that serves the installation address.
7. Submitting a signed application represents agreement to have *the City of Sacramento* verify installation of the incentive, with your accompaniment.
8. *The City of Sacramento* will issue rebate checks within eight to ten weeks of receipt of your completed application materials.
9. The water service providers or their representatives are required to send IRS form 1099 to the customer and the IRS when rebates total \$600 or more.
10. Call the City of Sacramento to verify the rebate amount you are eligible for. Total rebate amount will not exceed money spent. Rebates are up to, and shall not exceed, the following amounts:
 - Toilets (flushometer style) - up to \$250
 - Urinals (flushometer style) - up to \$250
 - Pre-Rinse Spray Valves - \$75
 - Plumbing Flow Control Valves - \$2.50 each (20 min.)
 - Air-cooled Ice Machines - \$300
 - Cooling Tower Controllers - \$500
 - Connectionless Food Steamers - \$200/compartments
 - Dry Vacuum Pumps - \$60/.5 HP (up to 2)
 - Laminar Flow Restrictors - \$5 each (10 min.)
6. For HET/Urinal applications, the reimbursed costs include the purchase price of the device(s), installation hardware and wax ring only, not to exceed the rebate amount. Installation, seat(s), and tax are not reimbursed. Rebates are issued once per lifetime of the property. Both the tank bowl and flushometer must be replaced.
7. For Clothes washer applications, the reimbursed costs include the purchase or leased price of the device, not to exceed the rebate amount. Installation and tax are not reimbursed. Rebates are issued once per owner.
8. Device(s) must be installed at the address identified on the application prior to submittal of this application.
9. All devices for which a rebate is issued are subject to an on-site installation verification inspection. If device installation cannot be verified, the payee will reimburse the Rebate Program for rebate funds received including all associated processing costs. Access to the rebated device (s) must be provided.
10. The payee's Social Security number or Tax ID number must be provided in order to receive a rebate. The Social Security or Tax ID number requested in the Rebate Application process is in compliance with exemptions to the Federal Privacy Act of 1974, 42 UCS 405 (c) (2)(c). The Internal Revenue Service requires Rebate Program participants receiving \$600 more in rebates to be issued an IRS Form 1099 unless exemptions apply. Social Security numbers provided as part of the application process are held in confidence under terms of the Privacy Act and are not divulged or otherwise conveyed to individuals or organizations outside the Rebate Program.

Disclaimer

The City of Sacramento reserves the right to deny an application of any participant who does not meet all requirements as outlined. The City provider reserves the right to change the terms of this program at their discretion. The City is not responsible for receipts or paperwork lost in the U.S. mail. The City cannot guarantee that the installation of the incentives will result in lower water utility costs. The number of rebates is dependent upon the availability of program funds. Applications will be processed when all required information is provided by the applicant; on a first-come, first-served basis.

Qualifications

1. The location of installation must have water service by *the City of Sacramento*.
2. Commercial, industrial, institutional and multi-family applicants are eligible.
3. New construction is not eligible for rebate under this program.
4. The purchased or leased device(s) must be new and an approved model in order to apply for a rebate.
5. Complete applications will be processed in the order received. This offer is subject to available funding. Rebates are available to customers of participating water agencies only.
