RE: Letter of Understanding - Miscellaneous Classifications Under \$20 Per Hour (Local 39)

This Letter of Understanding (LOU) confirms the agreement reached between the City of Sacramento ("City") and International Union of Operating Engineers, Stationary Engineers, Local 39 ("Local 39"), regarding the above referenced matter.

Specifically, the agreement is as follows:

1. Effective within sixty (60) calendar days of this Agreement, the City will eliminate all salary steps that are below \$20.000000 per hour for the classifications identified in "Exhibit A." The published salary schedule will be amended as shown in Exhibit A. Notwithstanding Section 6.1 of the current Memorandum of Understanding (MOU) between the City and Local 39, the salary schedules for the classifications identified in Exhibit A will no longer consist of eight steps.

2. Those employees in the classifications identified in "Exhibit A" and who are currently earning an hourly rate of pay below \$20.000000 per hour shall be advanced to the nearest salary step that places them at or above \$20.000000 per hour. Those personnel and their new salary step are identified in "Exhibit B."

3. Incumbent personnel identified in "Exhibit B" shall continue to utilize their date of appointment to their current classification for purposes of determining eligibility for future salary step advancement. Salary step advancement for these incumbents shall be administered consistent with the processes outlined in Article 7 (Salary Administration) of the MOU between the City and Local 39.

This Agreement does not establish precedent, nor does it interpret any employee rights under the language of the Labor Agreements, the Rules and Regulations of the Civil Service Board, or any applicable policies and procedures of the City of Sacramento except as expressly stated herein.

This Agreement memorializes and constitutes the entire understanding between the parties as to all matters referred to or included herein and supersedes and replaces all prior negotiations, proposed discussion, whether written or oral.
