





457(b): Contributions Breakdown




457(b): Distribution Breakdown Dollar Amount*

457(b): Distribution Breakdown Transaction Amount







457(b) Participant Count by Age Group




457(b) Average Account Balance by Age Group




457(b) Average Annualized Participant Contribution by Age Group










Net Flow - All Non-Cash Assets (3-Month Period Ending 6/30/2022)




Market Value Allocation - Mutual Funds (Quarter over Quarter)






Market Value Allocation - Equities (Quarter over Quarter)





Net Flow by Sector - Equities (3-Month Period Ending 6/30/2022)











Market Value Allocation - Equities (Quarter over Quarter)






Net Flow by Sector - Equities (3-Month Period Ending 6/30/2022)


