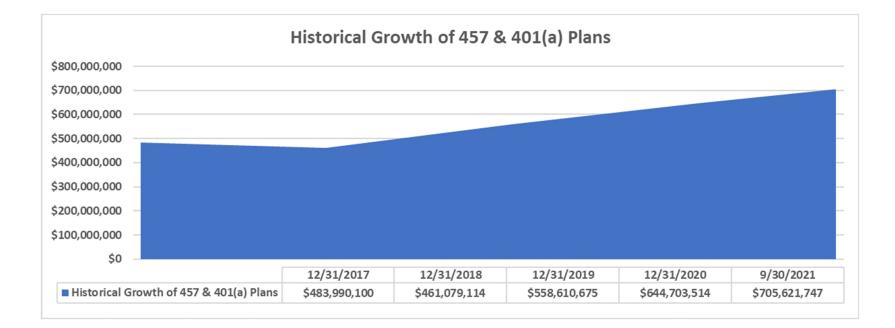

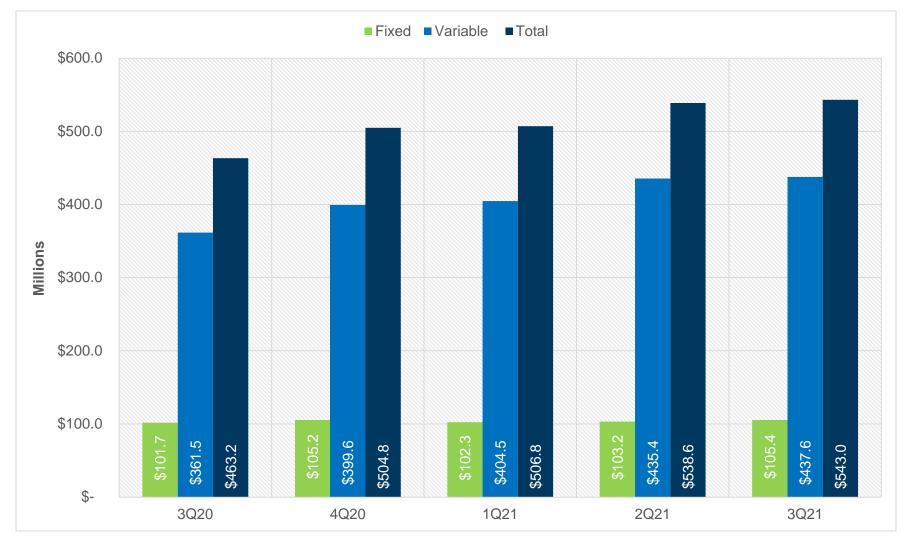

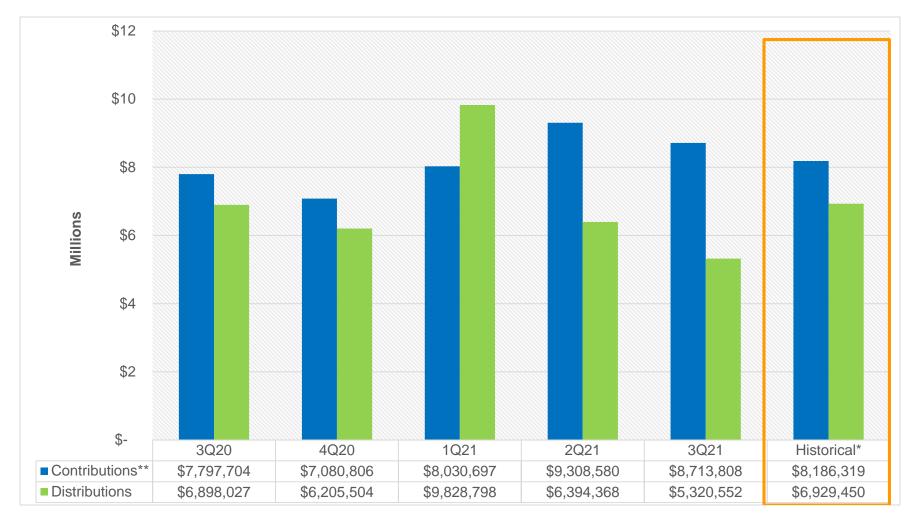
457(b): Asset Growth*

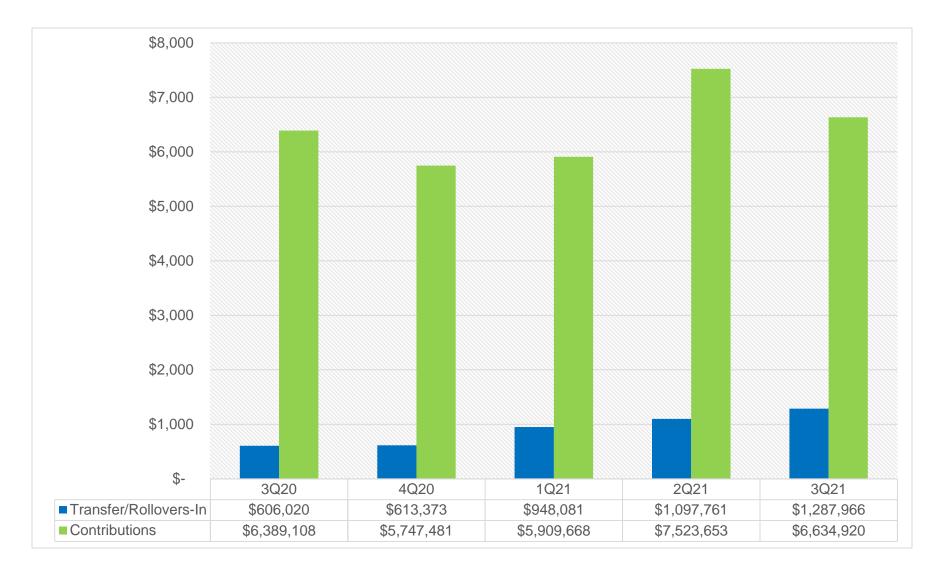
457(b): Contributions & Distributions

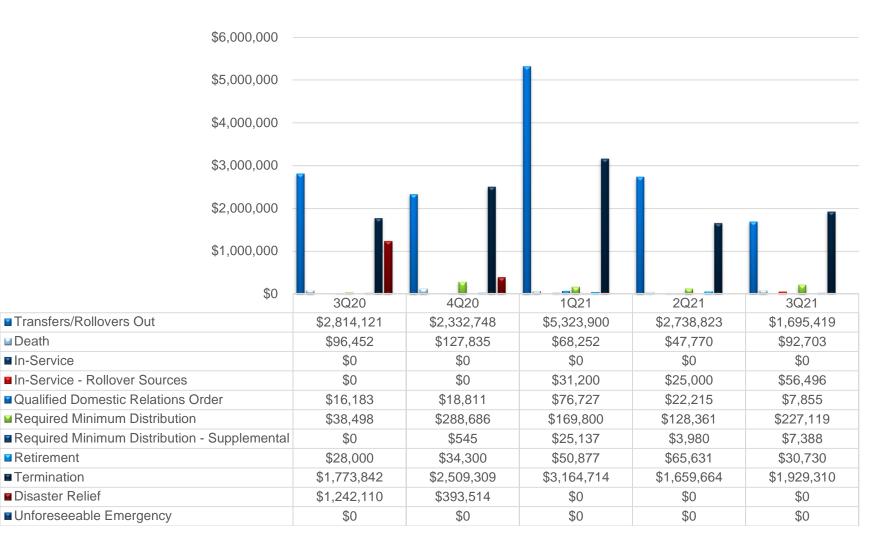

457(b): Contributions Breakdown



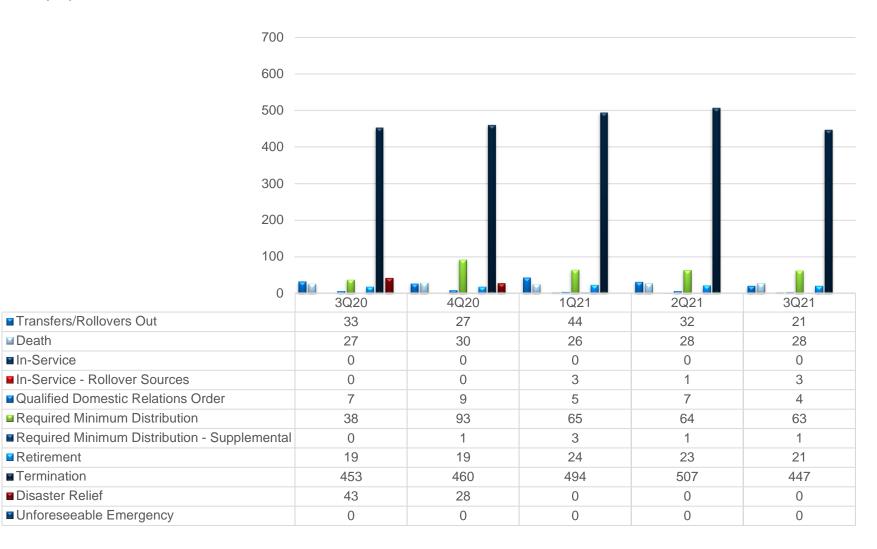

457(b): Distribution Breakdown Dollar Amount*

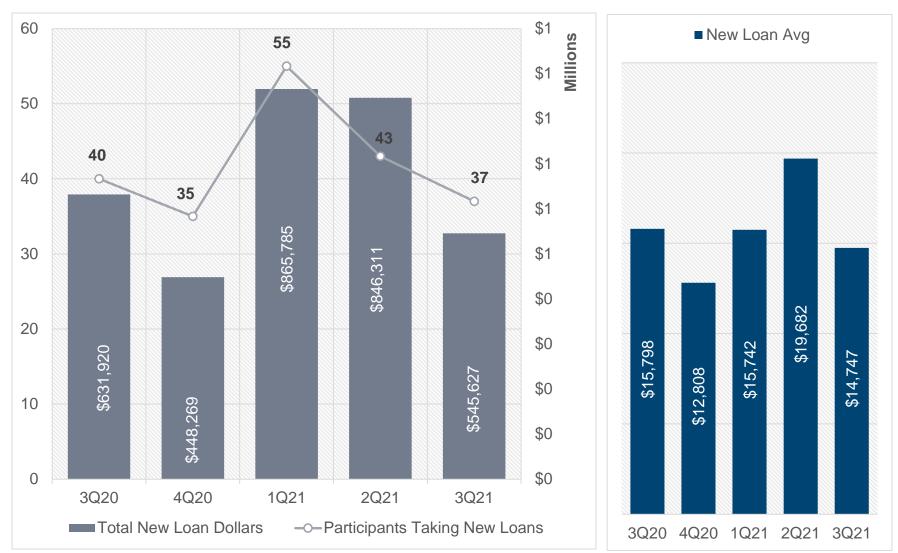

457(b): Distribution Breakdown Transaction Amount

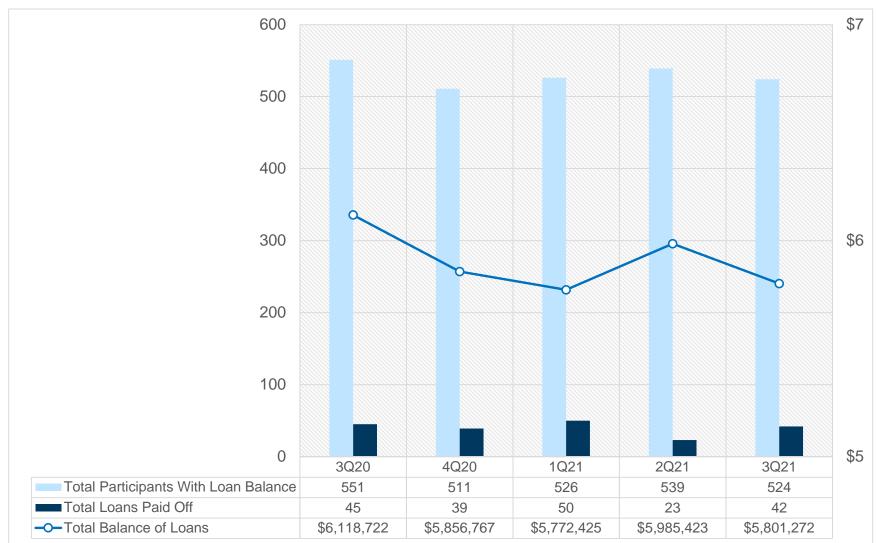

457 (b) Loan Activity



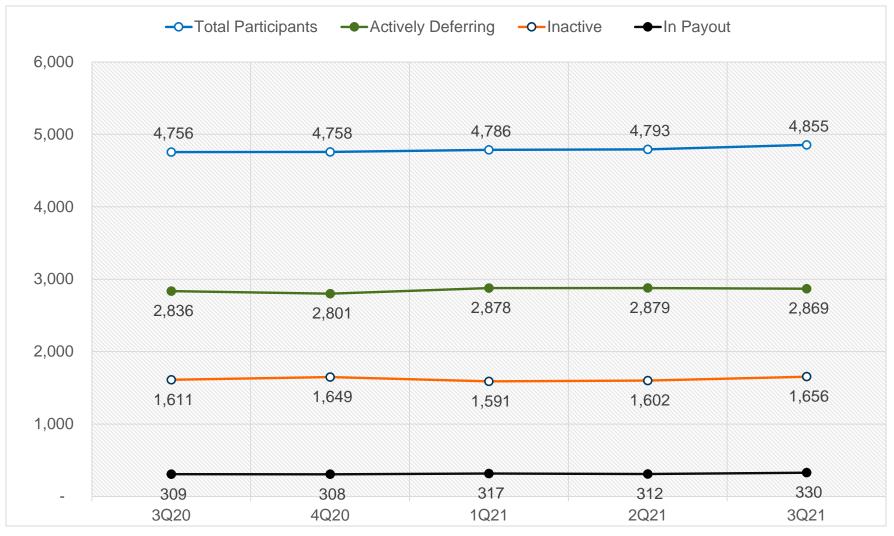

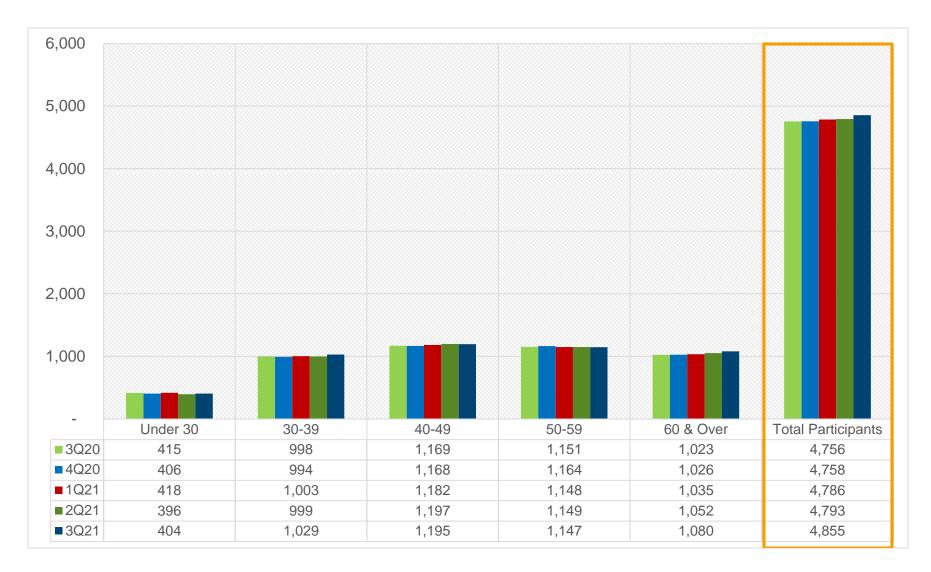

457(b) Average Account Balance by Age Group

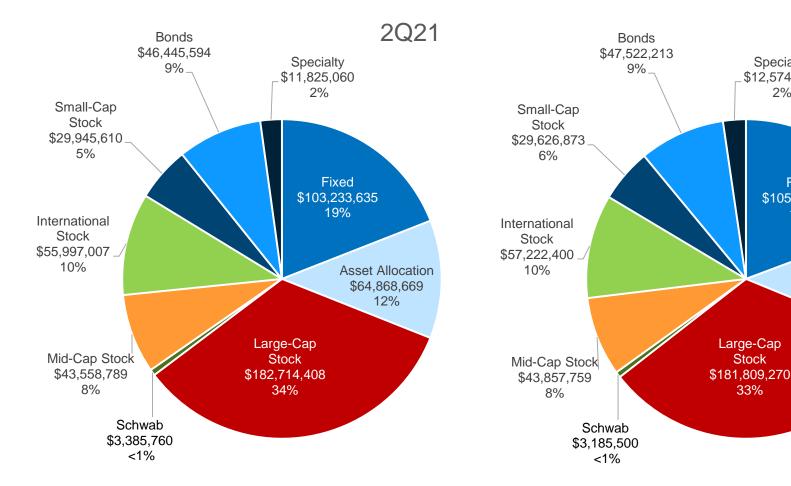

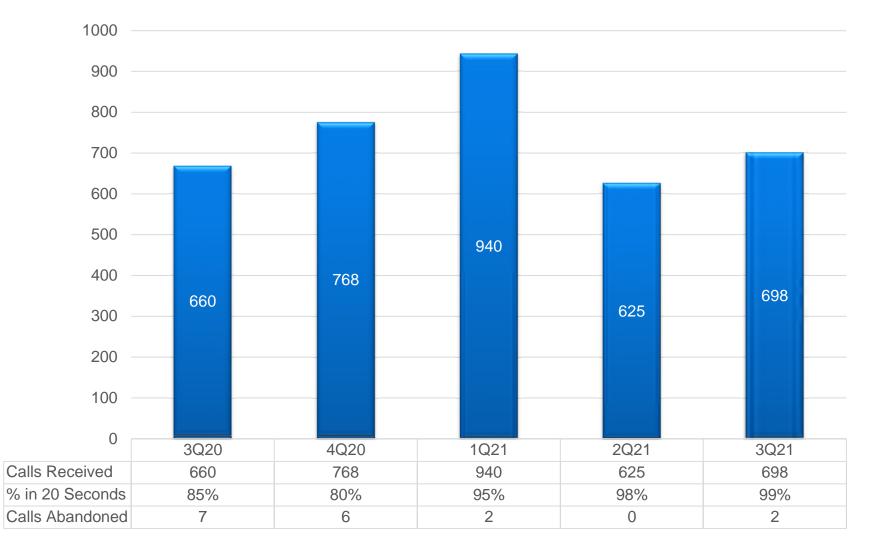

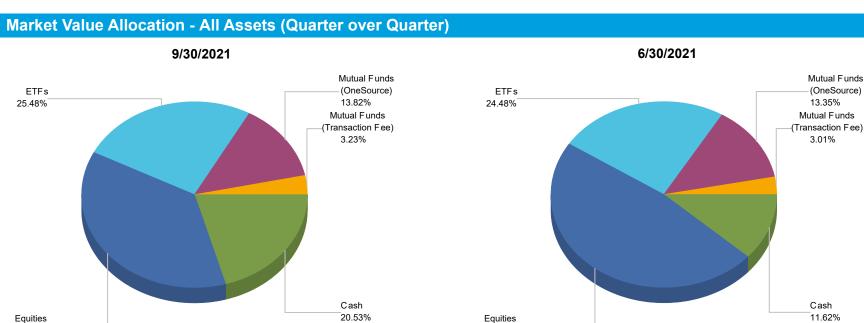

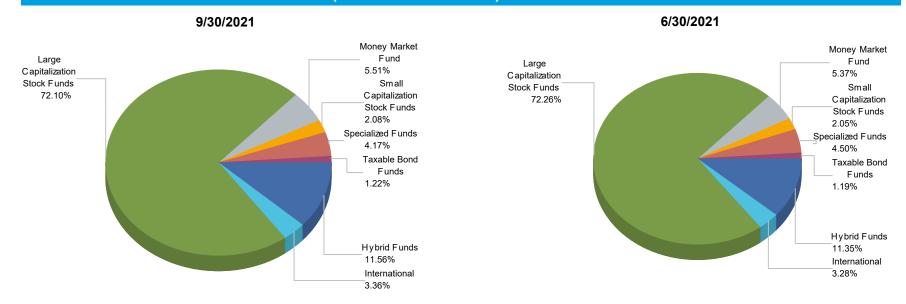
Net Flow - All Non-Cash Assets (3-Month Period Ending 9/30/2021)

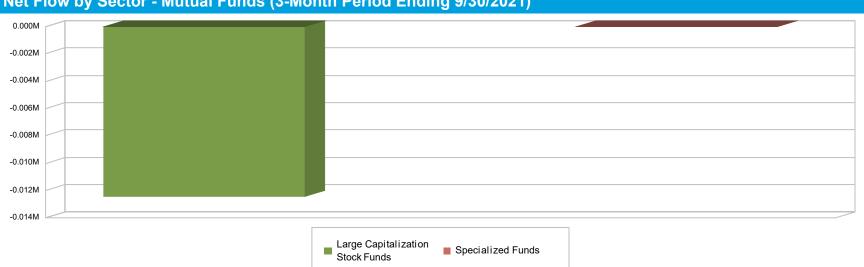

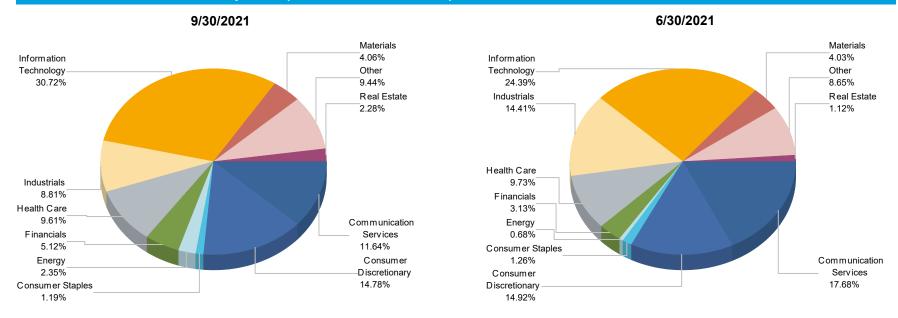


Net Flow by Sector - Mutual Funds (3-Month Period Ending 9/30/2021)

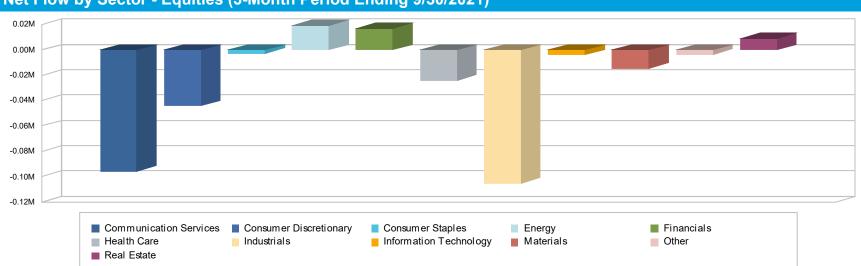

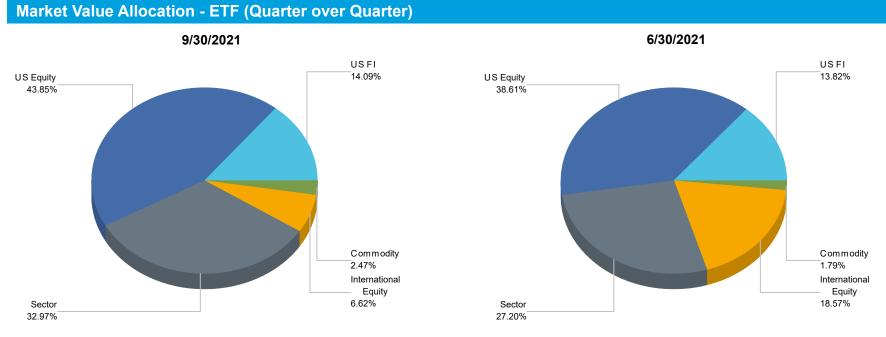
Market Value Allocation - Equities (Quarter over Quarter)



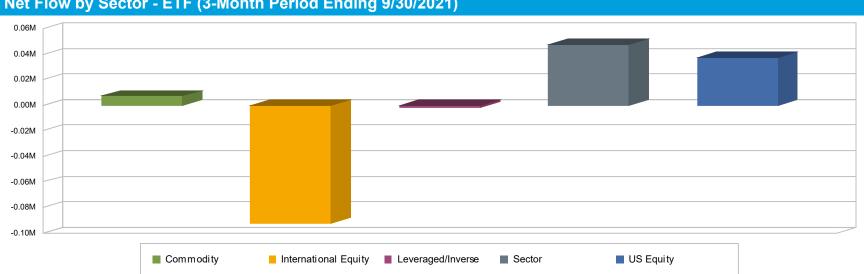

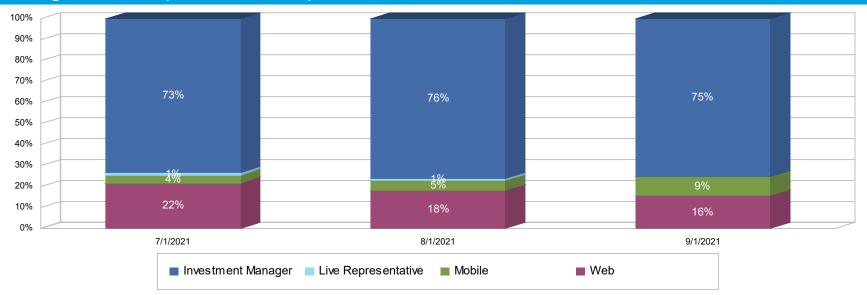


Net Flow by Sector - ETF (3-Month Period Ending 9/30/2021)

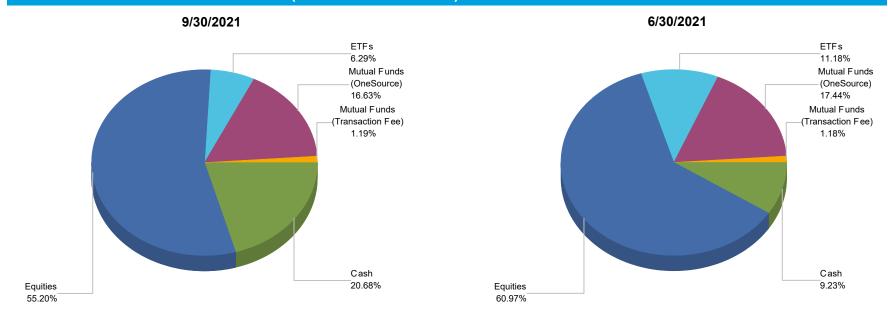

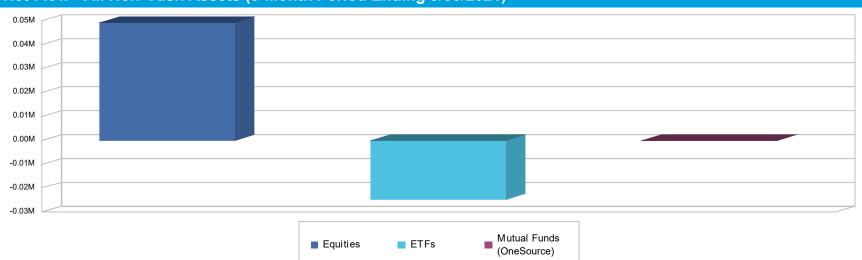

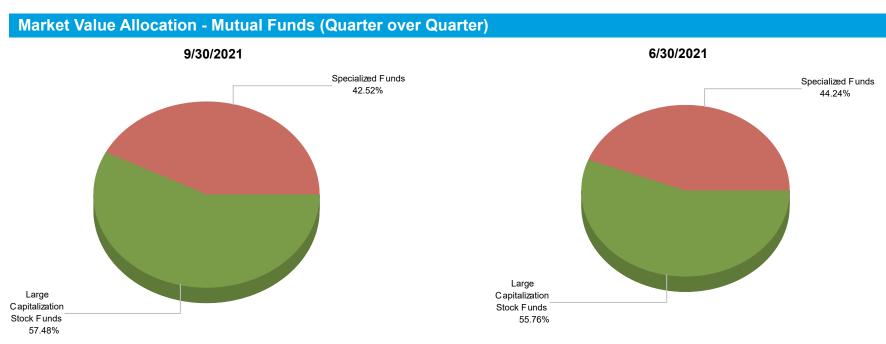
Market Value Allocation - All Assets (Quarter over Quarter)

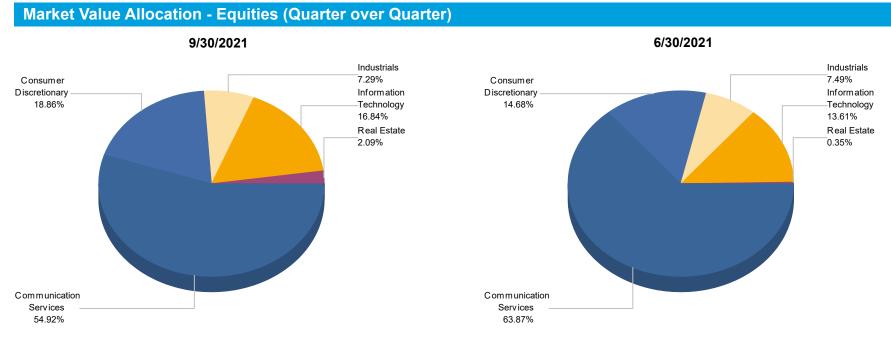
Net Flow - All Non-Cash Assets (3-Month Period Ending 9/30/2021)



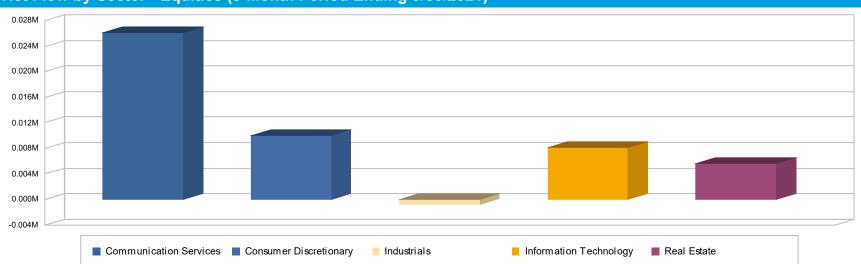

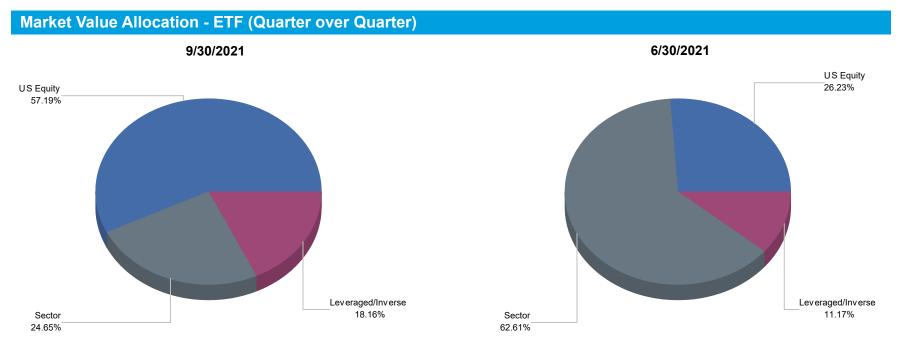
Net Flow by Sector - Mutual Funds (3-Month Period Ending 9/30/2021)



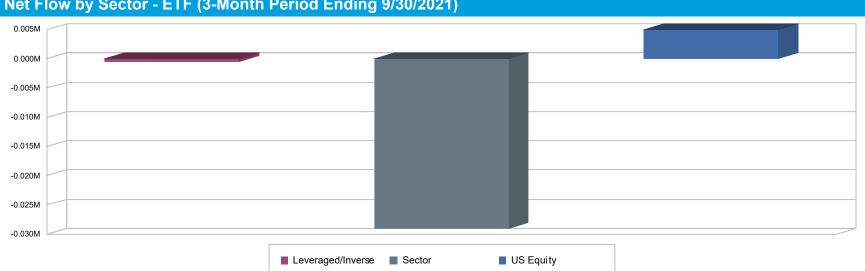

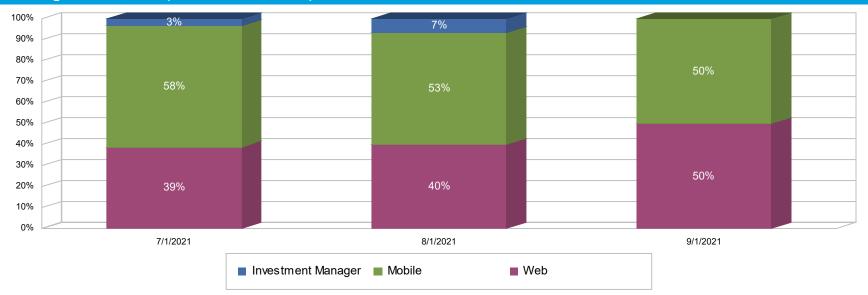


Net Flow by Sector - ETF (3-Month Period Ending 9/30/2021)
