Statement of Purpose: *The course will provide Officers with a review of historical and current circumstances and incidents that have influenced crowd management strategies and tactics. The course consists of lecture, open-discussion, break-out groups, and scenario-based training that will enhance their tactical knowledge and skills in responding to crowd control incidents, including riots. Equipment & Safety Inspections shall be conducted.*

IV. FUNCTIONS OF THE INDIVIDUAL OFFICER

- A. Positions
 - 1. On Guard
 - 2. Ready
- B. Gather intel and report
- C. Avoid independent action unless in defense of life or serious bodily injury

V. TEAM FORMATIONS AND FUNCTIONS

- A. 3-person team
 - 1. Arresting Officer / Team Leader
 - a. Leads the team
 - b. Decides who to arrest
 - c. Continuously assess and reassess
 - 2. Custody / Protection Officers
 - a. Grab suspect (**ARREST AND CONTROL TACTICS WON'T BE PART OF THE COURSE**)
 - b. Protect team / suspect
 - 3. Quick response team
- B. 5-person team
 - 1. Custody Officers
 - 2. Protection
 - 3. Team leader
- C. "T" formation (5-person shield team)
 - 1. Team Leader
 - a. Direct team and strategies
 - b. How to determine who to arrest
 - c. Continuously assess and reassess
 - 2. Team Members
 - a. Protection Officers
 - b. Custody Officers
 - 1. Must break through and grab suspect
 - 2. Secure suspect behind shields or line
- D. Functions of an Officer in a full shield team
 - 1. Dress right. Keep line straight and tight
 - 2. Hold shields up. Protect self

3. Use baton to “strike a tune” on the shield **(BATON WILL BE HELD BUT NOT USED FOR STRIKES)**
 - a. Use noise to intimidate and discourage
 4. Strictly an offensive formation used in extreme situations

1. Once an Officer becomes part of a squad, they must think of themselves as a cog in a larger wheel.

- A. Baton Use in Riot Control
1. Two Handed control required
 - a. Proximity of other Officers on the team
 - b. Press or moving
 - c. Sweeping motion for arrest
 2. Baton techniques
 - a. Ready position
 - b. Port Position
 - c. Defensive and offensive strikes
 3. Defense
 - a. High
 - b. Mid
 - c. Low
- B. Shield techniques
1. Striking the shield
 2. Driving the crowd
 3. Defense against projectiles

VII. **SCENARIOS (No chemical agents will be used)**

- E. Arrest in verbally simulated gas environment *NO CHEMICAL AGENT WILL BE USED
- F. Rescue

Student Learning: Students will demonstrate skills learned by determining the proper action taken and movement formations when presented with active and passive resisters. NO CHEMICAL AGENTS will be utilized at any time. Students will only have to don gas masks when verbally instructed to do so. **It should be noted that Arrest and Control Tactics will not be a part of this course and the batons will only be held but NOT used for strikes.**
