4. Modes of Transmission

- a. Direct Contact
- b. Indirect Contact
- c. Airborne Transmission

5. Degree of Exposure

- a. Close proximity
- b. Contamination of clothing
- c. Contact with subject's bodily fluid or droplets through non-intact skin, mucous membrane, or eye membrane

6. Exposure Protocol

- a. Officer notifies Sergeant of possible exposure
 - i. Sgt responds to the scene and determines if exposure or not
 - ii. If no exposure, an Emergency Response Employee Report can be filled out but is not required.
- b. If it is determined that there is an exposure:
 - i. Notify on-call DICO officer
 - ii. Attempt to gain consent from subject to have blood drawn
 - Complete Workers Compensation forms and Emergency Response Employee Report
 - iv. Transport source patient to ER for testing
 - v. Transport source patient to jail or 849b upon release from ER.
 - vi. Route forms to Work Comp and DICO team
 - vii. If source patient refuses testing, contact DICO team immediately and they will obtain a court order from the city attorney's office.
