### Incident Summary

---

4/23/13 1557 hrs. The Communication Center received a 911 call stating that an off duty Sac PD officer (Southward) was in a physical fight with a subject and requested code-3 cover. This was occurring inside the Espinosa Family Chiropractic, located at 3330 Folsom Bl.

Officer Southward was inside the chiropractic office when an aggressive panhandler entered the business and began asking for money. He noted that the subject was under the influence of alcohol. Officer Southward advised the subject he needed to leave the building. The subject refused to leave after several demands. The subject stated for someone to call the cops. Officer Southward identified himself as a Sacramento Police Officer verbally and by displaying his badge/ID. He instructed the subject to leave once more but he refused. The subject then squared up in a fighting position. Officer Southward placed the subject in a twist-lock control hold and escorted him outside. Once outside, the subject fell to the ground.

1600 hrs. Officer King arrived on the scene and assisted Officer Southward. The suspect continued to resist arrest, however the officers were able to quickly get the subject into custody. Officer King also used a twist lock control hold to secure the subject in handcuffs.

Officer King transported the subject to jail for 647f PC and 148 PC. The booking nurse rejected the prisoner due to the possibility of a dislocated shoulder. It was unclear if the injury occurred during the arrest, fall, or if it was preexisting injury. That was due to the subject's high level of intoxication.

The prisoner was transported to Sutter General Hospital for evaluation/treatment. While waiting for registration, the subject had a seizure and collapsed to the floor. He struck his head on the floor causing injury.

The prisoner was cited and released due to him not being fit for incarceration.

Officer King's I.C.C. recorded the audio portion of the arrest - outside the building. The camera was not positioned correctly for the video recording.

The Use of Force was justified and within department policy.

I am a sworn police officer with the City of Sacramento Police Department.

Today, I was off duty, and I was inside the business (Espinosa Chiropractic - 3330 Folsom Blvd). I was in plain civilian clothes. I was waiting for my wife. She was almost done, and at the reception desk. A MWA (Bosick) walked in the business, and started asking for money. I could smell alcohol about his person, and he had slurred speech.

I stood up, and set my son (in child safety seat) behind me. I told him he needed to leave. He did not. I told him to leave several times, but he did not. He continued to walk into lobby area. I grabbed his right wrist with my left hand. I placed him in an arm-bar. I pulled his arm out straight, and pressed down near the outside of his elbow to force him toward the door using the leverage. I walked him out of the front door, and he fell to the ground once he was outside. I didn't push him, or strike him at all. My wife called the police, and they showed up shortly after.

On 04/23/2013, at approximately 1559 hours, I (Officer King #210) was dispatched to 3330 Folsom Blvd for a request for code 3 cover from an off-duty Sacramento Police Officer. I arrived on scene at approximately 1600 hours. I observed the following in summary:

3330 Folsom Blvd is small "L" shape strip-mall located on the southwest corner of 34th St, and Folsom Blvd. There are four separate attached business (no actual suite numbers however).

I observed Officer Dustin Southward standing in front of Espinosa Family Chiropractic, in the "elbow" of the shared parking-lot. In front of him, sitting on the ground, was a MWA (later identified via jail booking photograph as Steve Bosick. There was no active struggle, or altercation currently. He was sitting down facing me. Officer Southward quickly stated that Bosick squared off with him inside the business, and had to forcibly be removed. I could smell alcohol about Bosick's person.

I instructed Bosick to lay on the ground. He did not respond to my command. He had slurred speech, and I could not understand what he was saying. At this point I believed Bosick to be under the influence of alcohol enough to where he could not care for him self. Based on my observations, and Officer Southward's brief statement to this point, I attempted to affect an arrest for 647(f) PC (public intoxication). I was in full police uniform, with my duty belt, badge, and "Police" patches on each shoulder clearly visible.

I grabbed his right arm, and lifted it up parallel to the ground. I placed my left arm behind his right shoulder. He was tense, and was not cooperating. I rotated him clockwise using the leverage (pushing with left hand, and pulling with my right), and placed him a supine position. He was still tense, and attempted to pull away. I put my weight on his back, and secured his right arm behind his back. Officer Southward was able to reach underneath Bosick, and secure his left hand. We were able to cuff Bosick at this point.

I took Officer Southward's statement (see statement).

Bosick was placed under arrest for 148(a)(1) PC (resist, delay, obstruct police officer), and 647(f) PC. Neither Officer Southward, nor I, was injured at all during the incident. I asked Bosick if he needed an ambulance, but I could not understand what he said. I did not observe any injuries about his person. He did not indicate to me that he was hurt or injured.

I transported Bosick to jail. Bosick now had complaint of pain to his right shoulder. The jail nursing staff advised he possibly had a dislocated right

shoulder. It was unclear to me when Bosick suffered the injury (during contact with Officer Southward, or when I was detaining him).

I asked Bosick when he injured his shoulder. He still had slurred speech, and was hard to understand.

I transported Bosick to Sutter General for treatment. We were sitting in the triage area of the ER. He was sitting in a seat drinking a cup of water. The nurse had already taken his "vitals". At this point he was not handcuffed. Bosick's eyes started to roll back. I called for a nurse as it appeared he was beginning to have a seizure. Bosick fell forward to the floor, and hit his head. He began seizing violently, and was bleeding from his forehead. The hospital staff tended to Bosick. He stopped seizing, and was taken to a room. He suffered a 2" laceration (and bruising) to his forehead where he fell. Hospital staff advised that Bosick's stay would be lengthy as a precautionary to potential head, and neck injuries.

Sgt. Chapman was advised throughout.

CSI was requested to photograph Bosick's injuries, and the scene (3330 Folsom Blvd).

Bosick was cited for the above charges, and released per 853.6 PC. He was not able to sign the citation with his right hand, but did with his left. He stated he understood what was going on. He declined to make a statement. Bosick was still not clear if he had previous shoulder injuries, or when it was injured.

I contacted [REDACTED] via phone (original caller, and witness), and obtained her statement (see statement).

I responded back to 3330 Folsom Blvd. I did not observe any video surveillance cameras. The business was now closed. I made a request for additional follow-up the following day to contact employees that may have witnessed the incident.
