Incident Summary

On 4-24-13 at 1634 hrs Ofc B. Laird and Ofc C. Schneider arrived at [REDACTED] 21st St in regards to a disturbance between a husband [REDACTED] and wife [REDACTED]. [REDACTED] called stating that her and [REDACTED] were arguing and the dispatcher could hear [REDACTED] yelling a [REDACTED].

Ofc Laird arrived and asked [REDACTED] to speak inside the residence. [REDACTED] was calm and speaking with Ofc Laird then became very agitated and began yelling at Ofc Laird and began cursing at him. Ofc Laird calmed [REDACTED] down again and approximately 2 minutes later [REDACTED] suddenly became agitated again, cursing at Ofc Laird and telling him to take him to jail. [REDACTED] stood up off the couch and told Ofc Laird he was going to punch him and took a fighting stance.

Ofc Laird stepped back and had [REDACTED] sit down. [REDACTED] advanced towards Ofc Laird who retreated. Ofc Laird requested Ofc Schneider's assistance in placing [REDACTED] in handcuffs for [REDACTED] evaluation.

Ofc Schneider took [REDACTED] right arm and Ofc Laird took control of his left arm. Ofc Laird was placing [REDACTED] left arm behind his back when he began to pull away. Ofc Laird placed [REDACTED] left arm in a rear wrist lock. As he applied the wrist lock, Ofc Laird felt [REDACTED] wrist bend and heard a popping sound.

Ofc Laird and Ofc Schneider placed [REDACTED] into handcuffs and called for Fire to evaluate [REDACTED] wrist. Engine 16 arrived and stated [REDACTED] did not need to be transported by ambulance but recommended X-rays be taken. Ofc Laird placed [REDACTED] on a 5150 hold at Methodist Hospital. The wrist was later found to be broken.

Due to the incident occurring inside a residence there was no In Car Camera video. [REDACTED] did not see the incident due to her being outside the residence. This use of force was within policy.



On 4-24-13 at approx 1651 hrs I, Ofc. Laird #459 (1C51) responded to a Domestic Violence call at [REDACTED] 21st St.

The caller [REDACTED] advised dispatch that her husband was yelling and cussing at her. The call taker could hear the male half ([REDACTED]) yelling at her. He would alternate between threatening her and then begging her not to have him arrested. At one point the call taker heard him threaten to hit her in the face and ask if she wanted to get belted, then he went back to begging her. At another point the call taker heard him apologize and beg her not to leave him.

I arrived with Ofc. Schneider and observed both parties standing in the front yard. As I approached [REDACTED] told me to make her not leave. I asked him to come inside and began attempting to get the story from him. Ofc. Schneider obtained a statement from [REDACTED] (see attached).

[REDACTED] sat on the couch and stated that he was stressed due to the condition of his mother. Then, out of the blue, [REDACTED] face became very grimaced and he stated "you fucking bastard". This surprised me as he was calm for the approx 2 minutes I had dealt with him to this point. I asked him if he was speaking of me and he quietly stated he was talking about himself.

[REDACTED] then continued to tell me about the issue he had with his mom's health and then suddenly growled and looked at me saying, "take me to jail then you fucking bastard". I became concerned at this point as to his mental health due to his erratic changes of behavior.

[REDACTED] then stood up with a grimaced face and squared up in a fighting stance stating, "I'm gonna punch you in the fucking face". I stepped back and told him to sit down. He advanced and I again told him to sit and I would not allow him to strike me.

After a few moments in a fighting stance, [REDACTED] calmed and sat down. I determined I was going to place a hold on [REDACTED] and called Ofc. Schneider on the radio (she was outside interviewing the female half). Ofc. Schneider was next to me within seconds and I advised we were taking him into custody immediately for 5150 evaluation.

I obtained [REDACTED] left arm and Ofc. Schneider his right. We asked him to

get up and he did. I began to put his left arm behind his back and he began attempting to pull away from us. I told him not to pull away or resist and acquired a department approved rear wrist lock. As I did this I heard a popping sound and felt his wrist bend. I looked at Ofc. Schneider and she was attempting to pull his right arm back. I quickly applied cuffs and said that his wrist may have been injured and to call fire. [REDACTED] did not yell out in pain so I asked if his wrist did hurt. He moved his hand and stated it did. Ofc. Schneider called fire and Engine 16 arrived. They advised he did not require transport by ambulance but may need xrays of the wrist.

I transported [REDACTED] to Methodist hospital and placed a 5150 hold on him. Xrays revealed a broken wrist.

I notified Sgt. Wann and CSI responded for photos. A red border form was completed as well.

I stayed outside the residence, at the far north side of the front yard, with [REDACTED] and obtained her statement.

Officer Laird went into the residence with [REDACTED] and obtained his statement.

From speaking to [REDACTED], I determined no crime had occurred. She related she just wanted to get her belongings and leave.

I went into the residence to advise Officer Laird. Officer Laird was standing in the residence living room, and [REDACTED] was sitting on the living room couch (north side of living room). The living room is directly east of the residence front door. As I spoke to Officer Laird, I observed that [REDACTED] had not settled down and still appeared to be upset regarding the situation, begging for us not to let [REDACTED] leave him. I had to yell at [REDACTED] regarding his wife being an adult and having a right to do as she pleases.

I went back outside to speak to [REDACTED] and give her an opportunity to come inside and get her belongings so she could leave.

As I was in the front yard speaking to [REDACTED], I could not hear Officer Laird speaking to [REDACTED] inside. Over police radio, I heard Officer Laird ask for me to come back inside the residence. I immediately went inside.

I saw Officer Laird standing in the living room, and [REDACTED] sitting on the couch. Officer Laird advised me that [REDACTED] had just "squared up" on him, got in his face, and threatened to punch him. Officer Laird stated he feels [REDACTED] is bi-polar, dangerous, and that Officer Laird was going to put him on a 5150 hold.

Officer Laird ordered [REDACTED] to stand up from the couch. Officer Laird went to [REDACTED] left side, and I went to his right side. Officer Laird grabbed his left arm to attempt to handcuff [REDACTED], as I simultaneously grabbed his right arm. [REDACTED] immediately began pleading for us not to handcuff him, was looking back at us, pulling both of his arms away, and not listening to Officer Laird's commands to put his hands behind his back.

After a few seconds of [REDACTED] trying to pull his arm away, I got [REDACTED] arm into a departmentally approved two-handed rear wrist lock. I could tell that [REDACTED] was also pulling his left arm away to avoid handcuffing due to his pulling away and Officer Laird's repeated commands for [REDACTED] to stop resisting. About five seconds after we had attempted to handcuff [REDACTED] I heard a single "pop" sound coming from his left side (arm). I did not hear [REDACTED] say anything after the "pop". I immediately looked to my left and saw that Officer Laird had [REDACTED] left hand in a departmentally approved two-handed rear wrist lock.

Officer Laird looked at me and asked me if I heard that "pop", and I told him that I did. Officer Laird told me that he was afraid [REDACTED] may be injured. He told [REDACTED] to settle down, and we were able to get him in handcuffs. Officer Laird advised me to request the fire department for medical aid.

I requested fire to look at [REDACTED] wrist. I asked [REDACTED] if his wrist or arm hurt, and he complained of pain on both sides from the handcuffs only. He did not have any other complaints of pain and did not request medical aid.

Officer Laird transported [REDACTED] to Methodist Hospital and I let [REDACTED] back inside the residence.

Records or information, the disclosure of which would constitute an unwarranted invasion of personal privacy (Cal. Gov. Code § 7927.700; see also City of San Jose v. Superior Court (1999) 74 Cal.App.4th 1008);

Records or information, the disclosure of which would reveal personal identifying information, where, on the facts of the particular case, the public interest served by not disclosing the information clearly outweighs the public interest served by disclosure of the information (Cal. Pen. Code § 832.7(b)(7));

Records or information wherein the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure (Cal. Gov. Code § 7922.000);

Records or information that constitute confidential medical, financial, or other information, the disclosure of which is specifically prohibited by federal law or would cause an unwarranted invasion of personal privacy (Cal. Pen. Code § 832.7(b)(6)(C)); and

Records or information, the disclosure of which is exempted or prohibited pursuant to federal or state law (Cal. Gov. Code § 7927.705; see also Cal. Const. art. 1 Sec. 1; Cal. Pen. Code §§ 11105 and 13300; and HIPAA 45 CFR Part 160 and Subparts A and E of Part 164)
