Incident Summary

Officer Frazer and Pangelinan were at the AM/PM clearing a call for service. Officer Frazer observed a Paladin Security officer being confronted by an individual. The subject appeared to be very upset and yelling at the security officer. The subject then walked away and threw a glass bottle toward the Paladin officer, landing in the roadway.

Officer Frazer drove over to the subject and started to get out of his car. The subject ran at Officer Frazer, who pushed the subject away. The subject then backed off while continuing to yell and not follow direction. The subject then ran away from Officers S/B Jibboom, then across the street into the motel parking lot. Officers Frazer and Pangelinan initially drove after the subject then chased him on foot.

The subject attempted to climb over the fence at which point Officer grabbed him. The subject then threw his head back, head-butting Officer Pangelinan, causing minor injury to Officer Pangelinans forehead/temple area and temporarily breaking Officer Pangelinans glasses (snapped back together).

Officer Frazer grabbed the subject and pulled him to the ground. The subject continued to resist and fight with both officers. Officer Frazer applied the Carotid control hold on the subject, enabling him to be handcuffed. The subject continued to resist and attempt to pull away and kick at officers.

Officer Peirsol arrived to assist and assisted in walking the subject to a patrol car. At one point the subject again tried to pull away and Officer Peirsol got his hand caught up in the handcuffs, injuring his right hand. Officer Frazer sustained minor scratches to his left hand.

The subject was transported to Sutter General for medical clearance prior to booking. Once at the jail, he again attempted to pull away and fight with Officers.

The force used during this incident was appropriate and within policy.
