Incident Summary

While driving in the area of Del Paso Blvd/ Plaza Ave, Officer Bradley #0545 observed 3 male subjects standing on the sidewalk in front of Lauderdale. As he approach the group, they began to walk in all directions. A young male (15 years old) was contacted by Officer Bradley who stated that he knew one of the males, but not the other.

2 of the subjects began to cross the roadway outside the crosswalk. Officer Bradley attempted to make an enforcement stop for violation 10.20.020 SCC. One of the subjects took off running around the building. Officer Bradley followed the subject and re-acquired him in front of the Lauderdale building.

Officer Bradley exited his patrol car and drew his firearm giving the male subject verbal commands. The male subject (later identified as [REDACTED]) became argumentative and aggressive. He called the Officer "bitch" multiple times and failed to comply with his commands to show his hands. S-[REDACTED] began pounding his chest with his fist and then spit at the feet of Officer Bradley.

Officer Bradley holstered his firearm and drew his CED. He continued to give verbal commands, but with no compliance. He then discharged his CED at the subjects chest. He observed S-[REDACTED] fall head first into the pavement. After the 5 second cycle was done, he observed that S-[REDACTED] was still shaking, as if in a seizure. Officer Bradley observed that one of the CED probes had hit S-[REDACTED] in the side of the head (temple area).

Security Officers from Paladin Security assisted Officer Bradley in handcuffing the subject. Officer Bradley requested Code 3 Medics to treat S-[REDACTED] who had become unresponsive. Multiple statements were taken from Paladin Security Officers and witnesses on-scene that were consistent with Officer Bradley's observations.

Officers remained with S-[REDACTED] at the hospital for over 24 hours as the Doctor's estimation was that he would be cleared for incarceration soon. After the ETA changed a couple of times, it was determined by Lt Ellis to issue him a citation and release him per 853.6 PC.

Paladin Security Officer [REDACTED] described the suspect's demeanor as having an aggressive state and that he swung his arms in an aggressive manner towards Officer Bradley. He also described the suspect to take a fighting stance prior to the discharge of the CED.

Paladin Security Officer [REDACTED] described the incident by saying that Officer Bradley discharged his CED just as the subject lowered his center of mass and turned his head to the left while advancing for the attack.

Officer Bradley advised that he pointed the laser on the CED at the suspect's chest and fired as the suspect started to charge at him. His intention was to deploy the CED to the chest area of the suspect, but when the suspect lowered his head to charge, one of the probes struck him in the head.

I responded to the scene, reviewed the report, the ICC video, and the report from Bradley's CED. Based on my response and review, I believe the use of force was justified and within the Policy of the Sacramento Police Department. The suspect had an agitated demeanor, speaking aggressively at the Officer and then took a fighting stance and was ready to charge at him.

During my review, I observed a couple areas of concern:

Officer Bradley stated that he believed his overhead lights were on during the chase and that he tried to push the button on his ICC mic during the incident to activate the ICC. After viewing the ICC video, there was no audio footage of the incident until after Officer Bradley had discharged his CED. Sergeant Armstrong discussed this discrepancy with Officer Bradley and he advised that he must have only switched his switch into the first position, causing only the rear amber/blue lights to flash. That would explain why the ICC video did not come on while he was chasing the subject.

The video appeared to be turned on by the button directly behind the camera as there were no other activations on the ICC screen and the vehicle car door closed momentarily after the audio turned on. The direction of the squad car and the ICC camera left no video of the exchange between Officer Bradley and S- [REDACTED]. It appeared that Officer Bradley did not have his ICC mic synched up to the squad car. When Sergeant Armstrong discussed this issue with Officer Bradley, he advised that he had put his ICC mic on the charger to synch it and forgot to retrieve the mic and holster it on his belt which would have completed the synch process. He advised that he had to enter the squad car and activate the ICC after the CED discharge after he realized that the ICC was not activated and he didn't have his ICC mic on his person.

I discussed with Officer Bradley the need to sync the Mic at the beginning of shift and to turn on the ICC and Mic as soon as practical when making an enforcement stop/contact. We reviewed the policy related to ICC's and the microphones. Officer Bradley stated he understood the policy and was advised regarding compliance in the future.

On Sunday, December 6th, 2015, I, Paladin Private Security Officer [REDACTED] observed as two Hispanic male adults walked southbound on Del Paso Boulevard towards McDonald's (2517 Del Paso Boulevard).

I observed as male Hispanic adult (Subject 1) continued to walk on the side walk. I noticed as male Hispanic adult (Subject 2) wearing no shirt proceeded to the McDonald's windows facing Del Paso Boulevard. I then observed as subject (2) began swinging his arms (in a striking or punching form) towards the windows and then pointing fingers at patrons inside of the store.

I then observed as subject (2) proceeded to subject (1) location. Together both subjects crossed the street, stopping vehicle traffic. I noticed as subject (2) appeared to be swinging his arms (in striking or punching form) towards the vehicles that are stopped. I continued to observe as both subjects finished crossing the street (Del Paso Boulevard).

I then observed as the subjects entered the lobby of the business (Taco Bell 2434 Del Paso Boulevard). I observed as subject (1) proceeded to the counter to make an order. I noticed subject (2) began circling the lobby of the business, continuing to throw his arms in the air and appeared to be also swinging his arms (in punching motion). I then proceeded to the parking lot of 2501 Del Paso Boulevard, where I observed subject (2) had his arms above his head and aggressively yelling at Sacramento Police Officer Bradley Badge 545. I parked my patrol vehicle (nosed in) to block any escape paths of subject (2). I noticed Sacramento Police Officer Bradley already had his taser drawn and pointed at subject (2). I exited my patrol vehicle, drawing my taser, I heard Sacramento Police Officer Bradley giving verbal commands to subject (2), who ignored the commands. I observed as subject (2) began crouching into a ready stance to tackle someone. I then observed as subject (2) began to move forward, I heard Sacramento Police Officer Bradley's taser deploy. I holstered my taser and observed as subject (2) fell head first into the pavement of the parking lot.

I asked Sacramento Police Officer Bradley badge 545 if he wanted subject (2) in handcuffs. Sacramento Police Officer Bradley badge 545 replied yes. I proceeded to subject (2) placed my handcuffs on his right wrist. I advised subject (2) to stop resisting and give me his other arm. I noticed the cycle of the taser had stopped, I then noticed subject (2) continued to move. Trying to grab subject (2) left hand, I looked at subject (2) I noticed a probe sticking from the side of his right head. I then noticed some blood on the pavement. I asked Sacramento Police Officer Bradley if I should continue with handcuffing subject (2). Sacramento Police Officer Bradley advised to continue handcuffing subject (2) for our safety. I then asked Paladin Private Security Officer [REDACTED] to assist me with moving subject (2) left hand under his body. I was then successfully able to complete the handcuffing process of subject (2).

I then noticed as a large group of occupants began forming around our immediate location. For our safety, I stepped away and began conducting crowd control. I then noticed as off duty Paladin Private Security Officer [REDACTED] arrived to our location. I asked Paladin Private Security Officer [REDACTED] to assist with crowd control.

Shortly after, I noticed as numerous Sacramento Police Officers arrived to our aide. I then assisted with taping off the area and stood by as Sacramento Fire and Paramedics arrived.

I along with Paladin Private Security Officer [REDACTED] remained on site as Paladin Private Security Officer [REDACTED] departed the scene.

On Sunday, December 6th, 2015, I, Officer [REDACTED], responded to a Paladin call for backup at Taco Bell, located at 2434 Del Paso Boulevard.

Paladin Officer [REDACTED]'s initial call for assistance was radioed at approximately 5:56 PM. I was advised via [REDACTED] that he had been contacted by employees at Taco Bell and requested to eject an unidentified Hispanic male adult who was behaving erratically, swinging at the air, being aggressive and disturbing customers in the lobby. The subject was reported to be shirtless and possibly under the influence of narcotics.

I arrived on scene at 2434 Del Paso Boulevard at approximately 6:04 PM. I met with [REDACTED] on scene, and provided contact cover while he established verbal communication with the subject. Based on my training and first hand experience with numerous narcotic influenced subjects in the field, I observed the subject's erratic body language and aggressive demeanor to be indicative of such influences at this time.

While we were able to obtain uneasy compliance with our verbal directives to depart, the subject remained in a highly agitated, aggressively combative state. We tactically retreated to a position of observation as the subject departed the premises on foot but remained on scene to ensure he did not engage anyone else in the area in a violent manner.

However, we observed the subject's hostility increase to the point where he was actively engaging oncoming vehicles in fist fights in the middle of Del Paso Boulevard. The subject then crossed the street and approached several customers at the Subway and Laundreland in an aggressive manner. We also observed the subject punch a nearby tree several times. We observed that the subject was an ongoing threat to himself and innocent bystanders, as well as motorists along Del Paso Boulevard.

As we prepared to cross the street to Laundreland, we observed a Sacramento Police patrol vehicle actively attempting to communicate with the subject. The subject fled on foot through down the street behind Subway and Sacramento Police Bradley, badge #545, turned his vehicle around to engage the subject for questioning.

When Bradley arrived at Laundreland, located at 2503 Del Paso Boulevard, I observed him exit his vehicle and to attempt to verbally engage the subject. However, the subject maintained his previously observed aggressive state. The subject screamed at and swung his arms in an aggressive manner toward Officer Bradley. Bradley drew his non-lethal, conductive electrical weapon in preparation for what appeared to me as an eminent attack against his person. Bradley shouted several verbal commands and the subject did not appear to comply.

Instead, the subject's visible aggression appeared to increase, and the subject took an offensive fighting stance. I then observed the subject enter what can only be described as a 'bull rush', football-like charging position as if to attack Officer Bradley at the hips or legs. Officer Bradley discharged his non-lethal, conductive electrical weapon just as the subject lowered his center of mass and turned his head to the left while advancing for the attack. I then observed what appeared to have been an ineffective taser deployment as the subject was still thrashing about in a combative manner.

I observed the subject fall to the ground and continue to thrash but did not hear any further cycles of power from Bradley's conductive electrical weapon. Out of fear for Bradley's immediate safety, Officer [REDACTED] and I moved to engage and assist Bradley by securing the combative subject.

[REDACTED] and I restrained the subject and assisted with cuffing him. I noted blood on the ground and realized the subject must have hit his head on the asphalt when he fell after being exposed to a single cycle of energy. After securing the subject, I observed the subject cease his resistance. Then suddenly, I observed the subject enter what appeared to be a state of seizure.

Fellow Paladin Officer [REDACTED] arrived on scene and assisted me with provided medical aid. We secured the subject's limbs and head to prevent him from further injuring himself, and checked his mouth for the possibility of his tongue obstructing his airway. We placed the subject's head slightly backward and elongated his throat to allow air to pass freely. We opened the subject's mouth and visually verified that he did not bite or swallow his tongue during the seizure. After verifying the subject had a steady pulse, Officer [REDACTED] applied the use of salts to the subject's nose to bring him back to consciousness. We then utilized a sternum rub technique to keep him conscious and provided psychological first aid. We talked to the subject and kept his eyes on us. During this time, the subject moaned, and spoke one or two words and appeared visually stable.

Emergency medical services arrived on scene in response to the incident and immediately began to render aid. The paramedics requested that the subject be handcuffed to the gurney for their safety. [REDACTED] and I rendered this assistance in response to their request.

Once the subject was stabilized by emergency medical services, he was transported to a local hospital for further assessment and treatment.

Officer(s) [REDACTED] and I remained on scene while CSI investigated the scene. We also assisted with crowd control and protecting the scene from numerous citizens encroaching upon the area. As witnesses to the entire incident, we remained on scene until we were given the authorization by law enforcement to depart.

On 12/06/2015 at approximately 1815 hours, I Ofc.Bradley #545, was on routine patrol in the area of Del Paso Blvd and Plaza Ave. I was in full police uniform, driving a fully marked police vehicle.

While driving south on Del Paso Blvd, I observed 3 male subjects standing on the sidewalk in front of 2503 Del Paso Blvd (Launderland). One of the subjects had a "Mongolian" style hair cut which I know to be common among Norteno gang members. Based on my training and experience, I know this to be a high crime area with frequent narcotic sales and gang activity. I pulled into the parking lot of 2503 Del Paso Blvd (Launderland) and intended to conduct a consensual contact with the three subjects.

As I entered the parking lot, the group quickly dispersed. Two of the subjects began to walk together on Del Paso Blvd. The third subject (later identified as [REDACTED]) began to walk towards my patrol car. I rolled down my window and asked how old he was. He replied, "fifteen." I asked [REDACTED] who the other two subjects were and he said, "one is a family friend and I don't know the other one."

I began to suspect that the other two subjects may be trying to recruit [REDACTED] into a gang. I left the parking lot in an attempt to contact the two subjects who were now crossing Plaza Ave outside of the crosswalk in violation of 10.20.020 S.C.C. (jaywalk within 300 ft of crosswalk).

One of the subjects (later identified as Julian Morales) was throwing his hands in the air and jumping up and down as he crossed the street. The other subject had his head down the whole time and did not look in my direction.

I turned out of the parking lot and saw Morales look back at me. He had long dark hair and was wearing dark pants and a dark colored hooded sweatshirt. I turned south onto Del Paso Blvd and saw Morales start to sprint away from me. The other subject he was with continued to just walk on the sidewalk with no attempt to flee. I activated my overhead emergency lights and began to chase Morales in my patrol car.

Morales entered the parking lot of 2421 Del Paso Blvd and began to run north around the building. I followed him through the parking lot and

observed him run back south onto Plaza Ave. I drove south on Plaza Ave and no longer saw Morales. I quickly re-entered the Laundreland parking lot and observed Morales sitting on the outside of the business next to [REDACTED].

Morales' build, hair, and clothing matched the person I was chasing. Morales appeared to be winded and was breathing heavily. Based on my training and experience, I know that often times gang members are armed with weapons. Due to Morales' possibly being armed, I exited my patrol car and drew my firearm. I told Morales to show me his hands and slowly walk towards me. He replied, "for what bitch?" I yelled several times for him to show me his hand but he refused and called me a "bitch" repeatedly. [REDACTED] got up and walked away into the laundry mat.

Morales then started to quickly approach me. He appeared to be agitated and walked quickly toward me as I had my firearm pointed at him. He was pounding his chest with his right hand while his left hand was balled into a fist. I told him to put his hands up but he would not comply. I requested additional units for assistance via my portable radio.

He began to get within one foot of me while yelling and throwing his hands up. I shoved him backwards with my left hand and told him to get back. He replied, "oh you gonna push me now bitch?" I quickly holstered my firearm and transitioned to my conductive energy device (CED). I pointed my CED at his chest and gave him several verbal commands to get on the ground. Morales then spit on the ground at my feet and told me to "fuck off bitch!" He continued to place his hands near his waist.

Morales showed no signs of compliance and only became more aggressive as I gave him numerous verbal commands to get on the ground. I began to fear for my safety and thought Morales was about to attack me. I did not know where [REDACTED] or the other subject that was with Morales had gone. No other units police units were on scene yet and Morales had not yet been searched.

I pointed the red laser dot of my CED at Morales' chest and again yelled for him to get on the ground. Morales suddenly placed one foot back and crouched forward as if he was going to charge me. I deployed my CED and observed Morales fall face first to ground and begin to shake. Two Paladin Security Officers (Officers [REDACTED] and [REDACTED]) approached me from behind and asked if I needed them to handcuff Morales to which I replied, "yes." I turned off my CED as Paladin Officers [REDACTED] and [REDACTED] handcuffed Morales.

Despite my CED being off, Morales continued to shake on the ground in what appeared to be a seizure. A pool of blood started to form under Morales'

head. I holstered my CED and requested medical aid to respond code-3 to the scene.

An additional Paladin Officer (Officer [REDACTED]) advised he was a medic and began to render medical aid to Morales. As I rolled Morales over to his side I noticed that one of the CED prongs had entered his chest, while the other had entered his forehead.

Additional SPD Officers began to arrive on scene and controlled the large crowd that was gathering around me. Medic 17 arrived on scene and began to provide medical attention to Morales. Morales was transported to UCD for his injuries. Ofc.Catricalla rode with Morales to the hospital and monitored him until Ofc.Svizzero arrived to relieve him(See Supplements).

Sgt.Quinn (3SM1) arrived on scene and advised me to clear the immediate scene. I re-traced the area where Morales ran, but did not locate any contraband. I was unable to locate the third subject that Morales and [REDACTED] were initially with. [REDACTED] was detained by SPD Officers who obtained his statement.

CSI arrived on scene and photographed the area where the incident occurred.

Officers spoke to all witnesses on scene and obtained their statements (See Officers Supplements for details).

The Paladin Officers who witnessed the incident emailed me their statements which were printed and turned into records as a supplement to this report.

Morales was charged with resisting,obstructing, or delaying a peace officer (148(A)1 PC).
