Incident Summary

LITIGATION HOLD 02/21/15 (see attached memo). B

RT Sgt Cully had received complaints from a citizen of aggressive transients on the property of 1700 Alhambra Blvd. He asked RT officer Rath and Deputy Huffman to frequent the area. On 03/23/2015, they located two subjects on the property of 1700 Alhambra Blvd. One subject was cooperative and began packing up his belongings as instructed. The other subject was ignoring officers commands to exit the box and display his hands. Numerous requests were made to show his hands but no response. Deputy Huffman reached for the suspect's right arm, while officer Rath reached for his left arm. Both officers continued to tell the suspect to show his hands but he refused. Prior to Deputy Huffman obtaining a grip of the suspect's arm, the suspect attempted to elbow Deputy Huffman in the head. Deputy Huffman attempted to apply a shoulder hammer lock on the suspect's right arm. Officer Rath grabbed his left arm. During the struggle, Deputy Huffman heard a loud pop and thought that the suspect's arm had broken.

The Fire Department responded and transported the suspect to Sutter General Hospital where it was confirmed, his right arm was broken. An area canvas was conducted. CSI responded to photograph the scene and photographed the suspect at the hospital.

Prior to the first subject leaving the scene, officers obtained his statement as a witness to the incident.

The suspect was cited for 243 (b) PC and 148 PC and released at the hospital.

I, Sgt. Peck #3125, responded to the scene, 1700 Alhambra. I contacted both the officer and the deputy that were involved. I observed fire rendering first aid to the suspect. I ensured that a canvas was completed, that CSI responded to the scene and to the hospital, that the one and only witness was contacted and a statement taken, and that the proper paperwork was completed.
