Incident Summary

The following account describes a use of force, police K9-deployment. Information for this summary was generated from prepared police reports, statements from officers on scene, witness statements, neighborhood canvas and review of all available ICC footage/audio. All officers were wearing full police uniforms and riding in fully marked patrol vehicles equipped with functioning in-car-camera (ICC) systems. I (Sergeant Justin Brown #3129) was working as the District 6 patrol supervisor (1SM6).

On 5/1/16 (Sunday) at approximately 0022 hours, K9 Officer Dustin Henderson #0343 (K94) along with Officers Alexander Wagstaff #0922 (1A67), Christopher Swift #0668 (1A87), and Bradley Nelson #0378 (1A36) responded to 1031 30th Street (Chevron Gas Station) regarding a report of a felony assault in progress. The caller (— Employee) indicated that a group of 5 to 6 subjects were in a physical fight in front of the location and one of the subjects was armed with a handgun. The armed subject was described as a male black adult, approximately 25 to 26 years old, medium build, and wearing a red sweatshirt. The armed suspect was later identified as Jeremy Johnson (2/2/89 XREF: — Validated — Validate

Officers Swift and Nelson were the first to arrive on scene, followed by Officers Wagstaff and Henderson. Upon arrival, the officers made contact with the group of subjects, including suspect Johnson who was in the area, just north of the gas station. Suspect Johnson matched the description of the armed subject described above and was given verbal commands to "stop and show his hands" as he began to flee from officers. Johnson sprinted westbound across 30th Street away from officers despite several verbal commands not to run given by K9 Officer Henderson (briefly recorded by Henderson's ICC MIC at the start of the foot pursuit – 072521.av). At the moment, Officer Henderson summoned his police service canine (Ike).

As Johnson fled on foot through a parking structure toward J Street, Officer Henderson clearly observed the suspect remove a large black firearm magazine from his waistband and instructed K9 Ike to apprehend suspect Johnson based on the following:

1) Suspect Johnson's physical and clothing description was a complete match to the armed suspect description given to dispatch during the time of the call.

2) Suspect Johnson immediately fled holding his waistband when officers attempted to contact him. Officer Henderson feared at the time that he was armed with a handgun.

3) Suspect Johnson had not been patted down or searched for any weapons.

4) Suspect Johnson was fleeing into a downtown parking structure during early morning hours, posing a threat to the safety of the public if he was not immediately captured.

5) The suspect had reportedly brandished a firearm during a physical altercation.

6) Officer Henderson was in fear for his safety, the safety of cover officers, and the public if the suspect was not immediately captured. Due to the suspect possibly being armed with a gun and the rapidly evolving situation, additional K9 warnings were not warranted. Supervisor approval was not obtained and guidelines for deployment were met.

Officer Henderson and K9 Ike followed suspect Johnson to the southeast corner of 29th Street/J Street where

Henderson attempted to physically grab the suspect just after he threw the firearm magazine in the area and fell to the ground (lost his footing). The suspect physically resisted arrest by rolling on his stomach and flexing his upper body/arms, preventing Officer Henderson from controlling his arms/hands (officer could not see his hands). K9 Ike bit suspect Johnson's right arm as he continued to physically resist arrest. Officer Wagstaff arrived at the location, and assisted Officer Henderson with taking the suspect into custody. K9 Ike was called off just prior to Officer Wagstaff's assistance. As a result of the struggle Officer Henderson sustained a minor abrasion to his right hand.

Additional officers arrived at 29th Street/J Street for assistance and located a loaded 9mm handgun (Glock 26) and a high capacity magazine in close proximity to the custody location.

Sacramento Fire/Medical personnel (Medic 19/Engine 4) arrived at the scene and provided medical care for suspect Johnson (sustained puncture/avulsion wounds to his right upper and lower arm). Prior to being booked into jail (25850 PC/25400(a) PC/148(a) PC), Johnson received further medical care at Sutter General Hospital until he was fit for incarceration. CSI (Lustig #6373) responded to photograph Johnson's injuries as well as Officer Henderson's injuries. A canvas was completed for witness statements and possible video surveillance of the incident. I responded and took control of the scene.

Upon review of this incident, it is my belief that the use of force (canine deployment) was within the Sacramento Police Department's policy. I viewed all available ICC footage of involved officers with negative results.

On 05/01/16 at approximately 0022 hours, I, Ofc Wagstaff #922 responded to 1031 30th St regarding 5-6 subjects in a physical fight. I was in a marked Sacramento Police car in full Sacramento Police uniform. Per the text of the call the complainant stated that one of the subjects in the fight was armed with a gun. I arrived on scene at approximately 0025 hours. I observed the following in summary:

Over the radio, dispatch broadcasted that the subject that was armed with the gun was a male black adult 25-26 5'5 medium build with a red sweat shirt on (later identified as Jeremy JOHNSON). Upon arrival I observed JOHNSON wearing a red sweat shirt that matched the description that was broadcasted. JOHNSON was walking north along the west side of 30th St. I then lost sight of JOHNSON for a few seconds as he walked east into Jazz Aly. JOHNSON then reappeared and started to walk west on Jazz Aly towards 30th St.

I observed a male black adult, medium build, wearing a red sweatshirt looking around in a nervous fashion approximately 40 feet away to my south. Officer Swift attempt to verbally contact the suspect who immediately started sprinting away from him. I reversed my patrol vehicle and observed the suspect run around my clearly

I got out of my K9 patrol vehicle and yelled "Don't run! Don't run!" I then called my police service canine, "Ike" to a heel as I ran across 30th St. When (S) Johnson got into the parking structure I could see him remove what appeared to be a black colored large firearm magazine from where he was holding onto his waistband/pocket area. I instructed K9 Ike to apprehend the suspect based on the following:

1) Suspect Johnson's physical and clothing description was a complete match to the armed suspect description given to dispatch during the time of the call.

2) Suspect Johnson immediately fled holding his waistband when officers attempted to contact him. I feared at that time that he was armed with a firearm.

3) Suspect Johnson had not been pat-down or searched for any weapons at this point.

4) Suspect Johnson was fleeing into a downtown parking structure during early morning hours posing a threat to the safety of the public if he was not immediately captured.

5) The suspect had already brandished the firearm during a physical altercation.

6) I was in fear for my safety, the safety of my cover officers, and the public if the suspect was not immediately captured. Due to the suspect possibly being armed with a gun additional K9 warnings were not warranted.

(S) Johnson continued running west and then south through the parking structure as K9 Ike and I gave chase on foot. The suspect attempted to actively evade my K9 partner by constantly changing directions and running around cement pillars in the structure. He exited onto K St and then made a northbound turn on 29th St with K9 Ike in pursuit.

I observed (S) Johnson loose his footing and start to fall to the ground on the southeast corner of 29th St and J St. I observed him throw the large firearm magazine in a northeast direction approximately 5-10 feet away from him. Due to the suspects abrupt stop I quickly overtook his position. As I

approached him I could not clearly see his hands. I grabbed ahold of (S) Johnson who then attempted to roll onto his stomach in some shrubs on the corner. I still could not see his hands from under him. (S) Johnson was flexing his upper body and arms to prevent me from pulling them away from his body. I could not tell if he was attempting to retrieve a firearm so I attempted to control his arms to keep them away from his body while he continued to struggle and fight. K9 Ike made contact with (S) Johnson's right arm during the struggle as I continued to wrestle both of the suspect's arms away from his body. At this time, Officer Wagstaff arrived to assist. I yelled to Officer Wagstaff that I could not see the suspect's hands. At no time did (S) Johnson release tension in his arms or stop resisting our attempts at handcuffing. Officer Wagstaff began to assist in the struggle of (S) Johnson. Due to Officer Wagstaff's close proximity K9 Ike released his hold of (S) Johnson and I placed him in a down/stay near us. Officer Wagstaff and I physically pulled his arms out from under him and so he could be handcuffed.

I immediately requested Sacramento Fire/Medical units to check (S) Johnson. I later observed puncture and avulsion wounds to his right lower and upper arm. Fire responded and transported (S) Johnson to Sutter General Hospital.

Other officers arrived on scene to assist. Officers located a Glock 26 (9MM) handgun approximately three feet south of where we took (S) Johnson into custody. Per officers who secured the handgun it was loaded with one in the chamber. 23 live bullets were found in the magazine, and three on the ground where the magazine was thrown. (Carrying loaded firearm in public - 25850 PC / Carrying concealed firearm - 25400(a) PC) Officers Hann and Goggin took custody of the handgun to be booked into evidence.

CSI responded to the scene and took photographs. CSI also responded to Sutter General and obtained photographs of the suspect. Officer Quilhon responded to the hospital. Officer Quilhon attempted to gain a statement under Miranda from (S) Johnson. (See supplement)

Multiple patrol officers were tasked with conducting a neighborhood canvass for witnesses to the incident.

I sustained an approximate 1/2 inch x 1/2 inch abrasion to my right hand as a result of the struggle to take (S) Johnson into custody.
