Incident Summary

On 7-18-16 at 0506 hrs., Officers Lewis and Price were dispatched to the [REDACTED] Apartments located at [REDACTED] Millcreek Drive regarding a caller who had advised dispatch that her boyfriend's brother was high on narcotics and having a psychotic episode. While enroute, dispatch received six additional calls regarding the same subject banging on vehicles and apartment doors. One caller advised that she had locked herself in her bedroom with her daughters because she was afraid the subject was going to break down her door.

Officer arrived at 0513hrs. Upon arrival, they located a subject walking in the parking lot (later identified as [REDACTED]) matching the callers description. Officers gave [REDACTED] voice commands to stop. [REDACTED] was making erratic movements with his body but complied with the Officers commands. Officer Price placed [REDACTED] into a standing modified arrest position and placed a handcuff on his right wrist while Officer Lewis had control of the left wrist. [REDACTED] attempted to pull away from Officer Lewis so Officer Lewis used an arm bar takedown to bring him to the ground. [REDACTED] landed face down in the grass. [REDACTED] started flailing his arms, striking both Officers in the face and head. Officer Price was struck in the groin by [REDACTED]'s foot or leg.

[REDACTED] fought his way up to his feet and then turned towards the Officers. Fearing for his safety and the safety of his partner, Officer Price discharged his CED at [REDACTED] which was ineffective due to the probes not penetrating [REDACTED]'s shirt. [REDACTED] then turned and walked away. Officers followed him and after he failed to follow voice commands. Officer Price advised him that a CED was being deployed and discharged his CED into [REDACTED]'s back. The CED was effective and [REDACTED] fell to the ground in the grass.

Officers attempted to handcuff him but [REDACTED] again was able to fight his way to his feet and continue his resistance. Officers fell to the ground and [REDACTED] got back up several more times. Officers were beginning to feel exhausted due to the prolonged struggle. Officer Lewis administered the Carotid Control Hold on suspect [REDACTED] which rendered him unconscious. They again attempted to handcuff [REDACTED] but he regained consciousness quickly and continued his resistance. Officer struggled with [REDACTED] for approximately two more minutes until Officers Monelo #307, Fitzgibbon #659, Barret #627, Thompson #471, and Tsverov #893 arrived and assisted in restraining [REDACTED] so that he could be handcuffed. Once handcuffed, Officers requested medical aid .

[REDACTED] was transported to Sutter General Hospital by SFD Medic #20. CSI also responded and took photos of the suspect and Officers injuries. Officer Lewis received an approximately .5" abrasion to his right knee as well as a complaint of pain to both knees. Officer Lewis received bruising and swelling to both of his knees. Suspect [REDACTED] sustained an approximately 1" laceration on the firth side of his forehead, a medium 2"x2" abrasion to his left shoulder, and puncture wounds from the CED prongs on his back.

I responded to the hospital to provide medical paperwork to the Officers. Suspect [REDACTED] would calmly ask for water then immediately start screaming incoherently and had to be restrained by several Officers. CSI responded and took photos of the scene, and the injuries of the Officers and suspect.

On 7/18/16, at approx. 0506 hours, Ofc Lewis #233 and I (Ofc Price #539) were dispatched to the River Terrace Apartments (2574 Millcreek Dr) regarding a call of a male subject that was high on narcotics and having a psychotic episode. We were driving a fully marked SPD patrol vehicle, wearing full SPD patrol uniform. Per the text of the call, the subject having the episode was the brother of the complainant's boyfriend and was a male black adult wearing a gray shirt and blue jeans. As we were en route to the scene, the communications center received a total of 6 duplicate calls from separate parties advising there was a male wandering around in the parking lot of apartment complex yelling, banging on cars and banging on apartment doors. The additional callers advised that the subject was yelling to "call the cops" as he was wandering around the parking lot. A number of the additional callers also advised that they were scared and in fear for their safety with the subject banging on their doors and yelling. One of the callers advised that she locked herself, and her daughters, in her bedroom in fear after the subject had banged on her door on 3 separate occasions. We arrived on scene at approx. 0513 hours.

Upon our arrival, we were hailed by one of the callers, outside of the complex, advising that the subject was still wandering inside the apartment and was "acting crazy." As we entered the River Terrace Apartments, I observed a male subject (later identified as Jerry Sanchez 7/31/87) walking northbound through the parking lot wearing a gray shirt and blue jeans, matching the description given by the callers. (S)-Sanchez displayed several objective signs of being under the influence of a narcotic, including: swift and erratic movements, dilated pupils, rapid breathing and nonsensical verbal outbursts.

Ofc Lewis immediately ordered (S)-Sanchez to stop and put his hands up. I ordered (S)-Sanchez not to move and attempted to detain him by handcuffing his hands behind his back. As I placed the handcuffs around (S)-Sanchez's right wrist, I felt his right arm and his body immediately tense up. I once again ordered him not to move and he began to pull his right arm away from me. I ordered him not to move once more and he continued to pull his right arm away from me in an attempt to escape my grasp.

As (S)-Sanchez continued to pull his arm from my grasp, Ofc Lewis used a departmentally trained take down to maneuver the subject face up on the ground. As (S)-Sanchez was on the ground, I again grabbed his right arm and attempted to place the remaining handcuff on his left wrist. (S)-Sanchez began to flail his arms and legs violently, and was twisting his body in an attempt to escape our grasp. As (S)-Sanchez was flailing on the ground, both Ofc Lewis and I sustained several minor blows to various portions of our

upper and lower body. I also sustained a blow to my groin, from either (S)-Sanchez's foot or leg, leaving behind a large visible mark of dirt on my uniform. (S)-Sanchez was able to escape our grasp once again and immediately stood up and turned to face us.

As we were struggling on the ground with (S)-Sanchez, Ofc Lewis requested an emergency response to assist us in detaining (S)-Sanchez. Also during this time my In Car Camera microphone, that is attached to my duty belt, was forcibly pulled off of my belt onto the ground.

As (S)-Sanchez was facing us, Ofc Lewis deployed his department issued conductive electrical device (CED) towards (S)-Sanchez's torso in an attempt to subdue him to assist in detention. The CED failed to complete a connection and was ineffective. (S)-Sanchez turned and began walking at a very fast pace in the opposite direction from us.

As (S)-Sanchez began walking away from us, I unholstered my department issued CED and gave chase after him. I ordered (S)-Sanchez not to move once more and advised him that I would "taze" him if he did not comply. (S)-Sanchez continued to walk away and I continued ordering him not to move and to put his hands up several times. (S)-Sanchez refused to comply and continued walking away from me. After giving (S)-Sanchez a reasonable amount of time to comply with my commands, and in fear for my safety and the safety of the citizens in the apartment complex, I deployed my department issued CED (Taser brand X3 #X13000RK1) towards the back of (S)-Sanchez to assist me in preventing escape, overcoming resistance and effecting an arrest. My CED completed a circuit on (S)-Sanchez's back and he fell to his stomach as the CED cycled. I dropped my CED once again attempted to detain (S)-Sanchez by connecting the handcuffs behind his back during electrical cycle. Once the 5 second CED cycle was complete, (S)-Sanchez immediately began flailing violently again and attempted to walk away.

Both Ofc Lewis and I ordered (S)-Sanchez not to move and we once again took hold of his arms to attempt in connecting the handcuffs. (S)-Sanchez continued to struggle and resist, so Ofc Lewis and I used a departmentally approved take down to maneuver him to the ground once more. (S)-Sanchez continued to resist and would not comply, so Ofc Lewis placed him into a departmentally trained Carotid control hold. Once I observed that (S)-Sanchez had lost consciousness, I immediately advised Ofc Lewis and he released the hold. I grabbed back on to (S)-Sanchez's arms and attempted to connect the handcuffs behind his back again, however (S)-Sanchez regained consciousness and began flailing and resisting once again.

At this time, both Ofc Lewis and I were experiencing extensive exhaustion, both respiratory and muscular, and (S)-Sanchez was not showing any signs of compliance or exhaustion due to his alert mental state. Ofc Lewis maintained a moderate hold around (S)-Sanchez's neck/head area and his legs, and I continued to maneuver (S)-Sanchez's arms behind his back to

connect the handcuffs.

Ofc Monelo #307, Ofc Fitzgibbon #659, Ofc Thompson #471, Ofc Tsverov #893 and Ofc Barrett #627 arrived on scene and assisted us in detaining (S)-Sanchez and connecting the handcuffs behind his back.

From the time of our first contact, until the time (S)-Sanchez was fully detained, approx 6 minutes had elapsed.

We immediately requested an emergency response from Sacramento Fire Department Medics to evaluate (S)-Sanchez following the incident.

The use of 4 officers was required to subdue (S)-Sanchez on the ground until he was able to be fully strapped and restrained to a medical backboard.

Ofc Bender #602 arrived on scene and identified (S)-Sanchez via prior contacts. I verified his identity as Jerry Sanchez (7/31/87) via WebKPF booking photo (XREF: ██████████). Per Ofc Bender, he had a similar contact with (S)-Sanchez several weeks prior with him displaying the same erratic behaviors (See Report #16-177418).

(S)-Sanchez was arrested in violation of 69 PC (resisting executive officers) and 11550 HS (under the influence of a narcotic).

(S)-Sanchez obtained a minor laceration above his left eye and several minor abrasions to his face and body.

Sacramento Fire Department Medic 20 transported (S)-Sanchez to Sutter General Hospital for evaluation of his injuries and mental state.

During the incident, I sustained bruising and swelling to both of my knees requiring medical evaluation at Sutter General Hospital. Ofc Lewis obtained a small, approx. 0.5", laceration to his right knee cap during the incident.

CSI responded to 2574 Millcreek Dr and Sutter General Hospital for photographs of (S)-Sanchez's injuries, as well as my and Ofc Lewis' injuries.

CSO Virk #8180 responded to 2574 Millcreek Dr and collected the prongs, cartridges and AFIDS from both deployed CEDs and booked them as evidence at the Kinney Police Facility.

Sgt Wong #3056 and A/Sgt Edgerton #826 were advised and on scene.

Our fully functional In Car Camera video, and ICC microphones, were activated during the entire incident. However, due to our positioning and distance from our patrol vehicle, as well as my microphone being knocked from my belt, only a small portion of the incident was captured on the ICC.

(S)-Sanchez was medically cleared from Sutter General Hospital, and transported and booked into Sacramento County Main Jail for the above charges

On 07/19/16 at approximately 0506 hours, Ofc. Price #539 and I (Ofc. Lewis #233) were dispatched to 2574 Millcreek Dr # [REDACTED] regarding a suspicious subject. We were driving a fully marked SPD patrol vehicle, wearing full SPD uniform. Per the text of the call, the complainant [REDACTED] was advising that her boyfriend's brother was high on narcotics and having a psychotic episode. The complainant advised the subject having the episode was a male black adult named Jerry, wearing blue jeans and a gray shirt. While en route to the call, dispatch advised of numerous updates from other callers in the same apartment complex (6 total) who were advising that a subject was banging on apartment and car doors screaming for someone to call the police. One of the additional callers advised that she needed police to hurry because she was worried someone was going to be hurt by the subject. An additional caller advised that she was so scared of the subject, she hid in her bedroom with her children. We arrived on scene at approximately 0513 hours. I observed the following in summary (ICC activated for the duration of the incident):

Upon arrival, we were contacted by the driver (Unidentified male white adult) of a tow truck who approached our vehicle. The tow truck driver advised that the subject was in the south west corner of the parking lot. The tow truck driver stated that the subject was "really crazy" and advised Ofc. Price and I to be careful.

We entered the apartment complex and located a male black adult wearing blue jeans and a gray shirt (Later identified as S-Jerry Sanchez) walking eastbound through the complex. We parked and exited our patrol vehicle directly in front of the subject and commanded him to put his hands up. At this point, I observed S-Sanchez display behavior consistent with someone under the influence of narcotics (Methamphetamine). S-Sanchez' pupils appeared much larger than normal (Larger than any officer on scene).

In addition, S-Sanchez displayed odd behavior such as making a praying motion with his hands upon contact, repeatedly making erratic motions with his hands and arms, and repeatedly demanding to be taken to an ambulance. Ofc. Price approached S-Sanchez from S-Sanchez' right side and successfully positioned S-Sanchez in a standing modified arrest position. I was standing on S-Sanchez' left side. After placing handcuffs on S-Sanchez' right wrist, I heard Ofc. Price command S-Sanchez to stop moving multiple times.

I proceeded to grab S-Sanchez' left arm and attempted to place him in a two handed rear wrist lock. At this point, I felt S-Sanchez' body tense up and he began moving his arms to attempt to break the control hold. I then transitioned from the control hold to a department approved arm bar take-down on S-Sanchez' left arm. I successfully completed the take-down, causing

S-Sanchez to land face down in the grassy area outside of the apartment complex. I maintained control of the left arm and continued to attempt to handcuff S-Sanchez and Ofc. Price attempted to gain control of S-Sanchez' right arm, which at this point had a handcuff secured to the wrist.

I used my radio to call for emergency assistance from other units.

S-Sanchez started flailing his arms violently striking Ofc. Price and I in the head and face. While attempting to gain control of S-Sanchez' arm, S-Sanchez attempted to push me over onto my back. After approximately 1 minute of attempting to secure S-Sanchez' unsecured wrist in the handcuffs, S-Sanchez was able to break free of both Ofc. Price and my attempts to detain him and stand up on his feet. At this point, S-Sanchez turned towards Ofc. Price and I. Based on S-Sanchez' reported behavior prior to our arrival, the erratic behavior I observed, his physical resistance

during our attempts to arrest him, and the fact that we were unable to complete a pat-down search for weapons on S-Sanchez' person, I believed S-Sanchez posed a risk of great bodily injury to myself, Ofc. Price, and the residents of the apartment complex. Due to the facts listed above, I deployed my department issued CED (Taser X3 Serial #X13000RC) in an attempt to overcome S-Sanchez' resistance and effect an arrest.

My CED failed due to the prongs of the device not penetrating S-Sanchez' shirt.

Immediately after deploying my CED, I used my radio to broadcast that I had deployed my CED and that it was ineffective.

S-Sanchez then started walking eastbound through the complex in an attempt to escape. Ofc. Price gave chase and ordered S-Sanchez to stop. Ofc.

Price and I each ordered S-Sanchez to show his hands multiple times. Ofc. Price then warned S-Sanchez that he was going to taze him. After a reasonable amount of time, Ofc. Price deployed his CED, striking S-Sanchez in the back with both prongs. Ofc. Price's CED was effective, causing S-Sanchez to fall onto his stomach in a grassy area.

Ofc. Price and I then again attempted to handcuff S-Sanchez' unsecured arm/wrist. As we attempted to secure S-Sanchez' unsecured wrist, he immediately became physically resistive again, flailing his arms, kicking his legs, and rolling side to side, attempting to cause Ofc. Price and I to lose our balance. After approximately 20 seconds of struggling to control S-Sanchez on the ground, S-Sanchez was able to rise to his feet again.

At this point, I started becoming physically exhausted including muscle soreness, heavy breathing, sweating, and weakness. I became afraid that I would become overpowered by S-Sanchez due to my level of fatigue.

Ofc. Price and I continued to struggle to secure S-Sanchez' arms in handcuffs. Ofc. Price was positioned on S-Sanchez' right side, attempting to obtain a twist lock on S-Sanchez' right arm and I was on S-Sanchez' left side,

attempting to obtain a twist lock on S-Sanchez' right arm. S-Sanchez continually flexed, pulled, and flailed his arms. Eventually due to our attempts to obtain twist locks, and S-Sanchez' movements, we all fell to the ground.

Once on the ground, in an attempt to effect an arrest and overcome S-Sanchez' resistance, I administered a department approved carotid control hold. After holding the hold for approximately 10 seconds, I felt S-Sanchez' body go limp. I asked Ofc. Price if S-Sanchez was "out" and he responded yes. I immediately released the hold and rolled S-Sanchez onto his stomach in order to handcuff him. Due to S-Sanchez' arm being under his body, we struggled to complete the handcuffing prior to S-Sanchez waking up. As we were preparing to secure the handcuff to S-Sanchez' unsecured wrist, S-Sanchez "woke up" and began flailing his body violently again.

Due to S-Sanchez' continued resistance, I was unable to request medical aid for him immediately after administering the carotid hold.

Again, I secured a carotid control hold position and attempted to administer it to S-Sanchez. Due to S-Sanchez' flailing, I was unable to position the hold correctly and released it. I maintained a position of control on S-Sanchez' back while waiting for responding units.

After approximately 2 minutes of maintaining control of S-Sanchez, multiple officers arrived on scene, including Ofc. Monelo #307, Ofc. Fitzgibbon #659, Ofc. Barrett #627, Ofc. Thompson #471, and Ofc. Tsverov #893 (See supplements from all officers involved regarding their actions).

With the help of all responding officers, Ofc. Price and I were able to successfully handcuff S-Sanchez from the prone position. S-Sanchez continued to attempt to flail, flex his arms, and make evasive movements to avoid being handcuffed until the handcuffs were secured on his wrists. Immediately after S-Sanchez was secured in handcuffs, I requested code 3 medical assistance for S-Sanchez.

The total length of the incident from the initial request for emergency assistance to S-Sanchez being handcuffed was approx. 6 minutes. Additional units arrived on scene including 1SM1 (Sgt. Wong and A/Sgt. Edgerton).

CSI responded to the scene for photos of the scene.

CSO Virk #8180 responded and collected evidence for booking including CED blast doors, prongs and AFIDS (See CSO Virk's supplement for further).

SFD (Medic 20 and Engine 15) responded to the scene and administered aid to S-Sanchez. SFD transported S-Sanchez to Sutter General Hospital (Ofc. Price escorted S-Sanchez to the hospital inside the SFD ambulance).

S-Sanchez was arrested for being under the influence of narcotics in public (11550 H&S) and resisting executive officers (69 PC). S-Sanchez was admitted at Sutter General Hospital pending medical clearance to be booked at jail.

Ofc. Spencer and Ofc. Kellerman responded to the scene for prisoner watch/booking.

CSI responded to the hospital for photos of Ofc. Price's injuries, my injuries, and S-Sanchez' injuries.

I sustained a small (Approx .5" abrasion) to my right knee as well as soreness to both knees.

Ofc. Price sustained redness/abrasions to his right knee and soreness in both knees.

S-Sanchez sustained a small (Approx. 1") laceration to the right side of his forehead, a medium size (Approx. 2"x 2") abrasion to his left shoulder, and puncture wounds from the CED prongs on his back. S-Sanchez stated that he had no pain/injuries aside from discomfort from his handcuffs.

I will be able to recognize both male black adults if I see them again.

"Jerry" was adamant about me calling 9-1-1, and I was trying to, but I was so nervous with him standing in front of me and yelling at me to call 9-1-1 for him. My telephone has a password on it, so it took me a second to get the password entered. But, "Jerry" just kept saying, "You need to call 9-1-1! You need to call 9-1-1!" The way he was acting was making me very afraid of him.

I told him he needed to wait for 9-1-1 outside, and I pushed him out the front door and locked it. That was when I called 9-1-1.
