Incident Summary

On 9/19/17, at approximately 1457hrs., Ofc. Bohrer(1B67), Ofc. Jensen and Ofc. Jennings(2B32) were dispatched to Crete Av regarding a 242P (misdemeanor assault in progress). At approximately 1502hrs., Ofc. Bohrer arrived onscene contacting victim Per Ofc. Bohrer, victim and significant swelling to her eye and a laceration under the eye that would require stitches. SFD was requested for victim sinjuries. Victim advised that her son had punched her in the face when he was told he was no longer welcome at her home. Ofc. Trejo (1C68) and Ofc. Donnell/Ofc. Paiz (2B64) replaced out of District officers Jensen and Jennings. Ofc. Donnell and Ofc. Paiz arrived on scene at approximately 1511hrs., assisting Ofc. Bohrer who is waiting at the front door of the residence Crete Av). Ofc. Bohrer had heard noises from inside the residence advising that the suspect may have fled out the backdoor. Ofc. Paiz walked around to the back of the residence while
Ofc. Bohrer and Ofc. Donnell maintained visual on the front door. As Ofc. Paiz walked around the south side of the residence he observed suspec inside the backdoor with his back turned to Ofc. Paiz. Ofc. Paiz drew his firearm ordering suspec ito show his hands. Suspec it turned around and walked out of the residence sitting down on the rear steps. Ofc. Paiz advised Ofc. Donnell and Ofc. Bohrer to come around to the back of the residence as he was talking to the suspect. Ofc. Paiz took control of suspec its left wrist, orderin its put his right hand behind his back. Suspect complied at first but stopped, tensing both of his arms and balling his
fists. Ofc. Paiz told suspect to relax and not resist but did not comply. As Ofc. Bohrer and Ofc. Donnell rounded the corner of the residence, suspec stood trying to spin towards Ofc. Paiz positioning himself into a fighting stance.
Ofc. Paiz knew that suspect was wanted for 243d PC(felony) after punching his own mother in the face and believed that suspect was now going to assault Ofc. Paiz or the other officers on scene. Ofc. Paiz was unable maintain a grip on suspect noting record. 's strength and behavior was like that of a person under the influence of narcotics.
Ofc. Paiz decided to place suspect in a carotic control hold in an attempt to quickly and safely render the violent suspect unconscious. Ofc. Paiz applied the carotic control hold once he was in the proper position. The application of the hold lasted approximately 10-15 seconds as Ofc. Donnell and Ofc. Bohrer were struggling to handcuff the resisting . Ofc. Paiz advised that he could hear suspec snoring at which time he released the carotid control hold.
As suspect woke, he continued to resist and fight. Ofc. Bohrer immediately requested SFD for suspect due to the application of the use of force. Ofc. Paiz placed suspect into a position of recovery monitoring his breathing and overall medical condition. Suspec was transported to UCDMC for
medical clearance. Ofc. Paiz sustained minor bruising to his right forearm and complaint of pain to his lower back. Ofc. Donnell
had a minor scratch to his left hand. The incident was captured on BWCs worn by Ofc. Donnell, Ofc. Bohrer and Ofc. Paiz. **It should be noted that during the struggle with suspec , Ofc. Paiz's camera was knocked loose from his person falling onto the ground.
A neighborhood canvass was conducted by responding officers. I photographed victim 's injuries, Ofc. Donnell and Ofc. Paiz's injuries and the scene. CSI was requested for photographs of suspect 's injuries(abrasion/contusion to his forehead).
After reviewing all BWC footage, the submitted reports, injuries sustained by the victim and dispatch audio files, I believe that the force used by Ofc. Paiz was within the Use of Force Policy of the Sacramento Police Department.


