Incident Summary

SUMMARY:

Ofc. Eckert (1A64) was enroute to jail with a suspect from a previous call when he was hailed at 3rd and J regarding an assault. Ofc. Eckert stopped and spoke with a few FBA's who had just left the Pier Lounge and found out that one of the girls in their group had been pistol whipped by a MBA who was with two other men. Ofc. Eckert began broadcasting suspect information and their direction of travel. Sgt. Magee responded to assist Ofc. Eckert. Officer Truesdale responded to the scene. While trying to get the details of the incident, a loud disturbance was heard coming from the bottom floor of the Old Sacramento Parking Garage. Ofc. Eckert and Ofc. Truesdale responded to investigate, while Sgt. Magee stayed with Ofc. Eckert's prisoner who was secured in the back of his patrol vehicle. Officers found that the disturbance in the parking garage was related to the incident that Ofc. Eckert was hailed on.

In the subsequent investigation, officers found out that a group of FBA's and one MBA, up from Fresno, were enjoying an evening at the Pier Lounge. They left the Pier and walked over to the SE corner of the Old Sacramento City Parking Garage, on the bottom floor, where their car was parked and could not find the car key. While looking for the key, 3 MBA's went down into the parking garage and began cat calling the females. The male that was with the females told the 3 MBA's to back off but instead they commenced to beating down the guy. One of the females in the group, , removed her high heel shoe and struck one of the MBA who were attacking her BF in the ear. The three assailants then went up stairs in the parking stated that she saw one of them go to his car, get a gun out, and rack it. The three assailants, who were then joined by a MHA, later identified as went back after the group of girls and the BF. After a short run through the parking garage, the group stopped and tried to talk the guy with the gun down. The MBA with the gun then pistol whipped for ripping his ear open with for ripping his ear open with her shoe. The three MBA suspects then fled, apparently in a white Mercedes (unknown plate). joined them half way through, remained on scene. Additional units were requested as Ofc. Eckert and Ofc. Truesdale were dealing with a large crowd in the parking garage. Units responded Code 3 to the location. parking garage. Units responded Code 3 to the location. Who was the main aggressor, was proped out and detained in handcuffs. While Ofc. Eckert was dealing with a FHA, later identified as girlfriend was yelling. Ofc. Truesdale made sure the Ofc. Eckert was in control of and then turned her attention toward to deal with her and keep her back. Ofc. Eckert then assisted to a seated position where he seemed to be in dialogue and he was calm and cooperative. Ofc. Eckert assisted compliant. Ofc. Eckert engaged to his feet, and began walking him out of the parking garage to detain him in a patrol car. While being walked out, attempted to break free from Eckert and attack the females. Ofc. Eckert took hit his face on the ground causing an injury requiring medical treatment. to the ground and was ultimately transported to Sutter General Hospital where he was eventually cleared for incarceration, diagnosed with a jaw contusion and subtle fracture to his left cheek area. for 148(a)(1) PC, 647(f) PC and 415(1) PC. the call, the events that preceded Ofc. Eckert's actions, as well as the degree of active resistance and , that the use of force was justified and within the policy of the Sacramento aggression displayed by Police Department. (There was no available ICC footage due to all of the patrol cars being parked at the intersection of 3rd and J St during the UOF).

CONCERNS AND CORRECTIVE ACTION

I spoke with Ofc. Eckert on scene regarding this incident. I advised Ofc. Eckert that when dealing with a previously combative individual, who is proned out and handcuffed, to think about keeping him on the ground and waiting for additional units to assist him prior to moving the suspect. Additional units were already requested and responding at the time Ofc. Eckert had the suspect detained on the ground. I told Ofc. Eckert that waiting for another unit to assist him in walking the suspect to the patrol car would help in controlling him. Ofc. Eckert understood and was receptive. No further actions recommended.


