### Incident Summary

On 3/29/18, at approximately 2310 hours, officers responded to ■ Hallwood Court regarding a burglary in progress. The caller advised that the suspect (later identified as Ashneel Mani) had just broke into their residence and was armed with a knife. Mani fled out of the residence prior to officers arriving on scene. When officers arrived on scene, they were notified by the resident o ■ Hallwood Court that he heard noises in his backyard. A perimeter was established around that residence. Based on the fact that the suspect was armed with a knife, had a history of violent felonies, including assault with a deadly weapon, had just committed a burglary, and had not yet been searched, I authorized the use of a police canine to search for Mani.

K9 Officer Bradley and his K9 partner "Zuko" responded to the scene. Numerous K9 announcements were made by Officer Wacker via the PA system for Mani to come out and surrender. A contact team was formed to assist Officer Bradley. Officer Bradley deployed "Zuko" into the backyard o ■ Hallwood. Court. "Zuko" located Mani hiding up against the house, under several seat cushions that Mani had placed on top of himself to conceal himself from Air1. Mani was taken into custody without further incident. The knife that Mani had armed himself with was found next to where he was taken into custody. The incident was captured on all of the officer's body worn cameras.

After being on scene at the time of the canine deployment, reviewing the crime report and all the body worn camera footage, along with reviewing G.O 580.14 (Use of Canines), I found that the use of force was justified. .

I ran a records check on ASHNEEL. The check showed that he was on probation out of Yolo County until 11/8/2020. The record check also showed that there was an active restraining order against ASHNEEL MANI. The protective person on the restraining order was [REDACTED]. The order is a no contact and a 100 yard stay away order. Court case/ [REDACTED]

The records check also showed that there have been previous documented cases 2018-16655, 2018-9218, 2018-22940, 2018-1801124, 2018-55197, 2018-85398 that involved ASHNEEL.

On 03/29/2018 at approximately 2310 hours, I Ofc.Bradley #545, responded to ■ Hallwood Court regarding a burglary in progress. I was in full police uniform, driving a fully marked Sacramento Police Department K9 patrol vehicle.

Per the text of the call, the complainant stated that a male subject had just broken into the residence and was armed with a knife. While enroute to the area, dispatch advised via radio that the complainant said the suspect was her youngest son (later identified as Ashneel Mani 6/26/1983). She also stated that Mani did not live at this residence and that she had an active restraining order against Mani.

Officers arrived on scene and discovered that Mani had already fled from the house. Ofc.Vito (1A53) confirmed that there was an active restraining order against Mani. gate on the west side of ■ Hallwood Court which led into the back yard of the residence. I positioned my patrol car on Rightwood Way facing east into the backyard.

Ofc.Wacker (GNG 58) used my in car public address system to make K9 announcements repeatedly for approximately 3-5 minutes. These loud announcements requested Ashneel Mani by name to surrender peacefully to officers or a police K9 would be used to search for him and he may be bit. There was no response after multiple warnings. Announcements were recorded on my in car camera (ICC) and with my body worn camera (BWC).

With the authority of Sgt.Merten (1SM5), the decision to deploy my police service canine "Zuko" to search for Ashneel Mani was made based on the following criteria known to me at the time of the incident:

- 1) Mani was wanted for fresh felony charges- (212.5(A) PC)
- 2) Mani was wanted for a fresh restraining order violation (166(A)(4))
- 3) Mani had entered ■ Hallwood Court by forced entry and was brandishing a kitchen knife towards his family members. His family was forced to lock themselves in a bedroom out of fear for their own personal safety.
- 4) Mani was last seen armed with a knife and suspected to be concealing himself in a residential yard creating an extremely dangerous situation for both citizens and officers. The use of the police K9 to locate and/or apprehend Mani would increase the safety of the officers tasked with searching for him.
- 4) Mani refused to surrender peacefully to Officers after being given numerous announcements by name requesting him to do so indicating that he had no intentions of complying with the reasonable demands of Officers to peacefully surrender in violation of 148 PC.
- 5) A records check revealed that Mani was on F/S probation until 08/29/2021 and had a history of violent crimes including 245(A)(1) PC and 273.5 PC as well as a history of 459 PC. Mani also has had several previous restraining order violations and if not apprehended, it appeared very likely that the violations would continue.

At approximately 2349 hours, I began my search at ■ Hallwood Court entering the back yard from the west side of the residence on Rightwood Way. Prior to giving Zuko the search command, I again gave a verbal K9 warning and received no response. I gave Zuko the search command and directed him into

the yard. K9 Zuko traveled along the north side of the house in an eastern direction toward a covered patio. There were no exterior house lights on to illuminate the back yard and very little ambient light during the search.

Upon reaching the covered patio, Zuko began searching near a stack of patio cushions that were in the southwest corner. Zuko located Mani who was concealing himself under multiple patio furniture cushions. Officers illuminated Mani with their flashlights and I observed that Zuko had made contact with Mani's right arm. I ordered Mani to show me both of his hands to which he complied. Once I could see that Mani did not possess any weapons in his hands, I gained positive control of Zuko and gave him a release command. Zuko released as instructed and returned to a heel at my side. Ofc.Wacker then handcuffed Mani and took him into custody. The knife that Mani had used during the home invasion was located directly next to where Mani was hiding.

The location where Mani was hiding was approximately 40 feet from the front of my patrol car where announcements were made. This short distance would have made the announcements easily heard by Mani based on the location where he was found.

I immediately requested Code 3 medical to the scene for Mani's injuries.

Mani was escorted out of the backyard by Officers and detained in a patrol car. Sacramento Fire Dept. Engine #7 and Consumnes River Medic #76 arrived on scene and determined that Mani's injuries were minor and did not require emergency transport and did not require any type of first aid.

I observed a dog bite injury consisting of punctures and rakes to Mani's right forearm and right hand. Ofc.Gamble #946 later transported Mani to Kaiser South for treatment and obtained his statement. Mani stated to Ofc.Gamble that he could hear the K9 announcements from where he was hiding(See Ofc.Gamble's supplement for details).

CSI was requested and responded to the scene for photographs of the area where Mani was apprehended by K9 Zuko, photographs of the knife that was found next to Mani, as well as over-all photos of the residence. CSI later responded to Kaiser South for photos of Mani's injuries.

Officers conducted a neighborhood canvass (See Supplements for details).

Mani was later transported to Sacramento County Main Jail and booked for 212.5(A) PC, 166(A)(4) PC, 148(A)(1) PC, and 1203.2 PC.

At approximately 2310 hours, I was dispatched to ■ Hallwood Court regarding a report of a burglary-in-progress and that the suspect was armed with a knife. Other patrol officers, along with K9 units, also responded to the residence. I arrived on scene at approximately 2320 hours.

I contacted the complainant ■ (DOB ■) outside his residence, who informed me that the suspect, Ashneel Mani (DOB 06-26-83)(his brother), fled the scene just prior to my arrival. I updated responding officers, who began searching the area.

During my brief contact with the victim, Officer M. On #0744 informed investigating officers that there was probable cause to arrest Ashneel for burglary (later determined to be robbery) and violating a restraining order. I contacted the resident of ■ Hallwood Court, ■ (DOB ■), who gave me permission to enter his residence. ■ told me he saw someone hiding underneath his patio furniture cushion, located about three feet from the rear sliding glass door. I looked out the rear living room window and located this cushion, which was surrounded by numerous items, including buckets, and other large objects, which made it an effective place for concealment.

I watched this cushion for about 5-10 minutes, when I finally noticed a hand emerge from underneath it. I remained inside the residence to provide updates to other officers on scene. The K9 units gave numerous commands to Ashneel, which he ignored. Ashneel was eventually taken into custody, with the assistance of the K9 (see attached reports for further details).

Shortly after, I conducted a search of the area where Ashneel was hiding and saw a kitchen knife, with a 4.5" blade and wood handle, inside a container. The knife was bent in half. I had ■ look at the knife - he told me the knife did not belong to him. We later had the victim look at the knife and he confirmed it was the same one used during the incident. A forensics investigator took photographs of the knife. I then collected it as evidence.

Ashneel was transported to Kaiser Hospital, located at 6600 Bruceville Road, for medical treatment. He had lacerations on his right hand/wrist, which were bandaged by medical staff. I then transported Ashneel to the Sacramento County Main Jail, located at 651 I Street.

At jail, I read Ashneel his Miranda Rights, verbatim from my Sacramento Police Department reference card. Ashneel stated he understood each of his rights, but did not provide me with a statement. Ashneel was booked for penal code sections 212.5 (Robbery, Inhabited Dwelling), 166(a)(4)(Violation of a Court Order), 148(a)(1)(Resist, Obstruct, Delay of Peace Officer), and 1203.2 (Probation Violation).

I later booked the above-mentioned knife at the Joseph E. Rooney Police Facility.
