Officer Phelan had some abrasions on his knee and complaint of pain to his right hand. Suspec was transported to the hospital where he was thoroughly examined and determined to be fit for incarceration.

Based on my review of the body worn camera and the reports, it is my opinion the use of force was justified and within policy.

Officer Phelan admitted he forgot to immediately place the suspect into a position of recovery after he was handcuffed. He did immediately request emergency medical and saw that the suspect was breathing and moving.
