### Incident Summary

See attached report. Based upon my personal observations on scene, my review of BWC footage, ICC footage, and the associated crime report, I believe the use of force was justified and consistent with SPD policy. Tactical issues regarding efficient ways to lock down a residence with a two person perimeter, and the necessity of using cover / concealment when choosing perimeter positions was brought to the attention of Ofc. L. Smith and Ofc. Shepard. This was communicated via team debrief and direct communication. Officers receptive, handled at watch level.

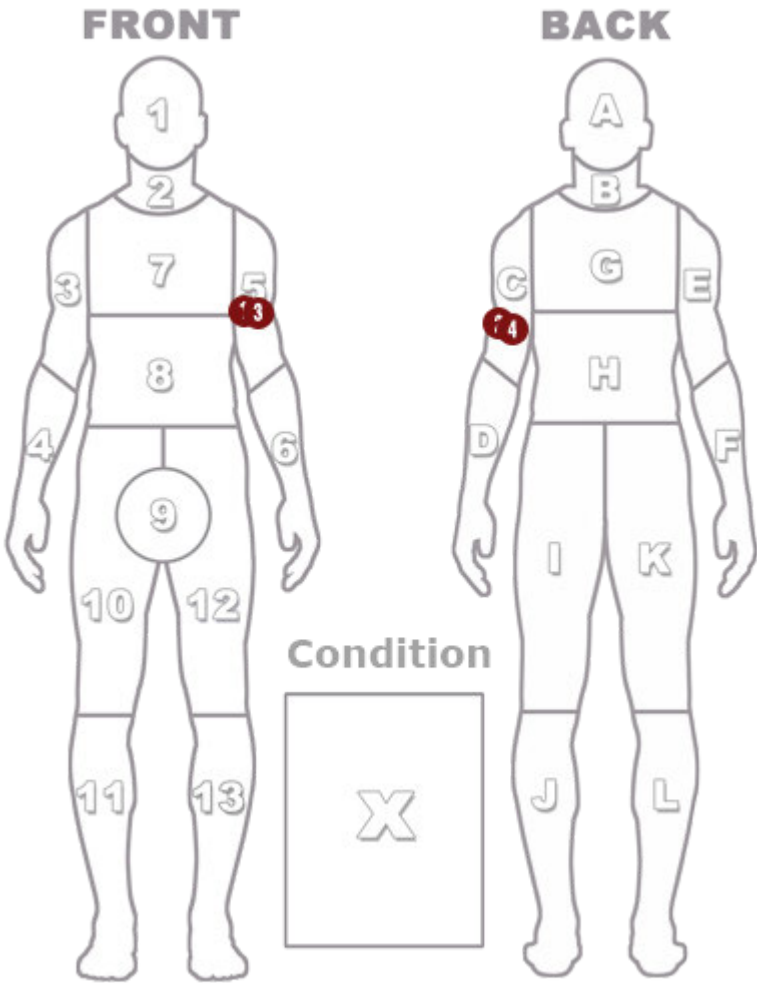

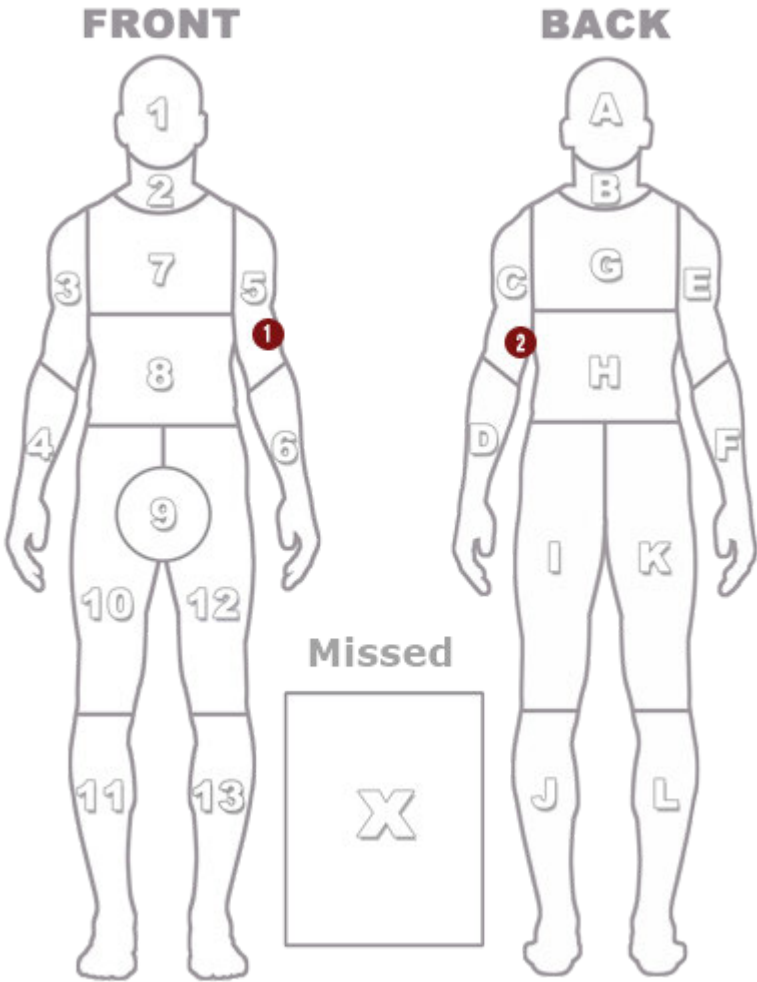

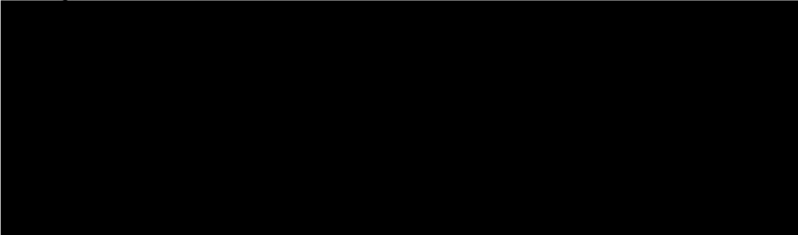

We went to [REDACTED] room in the SOUTH-WEST corner of the house to see if we could see anyone inside of the backyard. We saw a male white adult with long brown hair walking around our house in the backyard.

The man looked into the first window WEST of our side gate. The window was SOUTH-FACING. The man looked inside and saw us. He appeared to be talking to himself. We yelled at him to "Please leave!" and to "Get out!". We told him we were going to "Call the Cops!" but that didn't stop him from pulling on the window and trying to get in. That's when we called 9-11.

I took a picture of the male white adult from the SOUTH-WEST bedroom when he was in the backyard. I tried to pull up the picture on my cellphone but I could not find it. We lost sight of the man for a few moments and then heard someone banging on the FRONT door. The person kept yelling "Mommy!". I was scared and didnt know what was happening or if it was the man that was in the backyard moments earlier.

After banging on the FRONT DOOR and SOUTH-GATE for a few minutes, the male white adult returned to our backyard. He began pacing around the perimeter of the house.

were terrified so we baricaded ourselves in the bathroom. We could not lock the door so we armed ourselves with a hammer and a bat. We could hear him walking around in the house outside of the bathroom saying, "Where are you?". Luckily you (PD) showed up a couple of minutes later.

The man you have handcuffed, and sitting down on the porch IS the man I saw trying to get into our house.

I do NOT notice anything that is missing, but the chair in the living room is knocked over and the door leading from the living room in the SOUTHEAST corner to the bedroom is now open. The door was closed before we went into the bathroom. The plants that are on the window sill on the SOUTH wall in [REDACTED] room are also knocked over.

At this time I do NOT notice anything that is missing from our apartment. We just moved in a few weeks ago and are still unpacking, so there are things scattered all over the floors.

I have never seen him before, but my roommate [REDACTED] has.

I have no idea why this man would want to get into our apartment. We've never experienced anything like this before so this really freaked me out.

I am not hurt and I do NOT need any medical attention. I have a small scratch on my UPPER LEFT THIGH from climbing out of the window but I am fine.

Per the text of the call, a male SUBJECT broke the lock to the side gate and got into the backyard and was banging on windows. One of the callers advised that they had only lived in the neighborhood for a few weeks and did not recognize the SUBJECT who was said to be yelling "Mama".

A caller advised that the SUBJECT was still in the backyard and that she could see him through the windows. The caller stated that she had locked all doors and that she and her roommate were the only ones in the house. The SUBJECT was yelling "Open up!" and was beating on the windows with his hands. The caller was afraid that the SUBJECT would gain access to the residence.

A neighbor called and advised that a TRANSIENT was banging on the next-door neighbor's window and was breaking into their backyard. The caller advised that the neighbors were NOT home and described the SUBJECT as a male black adult approx 5'6"-5'8" in height, thin build, gray hoodie, khaki/green pants and had a lot of "things" in his shopping cart.

Additionally, the caller stated that the SUBJECT was talking to someone and that it was uncertain whether or not someone was in the backyard with him or if he was talking to himself. It was unknown what the SUBJECT was saying and she felt as if the SUBJECT was actively trying to break into the residence and was upset that PD had not arrived yet.

A caller stated that she could currently hear the SUBJECT on the SOUTH side of the house, but that he had been moving window.

Dispatch clarified to units that one of the callers was one of the residents and that she and her roommate were secured in the bathroom for safety. The female resident advised that the SUBJECT was trying to open the back door which lead to the mud-room.

While still land-lined with the resident, she stated that she thought he may have just gotten into the house, and then confirmed that he was inside. She advised that she could hear him saying, "Where are you?", and could hear him moving around outside the door, and heard a loud bang. She was unsure of what the noise was or if it was PD at the door.

The resident then advised that she and her roommate occupied the first floor and were both in the bathroom.

Based on the update from dispatch advising that the SUSPECT was INSIDE the residence, I responded CODE 3 to the scene.

A neighbor called in and advised that a transient was banging on the neighbor's window and breaking into their backyard. The caller advised that the neighbors were not home. That caller described the subject as:

patrol units were already on scene, I requested all units to form a perimeter around the residence and to hold their positions.

I responded to the rear of the residence along with K9 Kai at my heel. Officer Anchuk #438 was holding the north/west corner of the residence, Officer Baker #756 was holding the south/west corner, Officer Smith, L. #653 was holding the east side, and Officer Shepard #209 was mobile between the front and rear of the residence along the south side of the residence,

It appeared suspect/Corpuz made entry through the window on the south side of the residence near the south/west corner as the screen from the window had been pulled off and was on the ground below. Neighbors also corroborated that suspect/Corpuz gained access through the same window in question.

While in the backyard a screen on the west window pushed out from the inside. As Officer's directed their attention to the window they quickly discovered that it was the victims whom were hiding inside the bathroom. Both victims had armed themselves, one with an aluminum baseball bat, the other with a hammer in fear for their safety. I pulled the screen off the window and pushed the window open. Officer Shepard assisted the two victims out of the window and escorted them to the front of the residence and had them sit in the rear of a patrol vehicle. Both victims stated that they were the only two that lived at the residence, and no one else belonged inside. The victims also stated that their residence (lower) did not connect in the interior to the unit above.

Through the open window (west) that the victims had just crawled out of I began making repetitive K9 admonishments comprised of anyone inside the residence to exit the residence, if they do not a K9 would be used to search and he will bite you. I gave approximately five K9 warnings through the open window with no response.

surrendering shows his level of commitment to resist Officer's and his unwillingness to comply with Officer's commands. This resistance creates and inherently dangerous situation for all involved.

3) Suspect/Corpuz concealed in the residence of [REDACTED] 23rd St. Suspects hiding inside a home affords them concealment and poses Officer's with a tactical disadvantage and an inherently dangerous situation for all involved. Homes supply subjects with resources and both conventional and non conventional weapons, this enhances the risk for safety to both the public and to the Officer's attempting to locate and arrest suspect/Corpuz.

At approximately 1248 hours I deployed K9 Kai through the open window of the residence. I too climbed through the window and into the bathroom. I opened the bathroom door and directed Kai to search for the suspect.

At approximately 1250 hours K9 Kai ran to the east side of the residence and out of my view where I then could hear a mans voice yelling but I could not understand what he was saying. At approximately 1250 hours K9 Kai had made contact with suspect/Corpuz. I quickly walked to the rear door on the west side of the residence and unlocked it for additional units to make entry into the residence to assist with the custody phase of the incident.

I broadcasted over SPD radio that K9 had made contact and requested fire/medics code-3 for a K9 apprehension.

Officer's Anchuk and Shepard responded inside the residence to assist with taking suspect/Corpuz into custody.

Officer's Anchuk and myself quickly walked to the east side of the residence where we could hear K9 Kai and suspect/Corpuz. As I walked into the open room I could see K9 Kai in contact with suspect/Corpuz's left arm.

I took positive control of K9 Kai and directed him to release.

Officer's Anchuk and Shepard detained suspect/Corpuz in handcuffs and escorted suspect/Corpuz to the front porch of the residence.
