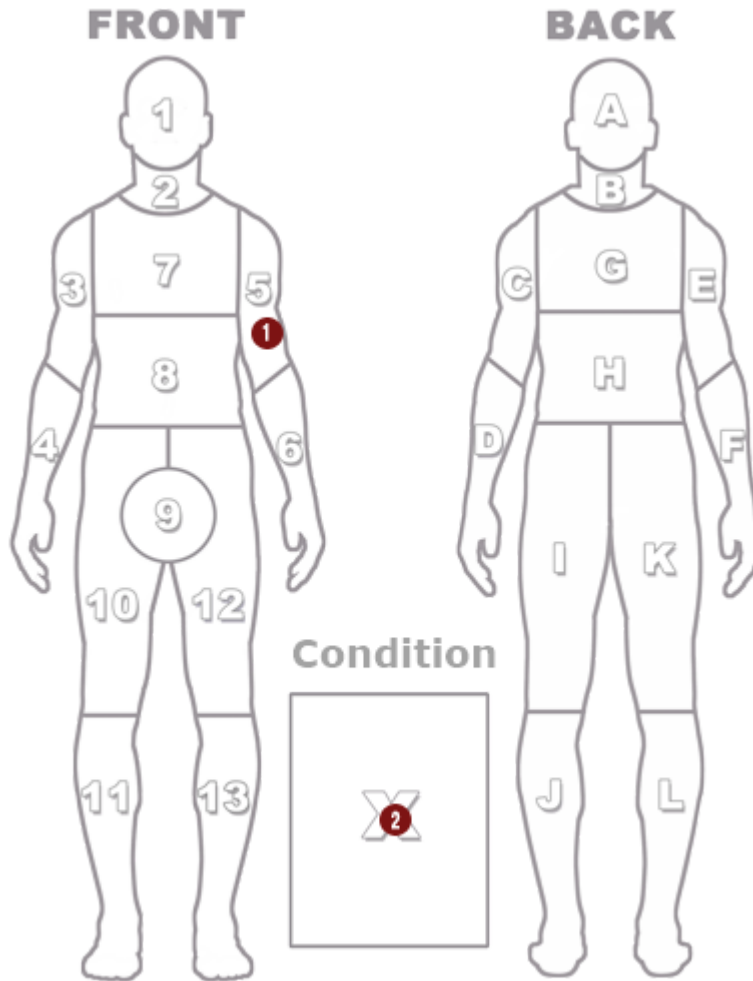

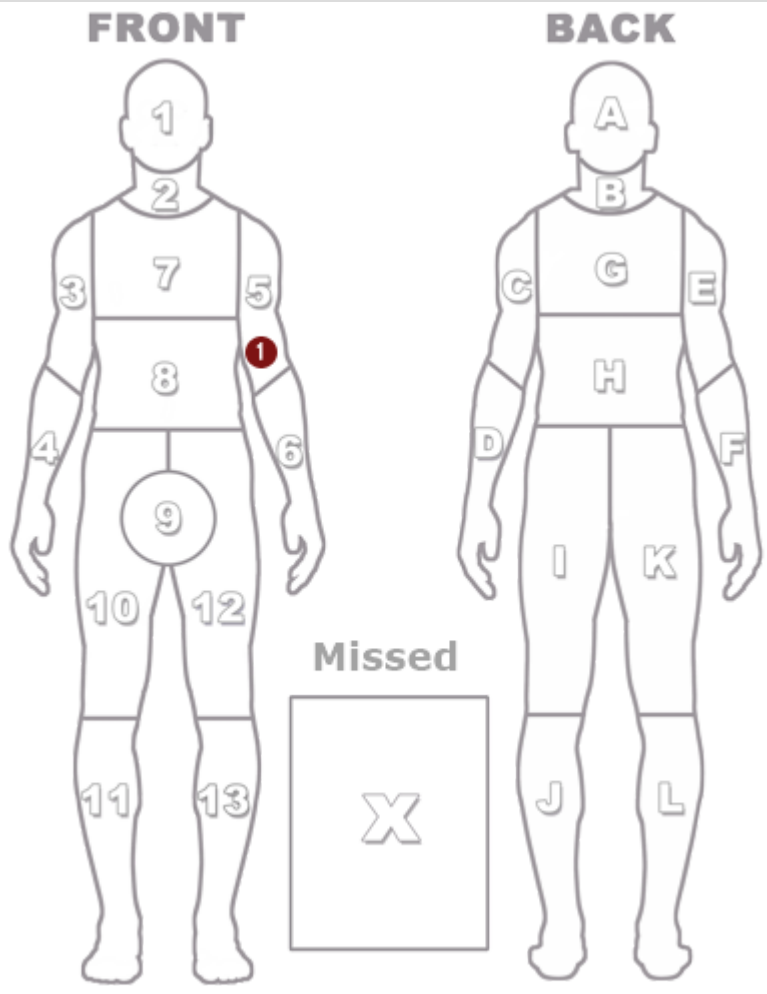

On Wednesday 06/12/2019 at approximately 0214 hours, I, Officer Vito #825, (1A54) was on scene of a family disturbance with Officer Brandt (1A56) at [REDACTED] Mack Rd # [REDACTED] (Trailer park).

Upon arrival we spoke with [REDACTED] and his wife [REDACTED]. They both told us that their daughter [REDACTED] did not live here. They said that she hadn't lived her with them for over a year, but about a week ago, she came around and [REDACTED] let [REDACTED] stay here because it was really hot that day. Since then she would not leave and they said they were going to get a restraining order tomorrow to make sure she leaves and stays away.

I was equipped with a body worn camera which was activated during this call.

They said that today she had been acting erratically, yelling and screaming at mom and they needed her out. Mom said that [REDACTED] has been continuously smoking meth and she doesn't eat which is why she is emaciated.

I explained that since she was only here for a week, she had not established residency and we would assist them in getting her to leave.

We entered the house where [REDACTED] was kneeling on the floor in the living room.

I told [REDACTED] she needed to grab her things and leave. She started talking about how her parents didn't care about her. I explained that we were not going to discuss that and she needed to leave. She then started in about how she has no place to go and where was she supposed to go. I explained that she was an adult and she would need to figure it out.

She started screaming about how she already had it figured out but no one was helping her.

I then explained that we had told her twice that she needed to get up and walk out the door and if she did not comply we would escort her out. I explained that we did not want to hurt her and I asked her to simply walk out on her own like an adult.

She made no attempt to get up so Officer Brandt and I took her arms and helped her to her feet. She got up willingly and started walking with us towards the door.

Once we got to the door she started flailing her arms and body and screaming for us to let her go.

I asked her what she would do if I did let her go and said she would get her things.

I asked her where her things were and she screamed "I don't know!"

I told Officer Brandt, let's just walk her outside and we will get her things for her.

We started to walk her out onto the porch and [REDACTED] started pulling her arms and flailing her body around.

I attempted to get a better hold on her left arm and she bent forward at the waist and put her head down almost onto a chair that was sitting on the porch.

I started to apply a rear wrist lock on her left arm and I could see Officer Brandt doing something similar on her right arm.

As I started to apply some pressure, I heard a loud pop and felt something in her elbow area.

I realized she was injured and I held her arm still to try and prevent further injury.

At first, she did not react and I told her not to move her arm because her arm was hurt.

We called for the fire department and for LSM5 (Sgt. Viscuso). I also asked for a few additional units to assist with taking statements.

As all this was happening, I had [REDACTED] sit in the chair and I told her repeatedly to stop moving. She was twitching and squirming and would not held her body still. I told her several times that something was wrong with her arm and that fire was enroute and try and hold still.

Officers arrived on scene and took statements from the mother and father (see their statements). Officer Elson (1A51) spoke with [REDACTED] and took a

Officers also conducted a canvass. There was a camera on the porch of the home however the homeowner could not pull the video up while we were on scene so Officer SCHANER (1A52) made up a call for dayshift to go and retrieve the video.

Fire arrived on scene and transported [REDACTED] to Kaiser South.

I later spoke with a doctor [REDACTED] who said that she had suffered a torsion fracture of the humerus bone (upper arm). He said she would most likely need surgery.

The doctor explained that this was most likely cause by some kind of twisting. The doctor also said that this type of injury would not have happened to a "normal" healthy person.

We cited the suspect for 148(a)1 PC, resisting, delaying, Officer and she was released per 853.6 PC.
