

On 11/11/2020, at approximately 1500 hours, CSO Briggs #8186I (Officer Walker #835) were en route to an unrelated call for service when we were hailed down by S- [REDACTED] at 5118 Stockton Blvd (Ross Department Store) regarding a MWA subject looking into his car and staring at his 6 year old son. We were in full police and CSO uniforms and driving a fully marked SPD patrol vehicle. Our body worn cameras were activated during the incident. The following are my observations in summary:

I arrived on scene at approximately 1500 hours.

Complainant [REDACTED] hailed me down and advised he had called dispatch regarding the subject looking at his son. He described him as a MWA, approximately 40-50 years old, 5'9", heavy build, wearing a long grey thermal shirt, blue jeans, and boots. He advised the subject walked up to his car while they were in the parking lot and began to stare at his son. He advised the subject made the comment he "does weird things sometimes". Comp [REDACTED] was concerned the subject might be a "child molester". Comp [REDACTED] took a picture of the subject. He showed me a picture of a MWA subject, approximately 40-50 years old, 5'9", heavy build, wearing a grey sweatshirt.

We began to check the front parking lot of Ross department store. I immediately saw S-Justin Kossak in the front parking lot. He was walking toward the front of the store from the parking lot. We made eye contact and I began to drive my patrol vehicle toward him. As soon as we made eye contact S-Kossak changed direction and began to walk away from the front of the store. It appeared he changed direction solely because he saw I was approaching him.

As S-Kossak was walking away from the store I paralleled him in the next parking lane with my marked SPD patrol vehicle. I made verbal contact with him and told him to stop. He stopped briefly. I exited my patrol vehicle and began to approach him. As I approached him he ran behind a vehicle and started to reach into his waist band. He bent over, appeared to remove something from his waistband, and placed an unknown item under a vehicle.

At this point I was at the rear end of the vehicle and S-Kossak was at the front of the vehicle. He stepped to the side, away from the item he had just attempted to conceal, and towards me. I confronted him about what he had just tried to hide. He advised he didn't try to hide anything and went right back to the item. He appeared to pick the unknown item up and began to run northbound through the parking lot toward Lawrence Dr. As he ran he continued to hold his waistband as if the item was weighted down.

Based on my training and experience I know that subjects will routinely carry

weapons and illegal contraband in their front waistband. I also know that when subjects carry weapons, such as handguns, they will carry them while running because they don't want them to fall out and are not properly secured.

At this time I voiced over the radio that S-Kossak was running from me and was holding his waistband as if he was carrying contraband or a weapon. I allowed S-Kossak to run away toward Lawrence Blvd. I did not give chase because I did not want to leave my cover behind the vehicle if S-Kossak was armed with a firearm. I checked under the vehicle where I saw S-Kossak attempt to hide the item and did not see anything on the ground. At this time I believed what ever contraband or weapon S-Kossak had attempted to conceal from me he was again in possession of.

I activated my overhead red and blue emergency lights and siren in my patrol vehicle and attempted to catch up to S-Kossak. I lost sight of S-Kossak as he ran westbound on Lawrence Blvd from the parking lot of Ross.

Several residents hailed me down and asked if I was looking for a white guy wearing all grey who was running down the street. They advised me he ran into Clauss Ct and was hiding behind several buildings.

I waited for additional officers to arrive to set up a perimeter. Officers Davis #975, Kelvin #1046, and Cato #443 arrived on scene. Officer Davis took a perimeter spot on 49th St. Officer Kelvin took a perimeter spot at the north end of Clauss Ct. Officer Cato and I began to search the open yards of Clauss Ct for S-Kossak.

As we were searching we located S-Kossak near the back of apartment D3. Officer Cato, Kelvin and I approached S-Kossak. S-Kossak had a plastic bag in one hand. I gave him commands to put his hands on top of his head and to face away from us. S-Kossak turned and tried to run south through the open yards to get away from us. As he ran S-Kossak began to again reach for his pockets and his front waistband. As S-Kossak was running away I was afraid for myself and my partners safety. I was afraid that S-Kossak was reaching into his waistband to grab a weapon that he could use to harm us. I did not know if he had a concealed weapon on him since I had not yet been able to pat him down for weapons and since he had attempted to conceal something from me before.

Based on the fact that I had seen S-Kossak attempt to conceal an item from me, ran away from me while holding his waistband consistent with someone holding a weapon, had not been searched for weapons, was not following commands to stop and place his hands on his head, and my reasonable fear that S-Kossak may have a weapon on him he could use to harm myself or my partners, I deployed my department issued Taser 7 Conductive Energy Device (CED).

The first cartridge (Serial #X4920AAAC) I deployed was ineffective and did not have any effect on S-Kossak. It appeared only one probe struck S-Kossak in the upper right shoulder of his back. He was able to keep running. Since the first CED deployment was not effective I deployed my second cartridge (Serial

#X4920AA4M) for the full five seconds. My second taser deployment was effective and caused S-Kossak to have Neuromuscular incapacitation.

While S-Kossak was still incapacitated by my second taser deployment, Officers Cato and Kelvin detained S-Kossak in handcuffs without further incident. While we detained S-Kossak he did not have any complaint of pain to his wrists, head, arms, or hands. While detaining S-Kossak other officers located approximately 0.51 grams of methamphetamine on S-Kossak's person. See their observations for details.

Once S-Kossak was detained I immediately requested Fire C3 for S-Kossak due to any injuries he may have obtained from my taser deployment. While walking S-Kossak back to our patrol vehicle I observed 3 of the 4 taser prongs were freely hanging from S-Kossak's clothing. To prevent anyone from being impaled by the prongs and causing any new injuries I placed them into the deployed cartridge bay, where they remained when I booked them as evidence.

An automated records check of S-Kossak indicated he was on Formal Searchable Probation [REDACTED]

The records check also indicated he had the following felony warrant for his arrest:

- Warrant # [REDACTED]

S-Kossak was arrested for his warrant, 11377 HS, and 148(A)(1) PC.

Officer Osmond #982 and J. Smith #575 later arrived on scene and took custody of S-Kossak. Metro Medic 53 later transported S-Kossak to UC Davis for medical treatment regarding the use of the taser. Once S-Kossak was cleared by UC Davis and found fit for incarceration, they booked him into the Sacramento County Main Jail.

Other officers conducted a canvas for any witnesses or video of the incident. See their observations for details.

I later recontacted Comp [REDACTED] and obtained his statement, see attached.

CSO Griggs and I later booked the 0.51 grams of NARTEC presumptive positive methamphetamine and Taser 7 cartridges as evidence at 555 Sequoia Pacific Blvd (Property) as evidence. We also booked S-Kossak's \$7 and personal property for safe keeping at property.

Sgt Porter #3138 was advised of the call on scene.

No other actions were taken on the call.

On 11/11/2020 at apprx 1507 hrs, while wearing my activated body worn camera, I, Ofc Kelvin #1046 responded to 5118 Stockton Blvd regarding Ofc D. Walker #0835 advising that a subject who was detained ran from him into the apartment complex located at █ Clause Ct. I observed that following in summary:

Ofc Walker described the subject to be a MWA , apprx 50 years old, and wearing a gray sweatshirt. Ofc Walker advisd that when the MWA originally ran from him, the subject pulled something from his waistband, put on the ground behind a car, then picked the item back up and put it back into his waistband and then ran away. After conducting a small perimeter inside the apartment complex I observed a MWA, apprx 50 years old, and wearing a gray sweatshirt in the northwest corner of the complex running southbound directly into where officers were standing. Ofc B. Cato #0443 held the MWA at gunpoint and Ofc Walker pointed his taser at the subject while giving him verbal commands to place his hands on the back of his head and not to place his hands back into his pockets. The MWA did not follow the verbal commands and placed his left hand back into his pocket and then began to run in the south bound direction again. Ofc Walker advised the MWA to stop and then deployed his taser apprx 2 times, as the initial deployment was ineffective on the MWA. The second deployment caused the MWA to fall to the ground where he placed into handcuffs.

I obtained the MWA, later identified as Justin KOSSAK DOB 01/18/1981, mirandized statement (see suspect statement). While speaking with KOSSAK he advised that he ran from police because he had meth in his hands and could not get rid of the meth fast enough so he ran.

On Wednesday 11/11/2020 at approx. 1458 hrs I, Officer Cato #443 was dispatched to 5118 Stockton Blvd regarding a suspicious subject. I arrived on scene at approx. 1503 hrs.

My body worn camera and in car camera were activated and recording.

Upon arrival, officers on scene advised that the subject on this call (MWA, 40-50, 5'9-10/heavy build, long gray thermal shirt, blue jeans, boots, hospital mask, and carrying a Walmart bag) ran from them and was reaching in his waist band. Officers advised that a witness told them the subject ran behind the homes on Clauss Ct.

I assisted looking behind the homes. While doing so Officer Kelvin #1046 advised on the radio that she was being hailed in the back of these homes. I observed a person matching the above description walking quickly from behind one of the homes.

While holding the male at gun point I gave him commands to stop walking, he continued walking. He put his right hand over the wall as if he was dropping something. I gave commands to show me his hand and he continued walking while holding a dark unknown item in his right hand and a plastic bag in his left hand. He advised that he did not do anything and he took a few more steps.

I gave commands to stop and to put down his bag, he did not put his bag down. Officer Walker #835 gave commands to put his hands on his head and face away from us. The male dropped his bag and proceeded to put his hands on his head and turn around. He then reached his left hand into his left front pants pocket to the point where his hand was no longer visible. He then bent down grabbed his plastic bag and began running away from us.

Officer Walker deployed his CED on the male and he immediately fell to the ground. Officer Kelvin and I detained the male in handcuffs. The male advised that he had methamphetamine on him. He began apologizing. He advised that his name was Justin Kossak. Officer Kelvin and Officer Davis #975 removed the items from his person.

Kossak was detained in the back of a patrol vehicle. Fire responded to do a medical evaluation on Kossak.

Officer Davis and I checked the backyards, with consent from residents, on the other side of the wall that Kossak was reaching over (████ 49th St, █████ 49th St) (Officer Davis checked the yards of two other residents, see her observations).

On 11/11/20 at approximately 1504 hours, I (Ofc. Davis #975) responded to the area of 5118 Stockton Blvd. to assist 1B64 (Ofc. Walker, CSO Briggs) with an uncooperative suspicious subject. My Body Worn Camera was on and recording. I observed the following in summary:

I located Ofc. Walker and CSO Briggs in the area of Clauss Ct. and Lawrence Dr. Walker advised the subject he was attempting to detain had fled from him on foot and requested I park my patrol vehicle to the West, on 49th St to hold a perimeter spot.

While parked on 49th St at Lawrence Dr. Ofc. Walker advised over the radio he had the Subject at Taser point at which time I responded to Clauss Ct.

When I responded to Clauss Ct, CSO Briggs advised Officers were detaining the subject behind the homes located on the west side of Clauss Ct. I ran to where CSO Briggs was pointing and observed Officers Walker, Cato and Kelvin detaining a male subject behind unit # [REDACTED] of Clauss Ct. The subject had taser prongs attached to him.

Officers detained the subject (later identified as Suspect Justin Kossak) in handcuffs. (S)Kossak spontaneously stated he had Dope and \$7.00 in his hand. I observed (S)Kossak had cash and a folded up lottery ticket in his hands while they were cuffed behind his back. I removed the money and a lottery ticket from (S)Kossak's hands. I observed a white crystalline substance inside of the lottery ticket. I conducted a Nartec Chemical test of the crystalline substance which tested presumptive positive for Crystal Methamphetamine. Ofc. Walker took possession of the money and Methamphetamine (see his observations for further).

I conducted a canvass of the area where (S)Kossak was detained with the following results:

Records or information, the disclosure of which would constitute an unwarranted invasion of personal privacy (Cal. Gov. Code § 7927.700; see also City of San Jose v. Superior Court (1999) 74 Cal.App.4<sup>th</sup> 1008);

Records or information, the disclosure of which is exempted or prohibited pursuant to federal or state law (Cal. Gov. Code § 7927.705; see also Cal. Const. art. 1 § 1; Cal. Pen. Code § 832.7(a); Cal. Evid. Code § 1040);

Records or information, the disclosure of which would reveal personal identifying information, where, on the facts of the particular case, the public interest served by not disclosing the information clearly outweighs the public interest served by disclosure of the information (Cal. Pen. Code § 832.7(b)(7));

Records or information wherein the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure (Cal. Gov. Code § 7922.000);

Records or information that constitute confidential medical, financial, or other information, the disclosure of which is specifically prohibited by federal law or would cause an unwarranted invasion of personal privacy (Cal. Pen. Code § 832.7(b)(6)(C)); and

Records or information, the disclosure of which is exempted or prohibited pursuant to federal or state law (Cal. Gov. Code § 7927.705; see also Cal. Const. art. 1 Sec. 1; Cal. Pen. Code § 15150 et seq.; and Cal. Pen. Code §§ 11105 and 13300).
