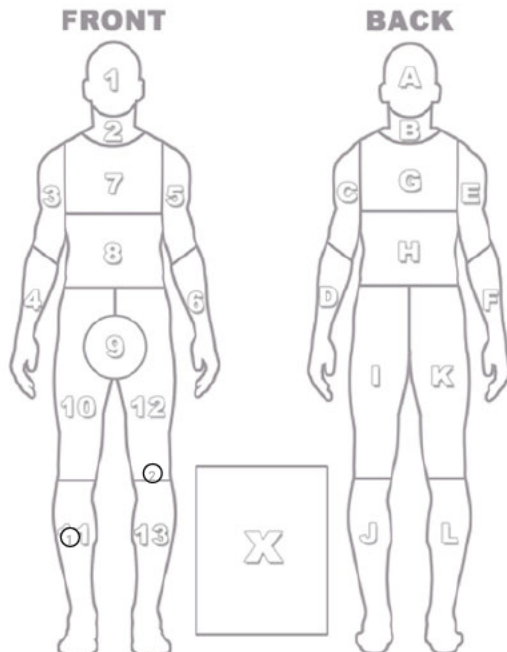

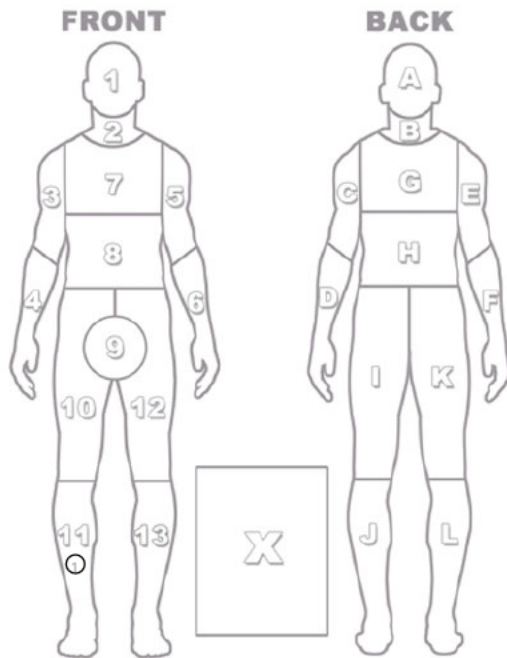

On 05/10/21, at approx. 2132 hours, I, Officer Catricala #379, and my partner (K9 Buster) were requested by the California Highway Patrol (CHP) to assist their Officers on a felony vehicle stop following a vehicle collision and vehicle pursuit (CHP #210510SA01406). I responded from the area of T St. and Alhambra Blvd. I arrived on scene at approx. 2201 hours.

The information I gathered on scene was that CHP responded to a vehicle collision in the Antelope area of North Sacramento. When a CHP unit arrived on scene the driver of the vehicle involved in the collision, later identified as Dylan Drewry (01/27/93), became confrontational with the CHP Officer and began to reach for his waistband. Because of the way Drewry was grabbing his waistband the CHP Officer thought that Drewry possibly had a firearm in his waistband. The CHP Officer asked for an additional unit at which point Drewry got back into his vehicle and fled the scene.

CHP and Sacramento Sherrif's Deputies (SSD) pursued after Drewry in his vehicle (CA # [REDACTED], Silver Nissan Sentra). CHP Officers advised that the speeds of the pursuit were 70-80 MPH on surface streets and that Drewry ran numerous red lights in an attempt to evade Officers and get away. Pursuing Officers also advised that at various points throughout the pursuit Drewry appeared to be reaching around inside of his vehicle and under the seats of his vehicle while driving. The pursuit terminated at 1435 Auburn Blvd.

Once Drewry stopped his vehicle a felony vehicle stop was initiated. Drewry immediately got out of his vehicle and turned away from Officers appearing to conceal an item in his waistband. CHP and SSD units attempted to get Drewry to comply and cooperate, but Drewry would not follow any of the commands given to him. CHP and SSD units attempted de-escalation techniques for no less than 8 minute prior to my arrival.

Once on scene I observed Drewry standing approx. 15 feet from his vehicle with his hands up. The driver's door of his vehicle was open. Drewry appeared to be very agitated and possibly under the influence of narcotics as he was fidgety and had difficulty standing still. Drewry was clenching his fists

and breathing extremely heavily. Every so often he would lower his hands and have to be told to keep them up above his head. I advised Drewry to get on the ground and to cooperate or else he would be bitten by a police K9. Drewry looked back and saw me standing there with K9 Buster on a leash, but Drewry did not comply with my command. Prior to forming a contact team Drewry had slowly been moving away from us and was now approx. 50 feet from his vehicle.

A contact team was formed in order to safely get Drewry into custody. As the contact team moved up to contact Drewry he began to walk away. Myself, K9 Buster and the contact team followed Drewry for approx. 30 ft. Drewry continued to walk away at which point less lethal flexible baton rounds were fired at Drewry. As the rounds hit him he attempted to run south away from us at which point I gave K9 Buster the apprehend command.

I deployed K9 Buster for the following:

-Drewry was to be arrested for 20002 VC, 148 PC, 2800.2 VC.

-Drewry displayed a high level of resistance by fleeing from uniformed CHP officers on scene and continuing to flee from them at a high rate of speed in his vehicle. Further, Drewry continued to resist even after a police K9 arrived on scene.

-Drewry had not been properly searched and was seen grabbing his waistband and grabbing/moving items in his vehicle. Drewry could've been armed with a knife, firearm or other weapon used to harm other Officers or members of the public.

-Drewry was now actively resisting and attempting to flee again from Officers after being struck with less lethal baton rounds potentially putting the public and citizens in the neighborhood to the south where he was fleeing in further danger.

K9 Buster made contact with Drewry's right lower leg/calf area. Drewry fell to the ground, but quickly got back to his feet and began to hop around with K9 Buster on his leg. Numerous commands were given to Drewry to get back on the ground, but he did not comply. To further prevent Drewry from attempting

to flee again or defeat K9 Buster I ran up and forced Drewry to the ground to gain a tactical advantage over him. Numerous CHP and SSD units quickly came to my aid. Drewry continued to fight and struggle with Officers as K9 Buster was still in contact with him. During the struggle Drewry attempted to reach for his waistband. Once CHP / SSD units had control of Drewry's hands I took positive control of K9 Buster and he released Drewry's leg. A folding knife was found in Drewry's pocket/waistband area.

Sacramento Metro Engine and Medic 20 responded to provide medical attention to Drewry's leg. I observed lacerations and punctures to Drewry's right calf. Drewry also had an abrasion to his right knee.

Officer Henderson attempted to get a Mirandized statement from Drewry, but he was unable to provide a statement. Officer Henderson also conducted a canvas for witnesses and surveillance video (SEE OFFICER HENDERSON OBSERVATIONS).

Drewry was transported to UC Davis medical center in the custody of CHP.

Sgt. Nutley was advised of the incident and responded to the scene.

CSI responded to the scene to take photographs of the vehicle. CSI then responded to UC Davis to take photographs of Drewry's injuries.

I completed a City of Sacramento Red Border form for the injuries that Drewry sustained during this incident. Neither K9 Buster nor myself were injured.

My body worn camera was activated during this incident.

I cleared the scene.
