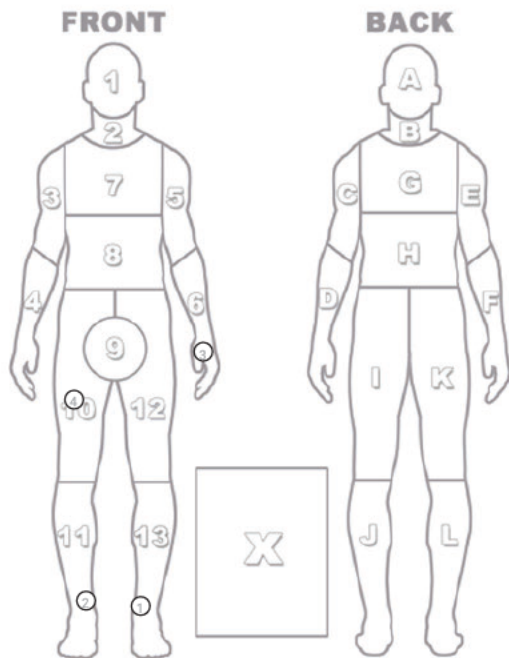

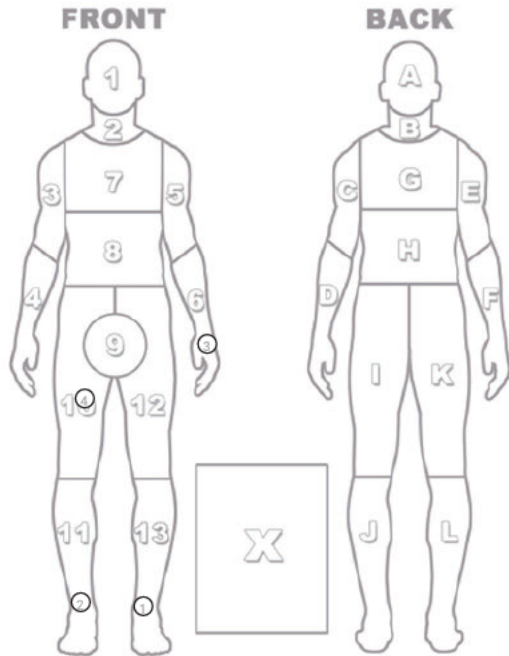

## Incident Summary

See attached report for details of the incident. After reviewing the report, dispatch audio, and the associated ICC/BWC footage, I did observe the following:

The incident went to surveillance mode a short time after the pursuit began. Officer Morrill-Heredia turned off the ICC/BWC when the vehicle deactivated lights and siren and followed the suspect vehicle while going the rules of the road. A second incident started during surveillance mode after and attempt to detain the suspect driver after the suspect parked for a short time. Units again activated their lights and siren and followed for a short time until surveillance mode was initiated again. Officer Morrill-Heredia again deactivated the ICC/BWC while responding the the termination point of the incident while the suspect was being surveilled by the air unit.

As I was conducting the welfare check on the residence, Officer Terman attempted to contact Miller who AIR 21 was following. I heard over the radio that Officer Terman attempted to conduct an enforcement stop on Miller who failed to stop and took officers on a felony pursuit. I heard over the radio that the pursuit went into surveillance mode and the vehicle was parked in the area of Erin Dr/ Dorine Way. Surveillance mode is when the ground units pursuing the suspect vehicle stop pursuing and set up loose perimeter around the vehicle. The air unit follows the suspect vehicle until it parks or the suspect flees from the vehicle. This is done when the suspect vehicle driving becomes reckless and greatly endangers the public. Officer Terman, along with additional Officers, attempted to conduct a felony car stop of the vehicle and again it led officers on a felony pursuit. Officer Terman advised that he was able to positively identify the driver of the vehicle as Andrew Miller. Officer Terman also advised that Miller was wearing a light colored tank top at the time of the felony stop which matched the description of the subject breaking into [REDACTED] Rio Adelanto Ct. The pursuit again went into surveillance mode and AIR21 followed the vehicle until Miller parked and fled into the backyard of [REDACTED] Grove Ave. See Officer Terman's supplement for further detail.

Over the radio 1SM4 (Sgt Cunningham) approved the use of K9.

AIR21 advised that the subject ran to the backyard of the [REDACTED] Grove Ave and gained entry into the house. Officers set up a perimeter around the residence and Officer Maclean #1010 and I took up a containment position to the rear of the residence. From my containment position in Carl Johnston Park, I could clearly hear the K9 announcements that were given by officers on a PA in the front of the residence.

Officers in the front of the residence gave numerous PA announcements for Andrew Miller to come out and to surrender to officers. There was no response at the front. A short time later I observed what appeared to be a male subject with a long sleeve black t-shirt and shorts walk to the far west fence line of [REDACTED] Grove Ave. The unidentified male subject appeared to look around and then walked directly back to the residence. A short time later, another male matching the description of Andrew Miller started to slowly walk to towards the far west fine line of the property. I observed Miller hop the fence into [REDACTED] Grove Ave and then hide behind a trailer. Miller then hopped back into the yard of [REDACTED] Grove Ave and ran back to the residence. As Miller was running back to

the residence, he ran under a light that illuminated his body. At that time I observed him wearing a gray tank top and red basketball shorts with a black stripe, which matched the description of what Officer Terman observed and what was provided by the original complainant.

I observed Miller move around the large back property of [REDACTED] Grove Ave and at multiple times I lost sight of him as he appeared to conceal himself near a shed. Several times, I observed another male subject, who was wearing a long black shirt and shorts, walk around the property with Miller. It appeared that the male subject was assisting Miller with evading arrest by the police.

For approximately fifteen minutes, I observed Miller move around the yard of [REDACTED] Grove Ave. There were a large number of items in the back property of [REDACTED] Grove Ave, including a shed, a car, and other large items. This provided Miller with a place to hide, and gave him access to potential weapons for him to arm himself with. Miller did comply with the PA commands that were given to him by officers in the front of the residence, which were clearly audible from my position. I then observed the unidentified male subject walk in the same direction where Miller went. Subsequently, I saw Miller walk back out wearing a long black t-shirt, which appeared to be the same shirt that the unidentified subject was wearing. Miller slowly started to walk west through the property to the west fence line. As Miller got closer, I could clearly see that he was still wearing the bright red basketball shorts, but now had the black t-shirt on.

I observed Miller push himself through the west fence line of [REDACTED] Grove Ave to Carl Johnston Park. At that time, I stood up and in a loud voice gave a K9 advisement by yelling "Police K9-do not run". Miller failed to comply with my command, and turned away and ran northbound through Carl Johnston Park. At this point, I directed my K9 partner Hoss to apprehend Miller based on the following information known to me at the time:

- 1) Miller was wanted for multiple counts of fresh 2800.2 CVC-reckless evading of a police officer.
- 2) Miller was wanted for a misdemeanor charge of 148 PC- resisting arrest.

- 3) Miller was wanted for a violation of his terms of his probation and PRCS-3454 PC
- 4) Miller ignored multiple PA announcements, specifically naming him to peacefully surrender to officers.
- 5) If allowed to escape on foot, Miller would put additional citizens at risk due to the fact that this was occurring in a residential neighborhood. Miller had already shown that he was willing to attempt to gain access into residences in an effort to evade arrest. The utilization of a trained police K9 sent directly to apprehend the suspect in the event he fled could prevent him from concealing himself in another location, gaining access to traditional and non-traditional weapons that could be used against officers or citizens. This would increase the safety of officers who would be searching for the suspect, as well as the public.
- 6) Miller possessed a [REDACTED] thereby leading officers to believe he was capable of further violence.
- 7) Miller fled from officers and had not been searched for weapons. Considering his [REDACTED] and Miller being a [REDACTED] it was not unreasonable to believe that Miller could be possibly armed.

I briefly lost sight of K9 Hoss due to the darkness in the park. As I ran towards the location of Miller and K9 Hoss, I observed that K9 Hoss had made contact with Miller's left forearm. Miller was sitting down with both of his hands visible. I observed what I thought was a phone in Miller's left hand.

Miller was verbally stating that he was going to comply and at which point I took positive control of K9 Hoss. I directed K9 Hoss to release his hold and he immediately released his hold as instructed.

At this point, Miller immediately rolled to his stomach and concealed his hands under his torso. I observed Officer Maclean attempting to gain control of Miller, and it appeared Officer Maclean was unable to gain control over Miller

due to him actively resisting. I yelled at Miller to stop fighting multiple times. Miller continued to resist Ofc. Maclean.

In my training and experience, I know that it is common for subjects to conceal weapons in their waistbands or hide them in loose clothing. Miller had switched clothing and I was in fear that Miller may have additionally armed himself with a weapon and was attempting to conceal it within his loose-fitting clothing. Given Miller's furtive movements, continuing to actively resist, and not being searched for weapons, I directed Officer Maclean to get off Miller and I directed K9 Hoss to make contact with Miller again. This was in an attempt to gain a tactical advantage to overcome Miller's resistance. K9 Hoss made contact with Miller's right ankle and Miller immediately removed his hands from under torso. I could see that Miller not holding a weapon. Miller verbally stated that he was done and at that time I again took positive control of K9 Hoss and directed him to release his hold. K9 Hoss released his hold as instructed and it was then that additional officers arrived and assisted Officer Maclean with taking Miller into custody.

I immediately requested code three fire and ambulance for medical treatment for Miller. Engine 20 and Medic 20 responded and rendered first aid to Miller's injuries. Miller was later transported to Sutter hospital for medical treatment.

Miller sustained dog bite injuries consisting of punctures, rakes to his right ankle, left ankle, left hand, and upper right thigh. During Miller's attempt to evade arrest he did climb over a barb wire fence multiple times and could have sustained injuries.

CSI was requested to respond to the hospital to photograph Miller's injuries.

Miller was taken into custody for 2800.2 CVC, 148 PC and 3454 PC.

A neighborhood canvass was completed by officers on scene.

1SM4 was advised and took photos of the scene where Miller was taken into custody.

Further details indicated that the subject was described as "Andrew", a male, possibly Hispanic, 31-32 years old, medium-heavy build with a bald head wearing a white tank top and red shorts. Complainant advised that she had locked herself in the bedroom with two young kids and that Andrew (later identified as Andrew MILLER X-■) had broken into the house. I attempted to locate the fleeing vehicle in the area as Officer Wagstaff responded to [REDACTED] Rio Adelanto Ct to conduct a welfare check of the complainant and children. As I was at the intersection of Rockinghorse/Bridgeford, Air21 advised that the vehicle was SB Bridgeford passing Chuckwagon. I drove SB Bridgeford reaching speeds of approx. 62 mph. As I approached San Juan/Bridgeford, Air21 advised that the vehicle had turned EB on San Juan from Bridgeford. I reached the intersection (a red light) and used my lights/sirens to clear it safely in an attempt to continue to try to catch up to the vehicle. I reached speeds of approx. 79 mph on San Juan as I could see the vehicle approx. 100-200 yards ahead of me traveling EB San Juan at a high rate of speed. It should be noted that the speed limit on San Juan at this point was 40 mph. I did not pass any other vehicles EB San Juan from Bridgeford until I arrived at the intersection of San Juan/Northgate where I observed the vehicle (Silver Chrysler 300 [REDACTED]) stopped at a stale red light. There were no other vehicles in the EB lanes of traffic at the light when I arrived at the intersection. Air21 advised that I was behind the correct vehicle.

While I was attempting to locate the vehicle, Officer Wagstaff had provided several radio broadcasts advising that the complainant and children were ok, that there was no crime and that Andrew resided at the house.

I decided to conduct an enforcement stop based on the high degree of likelihood that the subject driving the Chrysler was MILLER (active PRCS). Additionally, the Chrysler had been driving at a high rate of speed as it fled the area in violation of 22350 CVC.

As the light turned green for EB traffic San Juan/Northgate, I followed the Chrysler which continued EB. It should be noted that just prior to activating my lights and sirens, I was driving approx. 50 mph and I was not overtaking the Chrysler. Moments after activating my lights/sirens for an enforcement stop, I reached speeds of approx. 62 mph (speed limit in this area was 35 mph) as I attempted to overtake the vehicle. The Chrysler slowed slightly and appeared to yield to the right before continuing to drive EB, appearing to yield once more and clipping the curb, once again re-centering in the EB lanes of traffic and continuing EB. At this point I broadcasted that I was in vehicle pursuit, updating the speed, direction of travel and want (traffic). The Chrysler began accelerating rapidly, running the stop sign at Mabel/Silver Eagle (violation of 22450 CVC, continuing EB and running the stale red light Norwood/Silver Eagle (violation of 21453 CVC). approx. 73 mph as I continued to pursue the Chrysler SB Norwood though Fairbanks. In the area of Norwood/Lindley, Sgt. Cunningham ordered units to reduce and go surveillance mode. I slowed down to a safe speed and deactivated my lights and sirens, following the path of travel of the Chrysler from a distance as Air21 continued providing updates.

#### \*\*\*FIRST PURSUIT\*\*\*

Top speed: approx. 78 mph  
Distance: approx .90 miles

Eventually Air21 advised that the Chrysler had parked at Erin, south of Dorine and that no one had entered or exited the vehicle. I requested permission to re-engage the vehicle for a felony stop from Sgt. Cunningham who replied affirmatively. I proceeded to Dorine/Erin where I observed the vehicle on the west curb line facing SB on Erin Dr. I drove up to it on the Driver's side approaching from an angle, activating my overhead lights. Air21 advised that we were contacting the correct vehicle. I observed the driver appeared to be MILLER (please see Officer Murchie's supplement for additional observations regarding this portion of the incident). I yelled at MILLER to shut the car off. MILLER put the vehicle in drive and fled SB Erin at a high rate of speed. I initiated a second vehicle pursuit, activating my overhead lights and sirens as I pursued MILLER SB Erin towards West El Camino. I reach speeds of approx. 62 mph as I pursued MILLER SB Erin. At Erin/West El Camino, MILLER did not come to a full stop at the stop sign (violation of 22450 CVC) and continued fleeing EB West El Camino at a high rate of speed. I reached speeds of approx. 80 mph as I continued pursuing MILLER. In the area of Northgate/West El Camino, Sgt. Cunningham ordered units to go surveillance mode again. It should be noted that within moments of units going surveillance mode, MILLER appeared to run a red light at Northgate/West El Camino. I once again slowed down to a safe speed and deactivated my lights and sirens, following the path of travel of the Chrysler from a distance as Air21 continued providing updates.

Air21 advised that MILLER had jumped a fence into the front yard, a back fence and then made it inside of the residence at

█ Grove Ave. I arrived in the area and began setting up a perimeter and containment. Multiple units responded for assistance. During this time, I directed Officers to cut a chain which was securing a gate, and to ram a residential pedestrian gate both in an attempt to provide a position of advantage for our contact and perimeter teams (see red border forms). It was quickly determined that the residence was likely friendly to MILLER. Once the perimeter and containment were set, numerous PA announcements were made for all occupants to exit the residence. We received no response. Subsequently, numerous PA announcements were directed towards MILLER, asking for him to surrender and advising that if he resisted he would be bit by a Police K9. We received no response.

Eventually, Officer Wagstaff and perimeter Officers to the west observed MILLER and a possible homeowner from █ Grove in the backyard of the residence. Per radio updates, they appeared to be scouting out a possible path of escape for MILLER. I moved my contact team to the church parking lot immediately north of █ Grove, approx. 50 yards to the west of Grove. After a short period of time, western perimeter units advised via radio that MILLER was fleeing westbound towards them. I heard Officer Wagstaff yell "Police K9 don't run", then I observed the silhouettes of MILLER fleeing NB and K9 "Hoss" in pursuit. I then heard Officer Wagstaff yell "don't fight" as he updated that MILLER was fighting Hoss and the contact team. I sent two Officers from my team to assist in taking MILLER into custody (please see Officer's supplements for details). MILLER was eventually taken into custody without further incident.

I responded to the front of █ Grove and attempted to contact the residents by knocking on the door several times and announcing myself as Police. I received no response.

I assisted Sgt. Cunningham in photographing the area where the K9 apprehension took place and then various locks and gates that were damaged throughout the scene.

Sgt. Cunningham (1SM4) and Sgt. Thompson (K9SM9) were advised of the details and circumstances of this call.
