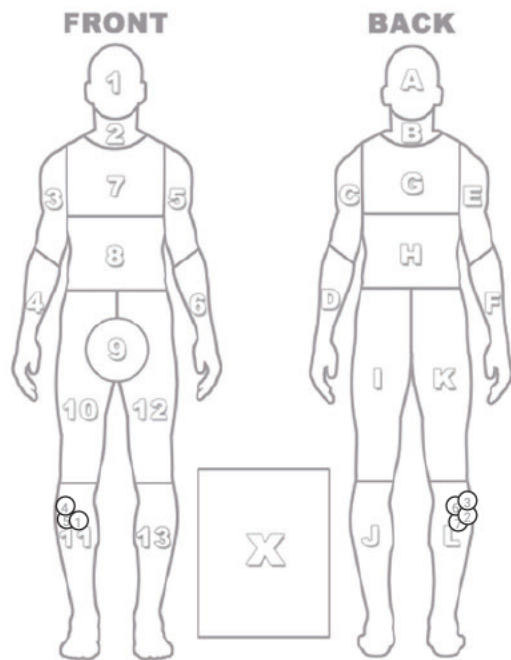

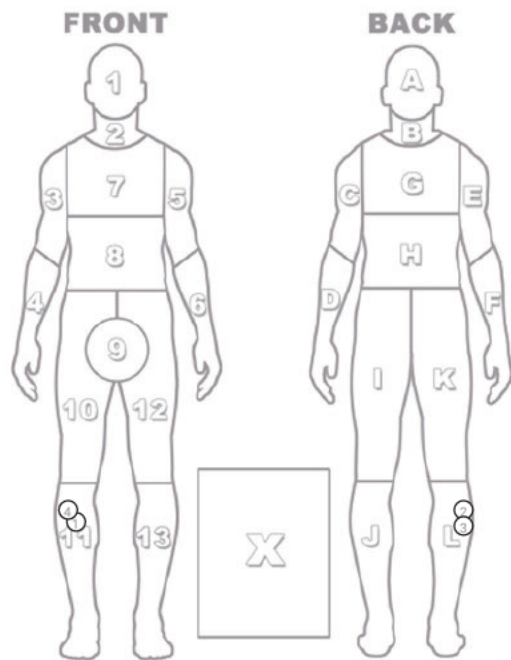

I arrived on scene at approximately 1901 hours. My body worn camera and in car camera were activated and recording for the entirety of the investigation. I observed the following in summary:

I contacted S-Lilly's aunt (█████) via telephone (PHN: █████) who advised me that the restraining order against S-Lilly was not properly served. █████ advised that she did not have the paperwork for the restraining order anymore because when law enforcement attempted to serve it before, they took it.

I verbally served a restraining order that was issued to S-Lilly on 06/17/2021 (█████) I contacted SPD records and updated the status of the restraining order. S-Lilly verbally acknowledged the terms of the restraining order by stating "Okay".

While serving the restraining order to S-Lilly, Sacramento County Sheriff deputies advised me that S-Lilly had four white oval shaped pills that were located in his boxers near his genitals.

While at Kaiser South, medical personnel gave S-Lilly four white oval shaped pain medication pills, I was unaware of the names on the pills.

I observed S-Lilly put the pills in his mouth and drink water to swallow the pills.

I observed the pills to be long oval white shaped pills, approximately 5 centimeters in length. Upon closer observation of the pills, the four white pills were partially dissolved and any number on the pills were not legible.

I recognized the pills to be similar to the ones given to S-Lilly by medical personnel at Kaiser South.

I completed an additional booking packet for S-Lilly for being in violation of 4573.5 PC and

On Friday, 7/16/2021, at approx. 1856 hours, I, Officer Terman #879 and my Police K9 "Ranger" were in the area of Francine/Mace. I was driving a marked SacPD K9 SUV and I was wearing a full Police uniform. K9 Ranger was wearing a Sacramento Police K9 badge and a tactical collar with "POLICE" printed in bold reflective lettering across it. I observed the following in summary:

My in car camera and body worn camera were activated for this incident

I observed a subject (Donte LILLY, X-██████████) that I was personally familiar with based on a prior contact (21- 67786). During this past contact, LILLY, who at the time was wanted for being a parolee at large, had fled from Deputies and barricaded himself on a church roof where a lengthy standoff ensued. During this time, LILLY demonstrated continued active resistance against Officers/Deputies on scene. Ultimately, law enforcement left the area based on officer safety concerns. LILLY was not taken into custody that day.

Additionally, on 7/15/2021, I responded to the area of Francine/Mace for a disturbance call for service (21-198738). Lilly's aunt had called SacPD to advise (in summary) that LILLY was on foot in the area, possibly high on narcotics, [REDACTED] but she was not sure and that she would like him sent on his way. Responding patrol units conducted records checks and determined that LILLY had a felony want for being a parolee at large. Due to LILLY's felony want and criminal history, Sgt. Casella (1SM6) had given authorization for K9 usage prior to units responding to the scene. LILLY was gone upon our arrival to the area and we were unable to locate him in the general vicinity.

On, 7/16/2021, as I arrived in the area of Francine/Mace, I observed a male Asian adult running EB on Francine towards Mace then NB Mace past my car. I then observed LILLY walking EB on the south curbline of Francine, just west of Mace. At this point I was unable to confirm if the male Asian adult was fleeing from LILLY, however I believed he may have been. I broadcasted my location via radio, advised that I was out with a parolee at large and requested additional units. I drove up to within approx. 10 yards of LILLY, positioning my vehicle head on with him. LILLY had an object in his left hand, I could not determine what the object was. I exited my vehicle and said "Donte don't run, don't run you'll get bit. Get on the ground right now, get on the ground." As I ordered LILLY to the ground the second time, he turned away from me and began sprinting WB Francine away from me. I opened Ranger's door and commanded him to exit the vehicle and "heel" (run at my side) as I pursued LILLY on foot. I observed that LILLY was still sprinting WB Francine away from

me and had made no apparent attempt to stop, surrender or comply. I gave Ranger his command to pursue and apprehend LILLY based on the following facts and circumstances that were known to me at the time of the incident:

- LILLY had a felony want for being a parolee at large (confirmed by patrol units who had responded to the call for service the night prior).
- LILLY had criminal history to include but not limited to: [REDACTED]
[REDACTED] LILLY's criminal history included [REDACTED] [REDACTED] [REDACTED].
- LILLY had a consistent history of active resistance and combativeness with Law Enforcement upon contact.
- LILLY had demonstrated a high level of active resistance against me personally by failing to comply with multiple lawful commands including K9 warnings and running away from me. LILLY physically signaled an intention to avoid or prevent being taken into custody.
- LILLY was wearing shorts with pockets and had not been searched for weapons, additionally LILLY was holding an unknown object in his left hand.
- I was a solo unit attempting to apprehend an extremely violent subject with history of [REDACTED].
- Using a Police K9 to apprehend LILLY would greatly enhance my officer safety and diminish his opportunity to continue to flee into the neighborhood and endanger the community.

Ranger and I pursued LILLY as he continued running WB Francine. In front of [REDACTED] Francine, LILLY jumped onto the hood of a Honda Civic in an apparent attempt to evade Ranger. Ranger made contact with LILLY on the hood/front windshield of the vehicle. I broadcasted via radio that I was in foot pursuit, that my dog had made contact with LILLY and that I needed code 3 assistance. I continued running WB Francine to catch up to LILLY and Ranger. As I got closer, I observed LILLY struggling with Ranger and I observed that Ranger had made contact with LILLY's right lower leg. I ordered LILLY to get on the ground. I took control of Ranger's collar and pulled both LILLY and Ranger to the ground. I ordered LILLY to roll onto his stomach. He would not comply. However at this point, LILLY was not struggling with Ranger, both of LILLY's hands were visible to me and he appeared to be surrendering. I ordered Ranger to release LILLY. Ranger released LILLY.

I took several steps back with positive control of Ranger's collar and Ranger in between my legs. I ordered LILLY to roll onto his stomach and to keep his hands visible. I warned LILLY that if he resisted he would be bit again. I

advised dispatch and incoming units via radio that Ranger had released LILLY, that LILLY was compliant and for units to continue responding code 3. Eventually LILLY rolled onto on his stomach. I requested that Fire Paramedics respond for LILLY's dog bite injuries.

Shortly after, Officer Russell (1C77) arrived on scene and LILLY was taken into custody without further incident.

Multiple other Officers also arrived in the area and assisted with LILLY's immediate medical care as well as a canvass of the surrounding area (see supplements).

I requested CSI for photographs of the scene at Francine/Mace as well as LILLY's injuries.

Fire Paramedics arrived, took over LILLY's medical treatment and transported LILLY to the Kaiser South Sacramento Emergency Room where he received continued medical care. Officer Morgan (1C79) responded to Kaiser South with LILLY and kept prisoner watch of LILLY.

I responded to Kaiser South to contact LILLY. Officer Morgan advised that LILLY had been Mirandized and had not invoked his Miranda rights. I asked LILLY if he had heard my K9 warnings, he responded yes. I asked him why he ran, he said because he was scared. I asked him if he got on top of the Honda Civic because he thought that Ranger would not be able to get him up there, he responded yes.

I observed LILLY's injuries to include several 1-2 inch evulsions, rakes and punctures to his lower right leg.

Officer Morgan transported LILLY to the Sacramento County Main Jail where he was booked for his outstanding PAL want and 148 PC.

I completed a City of Sacramento Red Border form and submitted it for approval to Sgt. Thompson (K9SM9).

Lt. Kaneyuki (LN12), Sgt. Jarvis (3SM6) and Sgt. Thompson (K9SM9) were advised of the details and circumstances of this incident.
