On 08/13/22, at approximately 0252 hours, I, Officer Wagstaff, responded code three from Stockton Blvd/ N St in a fully marked Sacramento Police K9 car to assist the Sacramento County Sheriff Department (SSD). SSD was in a vehicle pursuit of a black BMW (Methode) in the area of Fruitridge Rd/ Wilkinson Dr. The pursuit came to a stop in front of Methode Emerson Rd, where the driver of the vehicle fled on foot into the surrounding neighborhood. A perimeter was established in the surrounding area and the driver was described as a male black adult with dreads. Lt. Villegas (LN15) approved that I could respond and assist SSD. I arrived on scene at approximately 0257 hour. I observed the following in summary:

I contacted Deputy Kim, who advised that they could identify the driver and was described as a male black adult wearing a grey t-shirt with dreads. The driver was last seen running northbound Emerson Rd towards 25th Ave.

Deputy Kim advised that the driver of the BMW reached speeds of approximately 110mph, while driving on Wilkinson Rd and failed to stop at any stop signs throughout the pursuit. Deputy Kim advised the driver was wanted for 2800.2 CVC (felony evading) and 148 PC (resisting arrest).

Sgt Pullen was on scene and advised of all the information and advised that he approved the use of K9.

I drove the perimeter and gave multiple K9 warnings using my patrol car's PA system. There was no response verbally or physically from the suspect.

After I gave my K9 warnings, the California Highway Patrol's AIR21 (AIR21) arrived on scene and began to check the perimeter for the suspect. As AIR21 was checking the perimeter, I was alerted by perimeter units that they heard fence boards breaking in the area of 25TH Ave. Air21 found the suspect hiding in that backyard. Deputy Knox and I were on the street in front of the house attempting to develop a plan to take the suspect into custody. As we got to the front of the house, AIR21 advised that the suspect got up and ran southbound through multiple yards. I, along with Deputy Knox, continued to parallel the suspect on

71st St as he continued to flee southbound in backyards.

AIR21 was guiding Deputy Knox and I to the backyards the suspect was in as he fled from us. AIR21 advised that the suspect was in the backyard of 71st St. As I was standing in the street in front of 71st St, I yelled out another K9 warning. Despite the additional K9 warning, the suspect continued to flee southbound inside of the perimeter. The suspect finally appeared to stop in the backyard of 71st St. Sgt Pullen pulled up a patrol car and pointed it directly towards where the suspect was hiding. Sgt Pullen gave three additional K9 warnings over the patrol car's PA system advising the suspect that we knew he was in the backyard. The suspect immediately got up from his hiding location and fled northbound through the perimeter. It was becoming very apparent that the suspect was fleeing when K9 Hoss and I would get in close proximity to him.

AIR21 advised that the suspect was last seen in the backyard of Emerson Rd under a tree. I along with a contact team made entry into that backyard and the suspect got up and fled east. AIR21 advised the suspect was now in the backyard of Emerson Rd behind a shed. I, along with the contact team, moved to the front driveway of that residence. Officers were initially unable to get ahold of a homeowner, so I again made an additional K9 warning. A short time later the homeowner came to the door and the contact team, and I made entry into the backyard.

I then deployed my police K9 partner "Hoss" based on the following information known to me at the time:

1) The suspect was wanted for a fresh 2800.2 CVC (Felony evading) and 148 PC (resisting arrest).

2) The suspect had not been searched for any weapons at this point, and it was unknown if he was armed with anything that could be utilized against officers attempting to effect an arrest.

3) The suspect was hiding in a residential area and if the suspect was not apprehended it would pose a great risk to citizens.

4) The suspect had not been searched prior to fleeing and it was unknown if he was armed with any types of traditional and/or nontraditional weapons that could be used against officers attempting to effect the arrest without the superior apprehension capabilities of a trained police K9.

5) The suspect refused to surrender peacefully to officers after being given numerous announcements requesting him to do so, indicating that he had no intention of complying with the reasonable demands of officers to peacefully surrender.

From the west side of the backyard of Emerson Rd, I gave K9 Hoss the search command. K9 Hoss started his search and continued east through the backyard. I, along with the contact team, moved through the backyard to the eastside of the yard. I observed that K9 Hoss had located and made contact with the suspect as he was attempting to flee over a fence. I gave verbal commands for the suspect to get on the ground and the suspect complied. The contact team and I moved closer to the suspect and I took positive control of K9 Hoss and directed him to release his hold. Hoss immediately released his hold as instructed. Officers were able to safely take the suspect into custody without further incident.

I immediately requested code three fire and ambulance for medical treatment for the suspect. The Sacramento Fire Department responded and rendered first aid to the suspect's injuries. The suspect was transported to UCDMC for further treatment.

The suspect was identified as Dezjuan Washington.

Washington sustained dog bite injuries consisting of multiple avulsions on the front and back of his right thigh. There were additional rakes and punctures surrounding the avulsions on Washington's thigh. It should be noted that Washington had other injuries on his body from fleeing from officers through multiple backyards. Washington had what appeared to be two 1-inch abrasions to the right side of his head. Along with multiple 1-inch abrasions to his knees.

CSI was requested to photograph the scene and also Washington's injuries.

On Saturday August 13th 2022 at approximately 0252 hours, Officer Wilson #885 and I Officer Gonzalez #430 (2A79) responded to the area of Fruitridge Rd/ Emerson Rd to assist Sacramento County Sheriff's with a pursuit of a Black BMW. I observed the following in summary:

*****BODY-WORN CAMERA ACTIVATED*****

We responded Code 3 (lights and sirens) from 65th St and Fruitridge Rd. While en route, SSD advised that the vehicle had come to a stop and the driver had fled on foot northbound on Emerson Rd from 25th Ave.

We responded to Emerson Rd and observed a solo SSD unit on a felony stop at Emerson Rd. We assisted with a high risk vehicle stop of the vehicle and detained all occupants (passengers) without incident. Responding SPD and SSD units established a perimeter for the outstanding suspect.

While on scene, CHP AIR21 advised they observed the suspect jumping over fences on Emerson Rd and 71st Street. We maintained perimeter spots on foot on Emerson Dr trailing where the suspect was seen by the AIR unit.

CHP AIR advised the subject was hunkered down at Emerson Rd. I contacted the resident of and advised him to shelter in place.

A contact team was formed, Officer Wagstaff, Wilson, myself and two SSD deputies entered the backyard of Emerson Rd. The suspect was apprehended by K9 Hoss on the northeast corner of the residence while attempting to flee by climbing the fence on the east side of the backyard. The suspect was then taken into custody without incident.

Sacramento Fire department personnel responded to the scene and transported the suspect to UC Davis.

Per Sheriff's department radio traffic, they were in pursuit of a vehicle that terminated in the area of Vandenberg Dr. and Emerson Rd. when the driver of the vehicle fled on foot. I arrived on scene at approximately 0259 hours and observed the following in summary:

My body worn camera was activated during this investigation.

Shortly after hearing the announcement, I heard shuffling coming from the backyard of Emerson Rd. Ofc. Wagstaff advised via police radio that the suspect had been apprehended.

I responded to Emerson Rd. to assist in a neighborhood canvass.

I canvassed the following locations:

Emerson Rd.: Contacted **Example 2** and obtained their statements regarding the incident. (See witness statements.)

Emerson Rd.: No answer at the door.

During my contact with **Example 1** he advised that his cameras did not capute the suspect in the backyard of his residence, but it did activate when Officers walked him out of the yard. I provided **Example 1** with my department email to obtain copies of the footage. As of this writing I have not yet received these videos for review.

I stood by in the backyard of Emerson to preserved the scene of the K9 apprehension until CSI responded to document the scene.
