This is a summary of SPD 23-80584 that originated on 3/25/23 at approximately 1903 hours at [REDACTED] Glenburn Way, Sacramento, 95824 in SPD District 6C. The below information is what is currently known to FIT at the time of this writing and prior to the completion of all associated reports. **Summary:**

On 3/25/23, at approximately 1903 hours, the Force Investigations Team was notified of a FIT call out related to an incident that occurred [REDACTED] Glenburn Wy. FIT responded to the SPD Central Station, where Sergeant Shrum #3082 briefed the incident. FIT was provided with the following information.

On 3/25/23, at approx. 1903 hrs, SPD dispatch received a call from [REDACTED] Glenburn Wy. The caller stated that their neighbor at [REDACTED] Glenburn Wy had just come over and stated that they had been assaulted by their boyfriend, Douglas Cortez, who was armed with a knife and that he tried to use the knife to hurt the victim. The caller advised the victim stated there were two elderly residents in [REDACTED] Glenburn Wy and that the suspect had also made threats to harm them and was still inside. Responding officers advised they had prior knowledge of the suspect and that location and that the suspect had run from them prior.

At approximately 1918 hours, officers broadcast the suspect description and clothing. Upon arrival, Sgt. Shrum #3082 (3SM6), advised he heard a door slam and assumed the suspect had fled. At approx. 1919 hrs, K9 Officer Phelan #927 arrived at the scene. K9 Officer Phelan advised that he located the suspect who was walking north on Ring Dr., north of Elder Creek Rd. K9 Officer Phelan gave the suspect several announcements to stop and get on the ground. The suspect continued to walk away. K9 Shep was deployed and made contact with the suspect near 6313 Ring Dr. Officer Phelan took positive control of the K9 when the suspect surrendered. Officer O'Brien and Officer Lenoci arrived to assist K9 Officer Phelan with handcuffing the suspect.

The suspect was confirmed as Douglas Cortez, Xref [REDACTED] and was transported to UC Davis Medical Center. Once medically cleared for incarceration from UCDMC, Cortez will be booked for violations of 273.5(a) PC, 236 PC, 422 PC, 148(a) PC, and 245(a)(1) PC.

**Incident Summary:**

On 03/25/2023, at approximately 1903 hours, ██████ called Sacramento Police Department (SPD) dispatch from ██████ Glenburn Way and reported that her neighbor, ██████, from ██████ Glenburn Way, came over and said her boyfriend, Douglas Cortez, was armed with a knife and tried to use it to hurt her (██████). ██████ reported to SPD dispatchers that Douglas Cortez took ██████ phone and that ██████ had injuries to her face, including a bleeding mouth. SPD dispatchers added this information to the CAD call for responding officers.

At approximately 1906 hours, Officer Lenoci #658 (1C61) and Officer Roudebush #237 (1C63) were dispatched to the call. At 1907 hours, ██████ reported to dispatchers that ██████ said there were two elderly roommates in the residence and that Douglas Cortez was trying to stab them.

At approximately 1908 hours, Sergeant Shrum #3082 (3SM6) and K9 Officer Phelan #927 (K912) were dispatched to the call. Sergeant Shrum wrote in his report that he requested K9 to be used if the suspect fought or fled. At approximately 1909 hours, Officer O'Brien #936 and Officer Whitaker #727 (2C67) were dispatched to the call. At approximately 1909 hours, ██████ reported to dispatchers that ██████ said that Douglas Cortez had recently been released from jail ██████. Officer Lenoci advised via SPD radio that on a prior incident, the suspect named in this incident fled from officers in a vehicle but had crashed while fleeing.

At approximately 1914 hours, Officer Lenoci, Officer Roudebush, and Sergeant Shrum arrived

on scene. Sergeant Shrum wrote in his report that while on scene, he heard a loud crash at the back of the house. Officer Lenoci, Officer Roudebush, and Sergeant Shrum all reacted to the loud sound and Officer Roudebush is heard on body worn camera asking if the suspect is “going out the back.” Officer Lenoci began to check the area for the suspect in his patrol vehicle while Officer Roudebush and Sergeant Shrum continued to investigate. While on scene, Sergeant Shrum confirmed that a crime occurred.

At approximately 1916 hours, Officer Whitaker #727 and Officer O’Brion #936 (2C67) arrive on scene. Officer O’Brion dropped off Officer Whitaker to assist at the scene and searched the area in his police vehicle for the suspect. Officer Lenoci, while checking the area for the suspect, learned from witnesses that the suspect fled the area on foot by jumping fences and passing through other peoples’ property. Officer Lenoci broadcasted that information via radio. Officer Whitaker broadcast the suspect clothing description shortly after Officer Lenoci broadcast the suspect’s flight.

Officer Phelan arrived in the area of the incident at approximately 1915 hours. Officer Phelan wrote in his report that while responding, Ofc Phelan conducted a Sacramento County WebKPF records check of suspect Douglas Cortez via information provided by other officers and observed a mugshot photograph of suspect Douglas Cortez. While driving east on Elder Creek Rd, Officer Phelan wrote that he looked north on Ring Drive and saw a male wearing tan pants and a dark t-shirt walking north on Ring Drive consistent with the clothing description provided by Officer Whitaker via SPD radio broadcast.

Officer Phelan drove north on Ring Drive toward the suspect. While driving north, Officer Phelan observed tall wet grass on either side of the roadway. As Officer Phelan got closer to the male subject wearing the tan pants and dark t-shirt, Officer Phelan wrote in his report that he could see the man’s pants were wet toward the bottom, consistent with having passed through the high grass. The male turned and looked in Officer Phelan’s direction as Officer Phelan approached in his vehicle. Officer Phelan wrote in his report that he recognized the male as Douglas Cortez based on comparison to his mugshot photograph.

At approximately 1919 hours, Officer Phelan activated his overhead emergency lights and turned his vehicle toward Douglas Cortez to initiate an enforcement stop. Ofc Phelan wrote in his report that he observed Douglas Cortez look down and away, consistent with an attempt to hide his face and conceal his identity from Officer Phelan, and walk up the driveway of [REDACTED] Ring Drive toward the fence to the backyard. Officer Phelan exited his police vehicle and, while exiting, announced, “Get on the ground or you’re going to get bit.” Officer Phelan then immediately gave a second announcement saying, “Get on the ground.” Officer Phelan wrote that Douglas Cortez did not comply with Officer Phelan’s commands and instead began to walk even faster, refusing to turn around and look at Officer Phelan. Officer Phelan estimated that in the time that he activated his lights and gave the two warnings to get on the ground, Cortez had fled approximately 30 feet to the east.

Officer Phelan wrote in his report that he could see Douglas Cortez reaching toward his waistband. Officer Phelan gave commands to his K9 partner Shep and opened the rear door of his police vehicle. Officer Phelan wrote that he directed K9 Shep to apprehend Douglas Cortez based on the following reasons known to him at the time:

- *Cortez was wanted for 245 PC (Assault with a deadly weapon), 417 PC (brandishing a weapon), 211 PC (robbery of the phone), 273.5 PC (felony domestic violence causing injury), and 148(a)(1) PC (resisting arrest)*
- *Cortez was refusing to comply with my commands despite multiple requests to surrender, and a K9 admonishment, showing a high level of commitment and resistance to being detained in violation of 148(a)(1) PC*
- *Cortez had already shown high a level of resistance by his willingness to flee from Officers and jump over fences to avoid capture-Cortez posed a threat to pedestrians and passerbys if he was not detained-Cortez had not been searched for additional weapons, he was reaching for his waistband, and was believed to be armed with a knife-Cortez was within an arm's reach of the fence that led into the back yard of [REDACTED] Ring Dr and was fleeing eastbound (back toward the location of the victim*
- *I believed that if Cortez was not apprehended by K9 Shep that he may have began to jump more fences and avoid capture*
- *I was alone when I located Cortez and did not have other Officers with me for the use of alternate means of less lethal force*
- *The use of K9 in this situation would help enhance the safety of Officers tasked with apprehending Cortez on scene*

Officer Phelan wrote that when he gave K9 Shep commands to apprehend Douglas Cortez, Cortez was still actively fleeing eastbound toward the backyard of [REDACTED] Ring Dr. K9 Shep apprehended Douglas Cortez on the right calf at the fence separating the front and back yards of [REDACTED] Ring Dr at approximate 19:19:21 hours. Immediately prior to the apprehension, Officer Phelan can be heard on his body worn camera commanding Douglas Cortez to “get on the ground.” Officer Phelan wrote that during the apprehension, he observed that Douglas Cortez remained standing in a bladed stance and that his hands were down with his left hand out of view. Officer Phelan stated in his report that the left hand was the same hand he observed Douglas Cortez using to reach for his waistband during flight. Officer Phelan gave two additional commands, “Get on the ground,” to Douglas Cortez during the apprehension. Douglas Cortez did not comply with those commands.

Officer Phelan wrote that he maintained an approximately eight-foot stand-off distance from Douglas Cortez while he was being apprehended by K9 Shep because of the following:

- *He was known to be armed with a knife.*
- *I still could not see his left hand.*
- *To utilize reaction time to my advantage.*
- *I had yet to broadcast the contact via radio.*

Officer Phelan wrote that K9 Shep pulled Cortez to the ground. Officer Phelan was able to broadcast the apprehension and his location. During that broadcast, Officer Phelan wrote that Douglas Cortez grabbed K9 Shep by the snout in an attempt to pry his mouth open with his hands in an attempt to get away which caused K9 Shep to release his hold for approximately one second before re-apprehending Douglas Cortez on the right shoulder. Officer Phelan told Douglas Cortez to stop fighting his dog.

Officer Phelan moved forward and gained positive control over K9 Shep. Officer Phelan

commanded K9 Shep to release his hold of Cortez. K9 Shep released his hold at approximately 19:19:41 hours, approximately 20 seconds after the apprehension began. Officer Phelan ordered Douglas Cortez to get on the ground and then told Douglas Cortez to roll over. Douglas Cortez did not comply, lied on his back, and began to inspect his injuries. Officer Phelan told Douglas Cortez a second time to roll over. Officer Lenoci arrived on scene and ran over to assist Officer Phelan. Officer Lenoci took physical control of Douglas Cortez and rolled him onto his stomach for handcuffing. Douglas Cortez submitted to Officer Lenoci without incident and approximately 1920 hrs.

AMR EMS units arrived on scene at approximately 1926 hrs. While speaking to AMR EMTs, Cortez spoke in Spanish and indicated that he did not understand instructions in English. Douglas Cortez was transported via ambulance to UC Davis Medical Center by AMR853.

Douglas Cortez sustained puncture wounds to his right shoulder, right lower leg, and an avulsion to his right calf.

While at the hospital, Officer O’Brion obtained a Mirandized statement from Douglas Cortez utilizing Officer Bobadilla #449 as a Spanish translator. Douglas Cortez stated that he had been consuming alcohol (approximately six 12oz beers) with his girlfriend when she suddenly and inexplicably left the house. A short time later, one of the residents of [REDACTED] Glenburn Way told him that the police were on the way. He was unsure why, so he left, and went for a walk. While on the walk, he observed a police vehicle approach him from behind. He stated that he did not see the lights activated but started to run away because he was nervous. Douglas Cortez said he heard the officer tell him to stop. Douglas Cortez stated that he complied with the order, put his hands in the air, and then was bit by the police dog. Douglas Cortez said he told the officer to stop, but that he did not think the officer understood because he said it in Spanish. Douglas Cortez said that when the officer got over to him, he took the dog off of him.

Once medically cleared for incarceration from the hospital, Douglas Cortez was booked at the Sacramento County Main Jail for violations of PC §§ 273.5(a), 236, 422, 148(a), and 245(a)(1).

Regarding SPD General Order 580.14 Use of Canines, the circumstances for the deployment of K9 Shep included, but were not limited to, the following sections of the order:

- Cortez was the named suspect in a felony domestic violence incident which had just occurred and was actively being investigated by SPD officers (C.2.a)
- Cortez was believed to be armed with a knife used to threaten harm to his victim (C.2.b)
- Cortez was actively resisting officers' attempts to arrest him (C.2.e)

On March 25, 2023 at approximately 1915 hours, I (Ofc Whitaker #727) contacted Victim-[REDACTED] in front of [REDACTED] Glenburn Way and obtained her statement. [REDACTED] stated the following in summary:

Today my boyfriend, Douglas Cortez, was drinking and went crazy. He was saying that I was having a relationship with our roommate, [REDACTED]. He said he was going to kill me then kill [REDACTED]. He grabbed my hair and pulled it to try and hit my head on the ground. I wouldn't let him so he got mad and threw me on the bed. He threw my cell phone at me and it hit me in the face. Right here under my left eye is in pain. That's where the phone hit me. I had pulled the blanket up over my head to try and block it. While I was on the bed, I felt him hit me in my left thigh. Douglas was holding a knife in his hand with the blade open. It was a folding one, gray, and about 4 inches long. He said that he was going to go kill my roommate and I got in his way when he went towards the door to prevent him from doing it. That's when he punched me in my mouth. He punched me once with his right fist. My mouth is bleeding from him punching me. He told me he was going to kill our roommate then he was going to come back and kill me. He was holding the knife when he said this. I believe he would kill me and I was in fear for my safety. He opened the door and I was able to run out of the room. He chased after me. When I got outside, I was pretending to take out the trash. I saw my neighbor outside and I walked over to her and she called the police.

Douglas goes crazy sometimes. Today I asked him if he was hearing voices and he said yes. He gets really bad when he drinks. Last night he pulled my hair too. About 3 weeks ago, he pulled my hair and hit my head against the ground. That is what this lump on the back of my head is from. He has been arrested before for domestic violence against me, but I didn't want to press charges then.

I want to press charges against him.

On March 25, 2023 at approximately 1909 hours, Ofc O'Brion #936 and I (Ofc Whitaker #727) were dispatched to the area of [REDACTED] Glenburn Way in regards to a domestic violence incident. Per the text of the call, the complainant's neighbor, [REDACTED] [REDACTED] came over and advised her boyfriend (Douglas Cortez) assaulted her and was armed with a knife. Per the complainant, [REDACTED] was bleeding from the mouth. At approximately 1915 hours, we arrived on scene and I observed the following in summary:

I arrived in a marked patrol vehicle in full police uniform. All officers on scene were equipped with their body worn cameras. My in-car camera and body worn camera were both activated for the duration of the call.

Sgt Shrum #3082 and Ofc Roudebush #237 were already on scene upon my arrival.

I contacted Victim-[REDACTED] [REDACTED] out front of her house at [REDACTED] [REDACTED]. I observed [REDACTED] had multiple lacerations to her lips and had blood in and around her mouth. I also observed slight redness on her left cheekbone just under her eye, which is where she said the cell phone struck her. [REDACTED] advised she last saw her boyfriend, Douglas Cortez, inside the house armed with a knife. She advised he had been threatening to kill her and one of her roommates, who was still inside the house (see victim statement). [REDACTED] stated she last saw him wearing tan pants and a dark blue t-shirt. Officers on scene advised when they arrived, they had heard a loud sound that sounded like someone slamming a door or jumping a fence in the backyard and broadcast the information. I broadcast the suspect description for responding units.

K9 Ofc Phelan #927 located the suspect (Douglas Cortez) in front of [REDACTED] Ring Dr and apprehended him (see supplement).

Per [REDACTED]'s statement, Cortez punched her once in the face causing her mouth to bleed, pulled her hair and threw her on the bed, threw a cell phone at her which struck her near her left eye, prevented her from leaving the bedroom and said the only way she was leaving the room was if she called the cops but would be dead before they got there, and threatened to kill her while holding an open pocket knife in his hand. [REDACTED] advised she was able to run out of the house when Cortez opened the door after telling her he was going to go kill their roommate. [REDACTED] saw her neighbor, [REDACTED] [REDACTED] (complainant), outside and was able to run to safety.

Cortez was placed under arrest for domestic violence causing injury (273.5PC), false imprisonment (236 PC), criminal threats (422 PC), assault with a deadly weapon (245 PC), and resisting arrest (148 PC). He was transported to a hospital for medical treatment then later booked at the Sacramento County Main Jail without incident.

Ofc Roudebush contacted [REDACTED] and obtained her statement (see supplement).

Ofc Bobadilla #449 contacted the other residents at [REDACTED] Glenburn Way and obtained their statements (see supplement).

On 3-25-2023 at approx 19:08 hours, while on patrol in a marked Police K9 vehicle and in full Police uniform, I, Officer Phelan #927 and my K9 partner Shep responded to the area of [REDACTED] Glenburn Way regarding a domestic violence call involving a weapon. Per the text of the call, the complainant advised the suspect (Douglas Cortez) had assaulted his girlfriend and was armed with a knife. The complainant also advised the victim was bleeding from the mouth and that Cortez had brandished the knife at the victim before taking the victim's phone and was attempting to stab other subjects on scene before walking into his house. The complainant also advised Cortez had just been released from jail for child abuse. While responding to the call Officers advised via radio that the last time they attempted to contact suspect Cortez, he fled in a vehicle from Officers. Prior to arriving on scene I conducted a Web KPF records check of suspect Cortez via the information attached to the call by responding Officers. I observed a frontal mugshot taken of Cortez on 1-21-2023 and read his physical descriptors provided by Web KPF (male hispanic, black hair, 5'9" tall, 170 pounds).

[REDACTED] Officers Lenoci #658, O'Brion #936, and SGT Shrum #3082 arrived at the call location while I was still responding. SGT Shrum advised that they heard Cortez run out of the back of the house and possibly jump a fence. Officer O'Brion advised via radio that he contacted a witness that saw Cortez fleeing the area on foot southbound wearing tan pants and a dark navy t-shirt. I came into the area of the call at approx. 19:15 hours, I observed the following in summary:

While responding to the call location I was traveling eastbound on Elder Creek Rd from Highway 99. I was looking northbound on neighboring streets for suspect Cortez while responding.

I observed a light complected male wearing tan pants and a dark t-shirt walking northbound on Ring Dr as I passed Ring Dr while driving eastbound on Elder Creek Rd. I contacted SGT Shrum via radio to confirm the time of when the suspect fled. SGT Shrum stated he believed the suspect fled out the back as Officers were arriving on scene.

I completed a u-turn and proceeded northbound on Ring Dr from Elder Creek Rd in my patrol vehicle. There was tall fresh green grass that was still wet from a recent rain growing up and down the east and west sides of Ring Dr. As I approached the subject matching the description of suspect Cortez, I could see that the lower half of both of his pant legs were wet indicating that he may have just ran through tall wet grass. As I got closer to the subject he turned and looked my direction. At this time I positively identified this male as suspect Cortez via his booking photo I had observed earlier.

I activated my overhead red and blue emergency lights to initiate an enforcement stop on suspect Cortez.

As soon as Cortez looked back at my vehicle and saw me, he immediately looked the other direction (down and away) to keep me from further seeing his face and turned eastbound and began to walk down the driveway of [REDACTED] Ring Dr while reaching near his waistband. Cortez was walking straight for the north fence that led to the back yard of [REDACTED] Ring Dr. I exited my patrol vehicle and attempted to deescalate the contact by giving Cortez a K9 warning. I yelled in a loud voice "Get on the ground or you are going to get Bit". Cortez did not comply with my commands and continued to walk toward the fence that led to the back yard of [REDACTED] Ring Dr. I then ordered Cortez to get on the ground again, yelling in a loud voice "Get on the ground". Cortez did not comply with my commands and instead began to walk even faster refusing to even

turn around and look at me (captured on my ICC). When I activated my overhead lights to initiate the stop Cortez was standing near where the driveway of [REDACTED] met the east curblin of Ring Dr. From the time I initially activated my overhead lights and and completed my two warnings to get on the ground, Cortez had fled approx. an additional 30 feet to the east.

At this time I directed K9 Shep to apprehend suspect Cortez based on the following facts known to me at the time:

- Cortez was wanted for 245 PC (Assault with a deadly weapon), 417 PC (brandishing a weapon), 211 PC (robbery of the phone), 273.5 PC (felony domestic violence causing injury), and 148 (a)(1) PC (resisting arrest)

- Cortez was refusing to comply with my commands despite multiple requests to surrender, and a K9 admonishment, showing a high level of commitment and resistance to being detained in violation of 148(a)(1) PC

- Cortez had already shown high a level of resistance by his willingness to flee from Officers and jump over fences to avoid capture

- Cortez posed a threat to pedestrians and passerbys if he was not detained

- Cortez had not been searched for additional weapons, he was reaching for his waistband, and was believed to be armed with a knife

- Cortez was within an arm's reach of the fence that led into the back yard of [REDACTED] Ring Dr and was fleeing eastbound (back toward the location of the victim)

- I believed that if Cortez was not apprehended by K9 Shep that he may have began to jump more fences and avoid capture

- I was alone when I located Cortez and did not have other Officers with me for the use of alternate means of less lethal force

- The use of K9 in this situation would help enhance the safety of Officers tasked with apprehending Cortez on scene

I gave K9 Shep the command to apprehend Cortez as Cortez was still fleeing eastbound toward the back yard of [REDACTED] Ring Dr. K9 Shep apprehended Cortez on his right calf. Cortez was still standing in a bladed stance with his hands down and his left hand out of view (the same hand I observed reaching for his waistband). I ordered Cortez to get on the ground again. Cortez did not comply. I maintained a standoff distance of approx 8 feet from Cortez due to the fact that he was known to be armed with a knife, I still could not see his left hand, to utilize reaction time to my advantage, and I had yet to broadcast the contact via radio. K9 Shep pulled Cortez to the ground. I advised via radio that I had located the suspect and that Cortez had been apprehended by a Police K9. Cortez then grabbed K9 Shep by his snout in an attempt to pry his mouth open with his hands in an attempt to get away, causing K9 Shep to release his hold for approx 1 second before re-apprehending suspect Cortez on his right shoulder. I ordered Cortez to stop fighting my dog. At this time I gained positive control of K9 Shep and ordered K9 Shep to release his hold of Cortez. K9 Shep let go of suspect Cortez and I ordered Cortez to roll over onto his stomach. Cortez did not comply and had to be pulled onto his stomach by Officer Lenoci who had just arrived.

Cortez was then placed in handcuffs by Officer Lenoci and Fire Personnel were requested to respond to the scene. I utilized trauma shears to remove Cortez's clothing to further evaluate if Cortez needed

additional emergency first aid prior to Fire Personnel arriving.

Cortez suffered multiple punctures on his right shoulder, multiple punctures on his right calf, and one avulsion on his right calf consistent with injuries one would sustain from a K9 apprehension.

Sacramento Fire Department Personnel treated Cortez's injuries on scene before he was transported to UC Davis Medical Center by AMR853.

Officer Lenoci and I conducted a neighborhood canvass for witnesses to the incident. I contacted [REDACTED] (witness) at [REDACTED] Ring Drive and obtained her statement (see attached). [REDACTED] advised she did not have security cameras on her residence. I attempted to contact residents at [REDACTED] Ring Dr, but received no answer. I did observe a camera mounted to the front of [REDACTED] Ring Dr, but it did not appear to be mounted in a position that would have recorded the incident.

SPD CSI was requested to respond to the scene for photographs and to the hospital to photograph Cortez's injuries.

My body worn camera and my in car camera were activated and recording during this investigation.

SGT Shrum (3SM6) and LT Morse (LN25) were on scene and aware of the details on the call.

I, Sgt. Shrum #3082 am a patrol supervisor for the Sacramento Police Department. I work in uniform and drive a marked Sacramento Police vehicle.

On 3/25/2023, I was supervising District 6 when at 1903 hours, a call came out to [REDACTED] Glenburn Way advising that a neighbor came over after being beat by her boyfriend- Douglas Cortez MH24 and that he was armed with a knife and tried to use it. Additional information came in that he was in the house trying to stab elderly roommates with the knife. The weapons call is a 3 officer call and initially only two were available. I requested K9. to be used if the suspect fought or fled and Ofc. Phelan began responding.

Ofc. Lenoci broadcast that Sacramento PD contacted the suspect at the location before and he fled in a car but crashed.

I arrived along with Ofc. Roudebush. When we arrived, victim [REDACTED] was out front. She had some minor injuries to her face. We confirmed that there was a good 273.5(a) PC want and the suspect was likely still armed with a knife. She advised the suspect was inside.

Shortly after arriving, I heard a loud crash at the back of the house that seemed it was possibly outside the house. I again requested an air unit but none was available. A unit advised that they had a neighbor advising he was away from the house walking southbound on Fall River Way.

Units began checking the area and K9 Ofc. Phelan requested the suspect description.

Ofc. Roudebush and I made contact at the house and the front door was opened by an elderly female that spoke Spanish. There was also an elderly male that spoke Spanish. Neither had been stabbed or hurt. The suspect was not in the house. While in the house, K9 Ofc. Phelan broadcast that his dog was on the suspect on Ring Av.

I requested that CSI respond (forr photos of the victim, photos of the suspect, photos of the apprehension scene). CSI responded. Officers began taking statements and looking for additional witnesses at the original scene. Spanish speaking officers were requested to assist.

I responded to Ring Av north of Elder Creek Rd (a street over) where the apprehension took place. Fire/EMS had already responded. Ofc. O'brion was going to the hospital with the suspect. K9 Ofc. Phelan advised there was some blood at the house where the apprehension took place. Ofc. Phelan and Ofc. Lenoci conducted a canvas of the neighboring houses for witnesses and video surveillance.

Ofc. Lenoci briefly gave me keys and a phone thought to belong to the victim but he took them back shortly prior to responding back to the original house.

I confirmed that the suspect was medically treated and requested that officers ask that he sign a medical release for records related to the arrest.

The suspect was arrested for multiple charges related to the incident.
