# 510.14 UNIT IDENTIFIERS 06-11-09

#### **PURPOSE**

The purpose of this policy is to establish unit identifiers for the expedient assignment of calls.

#### **POLICY**

It shall be the policy of the Sacramento Police Department that unit identifiers be used when dispatching calls.

# **PROCEDURE**

#### A. PATROL OFFICER IDENTIFIERS

Unit identifiers for police officers assigned to patrol units on the watches shall consist of:

- 1. The number of officers assigned to a vehicle (1 or 2).
- 2. The shift the officer is assigned.

(f) Alpha	LateWatch	Α	2100-0700

- 3. The district the unit is assigned.
  - (a) Unit identifiers with a: "1" designate the Northwest District.
  - (b) Unit identifiers with a "2" designate the Northeast District.
  - (c) Unit identifiers with a "3" designate the Central District.
  - (d) Unit identifiers with a "4" designate the Southwest District.
  - (e) Unit identifiers with a "5" designate the South District.
  - (f) Unit identifiers with a "6" designate the East District.
- 4. The beat for which the unit is responsible.
  - (a) Unit identifiers ending in "1," "2," or "3" designate an "A" beat unit.
  - (b) Unit identifiers ending in "4," "5," or "6" designate a "B" beat unit.
  - (c) Unit identifiers ending in "7," "8," or "9" designate a "C" beat unit.
- 5. Examples: 2A68 =1B22 =1C46 =(2) Officers (1) Officer (1) Officer (A) Late (B) Day (C) Mid (6) District 6 (4) District 4 (2) District 2 (2) Beat A (8) Beat C (6) Beat B

#### B. COMMUNITY SERVICE OFFICER IDENTIFIERS

Unit identifiers for Community Service Officers assigned to patrol shall consist of :

- The shift the CSO is assigned.
  - (a) Late Watch = 1
  - (b) Day Watch = 2
  - (c) Mid Watch = 3
- 2. The identifier CS (CSO)
- 3. The district the CSO is assigned.
- 4. Examples: 1CS50 is a Late Watch CSO assigned to District 5

2CS30 is a Day Watch CSO assigned to District 3

3CS20 is a Mid Watch CSO assigned to District 2

#### C. PATROL SERGEANT IDENTIFIERS

Unit identifiers for sergeants assigned to patrol shall consist of:

- 1. The shift the sergeant is assigned.
- 2. The identifier SM (Sam)
- 3. The district the sergeant is assigned.

4. Examples: 1SM6 is a Late Watch Sergeant assigned to District 6

2SM3 is a Day Watch Sergeant assigned to District 3 3SM1 is a Mid Watch Sergeant assigned to District 1

# D. <u>WATCH COMMANDER IDENTIFIERS</u>

Unit identifiers for lieutenants (watch commanders) shall consist of:

- 1. The identifier LN (Lincoln).
- 2. The number following identifies the specific lieutenant.

# F. <u>ADDITIONAL IDENTIFIERS</u>

Unit identifiers assigned to other department employees shall consist of:

- 1. a designator identifying the assignment/responsibility.
- 2. a number assigned to the officer.

- 2. a number assigned to the employee.

- 1. a designator identifying the assignment/responsibility.
- 2. a number assigned to the employee.

#### I. INCIDENT COMMAND SYSTEM (ICS)

- Unit identifiers for the Incident Command System (ICS) are assigned when a disaster or major operation is announced and, as a result of the incident, the ICS is implemented.
   NOTE: The State of California requires that these unit identifiers be available for use in the event mutual aid is required from outside the operational area (county).
- 2. The following ICS unit identifiers can be found in the Police Unit (PUNIT) file of the CAD system:

# J. <u>WATCH COMMANDER SHALL ENSURE</u>:

- 1. No other unit identifiers are assigned or used.
- 2. Unit identifiers are correctly used.

#### K. ADDING UNIT IDENTIFIERS

- 1. The following procedure shall be used to add/create new unit identifiers:
  - a. Verify that one does not already exist that could be used.
  - b. Forward a written request to the Communications Manager and the CAD support team with a proposed identifier, including its definition.
  - c. The CAD support team shall ensure that the identifier does not conflict with any other CAD identifier or command and is acceptable for typing and verbal syntax.
  - d. If the proposed identifier is accepted, the requestor shall make all necessary notifications to other radio users and Communications explaining what the new identifier is and how it shall be used.
- 2. No other means of adding unit identifiers shall be accepted.
