Abandoned Vehicles

Contact Sacramento 311 and request service for CODE ENFORCEMENT.

Abandoned and nuisance vehicles are handled by City Code Enforcement, not Parking Enforcement.

The 311 Agent will ask:

- If the vehicle has not moved from same spot on the street for a minimum of 72 hours
- If the vehicle appears inoperable
- Vehicle color, make, and model
- Street or address where vehicle is parked.

A service request ticket will be created in the system for a Code Enforcement Officer to respond.

Reporting parking violations

Contact Sacramento City 311 to request Parking Enforcement service for parking violations that may include, but are not limited to, vehicles parked:

- blocking a driveway
- on the sidewalk
- within 15- 20 feet of a marked or unmarked crosswalk
- obstructing a crosswalk
- in a bus zone or bike lane
- · without authorization on private property
- · illegally with a residential permit

Unattached trailers & boats

Sacramento City Code section 10.36.080 prohibits the parking of any unattached trailer, semitrailer, or equipment as defined by California Vehicle Code section 225, for more than 4 hours on the street in a 24-hour period.

Violations of this city code may be reported to Parking Enforcement by contacting Sacramento City 311.

Confidentiality

The name of the person reporting a parking violation will not be disclosed to any party aside from City enforcement personnel who need access to that information. Reports may be submitted anonymously to Sacramento City 311.

Residential Parking Permits (RPP)

- Free of charge
- · Fee is charged for replacement of any physical permit
- · Only available to eligible residents in RPP areas
- Check the signage on the street section of your property to determine if you are in an RPP area
- Residential Vehicle Permits and Temporary 24-hour Permits are enforced by license plate number.

Required Documentation

One or more of the following are required, depending on the permit type

Valid DMV registration: Must reflect driver's name and physical address where the residential permit will be registered.

Proof of Residency: Must reflect driver's name and physical address on a utility bill, bank statement, mortgage statement, or similar verfication showing proof that the driver lives at that residence

Valid Driver's License or CA ID: Must reflect driver's name and physical address where the residential permit will be registered.

Help Stop Disabled Person Permit Abuse

The City of Sacramento has an undercover unit dedicated to the enforcement of Disabled Person Permits. Misuse of a DP permit (placard or plate) is a misdemeanor under California law and may result in fines and court appearances.

Disabled Person Permit in California:

Vehicles with valid DP permits (placard or plate) are **exempt under California law** from:

- Meter payments on the street
- Time zone restrictions (except at certain loading zones)
- Residential Permit Parking restrictions

Requests for Parking Enforcement

To request parking enforcement assistance or report parking violations, please contact Sacramento City 311.

Due to the large volume of schools in the Sacramento area, Parking Enforcement cannot guarantee enforcement at every school site every day. Requests will be serviced when officers are available,

To accommodate guest parking, RPP residents may register for free 24-hour Temporary permits online at sacpark.org. The guest's license plate number is required.

For larger parties, please call Sacramento City 311 with the event date, time, and number of vehicles expected.

Information related to permits or license plates are kept confidential under California state law. This includes exemptions from disclosure to requests made under the California Public Records Act, unless the request is from the legally registered vehicle owner.
