On-Street Operations

Parking Enforcement Officer Parking Enforcement Supervisor

This team is the division's largest, with 59 members who enforce all parking regulations, issue parking citations, monitor safety on the street, perform traffic control duties, and provide support to the Sacramento Police Department and City Code Enforcement, when needed.

Parking Enforcement Officers are initially hired as part-time, with 20 guaranteed hours. There is an option each week to work an additional 20 hours per week. Full-time (40 hours/week) status is offered when those positions become available.





The City of Sacramento Parking Division employs 148 positions ranging from front-line operations to administrative support teams.

The division is comprised of seven sections, each led by a manager, and one division manager who oversees the entire operation:

- Fiscal
- On-Street Operations
- Parking Revenue Operations
- Infrastructure & Technology
- Strategic Management & Policy Planning
- Business & Client Relations
- Sacramento Marina Operations



Parking Services Division

Technology & Infrastructure

Parking Meter Repair Worker Maintenance Worker Custodian I/II Facilities Maintenance Supervisor

The Technology & Infrastructure team of 14 members ensures all facilities, equipment, and parking systems are operating to support all other division sections. This team works tirelessly throughout different shift times to keep operations seamless to customers.

All positions are Career, Full-time at 40 hours per week with shift times that vary according to classification.



Marina Operations

Boating & Marina Facilities Attendant Marina Aide

This team of nine is managed by the City Marina Manager and operate the Sacramento Marina all seven days of the week. Shifts depend on the classification and uniform shirts are provided. Interested candidates should have knowledge of marine operations, water safety, customer service skills, and willingness to work in inclement weather. Attendants work full-time while Aides work part-time (non-career).



Revenue Operations

This team manages the intake of revenue at parking meters and in City off-street facilities (parking garages and lots). This team of 33 is comprised of Parking Meter Coin Collectors, Parking Lot Attendants, Senior Parking Lot Attendants, and Parking Lot Supervisors.

Parking Lot Attendants are hired as parttime, with 20 guaranteed hours and the option to work an additional 20 hours per week. This position is Career, Parttime. Senior Parking Lot Attendants and Parking Lot Supervisors are all Career, Full-time.

All employees in "operations" classifications are required to wear work uniforms for their safety and visibility to the public while working on City equipment or structures in the field. Uniforms are provided and professionally cleaned on a weekly basis by the Parking Services Division.

Administrative Support

All sections of the Parking Services Division have a combination of administrative classifications that provide direct support to the operation. These positions are Career, Full-time (40 hours/week) and require both office and fieldwork.

There are no uniforms required for administrative staff. However, professional business casual attire is preferred because these positions may encounter City Council staff, the public, and other department staff.
