

**PRIVATE DEVELOPMENT FEE SCHEDULE**

This fee schedule is provided to summarize the most common fees utilized by the Department of Public Works for Public Works reviews of Planning, Mapping, and Public Works permit applications. Reference should be made to the resolution for full details of the fee or deposit.

Every effort will be made to minimize the staff costs required to perform each task listed below. However, changes to the project, public opposition or other factors can necessitate additional expenses for City staff time in excess of the initial fees or deposits listed below. If required, additional fees or deposits will be collected prior to final approval. The applicant will be named on all invoices and shall be responsible for payment. Should an applicant withdraw their application, the applicant shall be entitled to a refund of the deposit/fees paid, less actual cost (including staff cost/consultant charges) incurred by the City on the applicant's behalf or shall be billed for all costs over the initial deposit.

The fees listed in this section include fees for Public Works and Utilities Departments. The fee listed will be collected at time of application; the actual cost will be collected prior to submission to the approving authority (billing may occur periodically or monthly as deemed necessary).
