

## **RESOLUTION 2025-0194**

Adopted by the Sacramento City Council

June 24, 2025

### **Adopting and Implementing the Sacramento Urban Forest Plan**

#### **BACKGROUND**

- A. The City desires to adopt and implement the Sacramento Urban Forest Plan. The Sacramento Urban Forest Plan will serve as a 20- year guiding document for the City's vision and goals related to trees and will direct staff work planning.
- B. The Sacramento Urban Forest Plan is a subsequent project under the City's 2040 General Plan and Master Environmental Impact Report (EIR) and has been developed in conjunction with the 2040 General Plan Update.
- C. On June 24, 2025, the City Council adopted a resolution of environmental determination for the Sacramento Urban Forest Plan as a subsequent project under the Master EIR for the 2040 General Plan, conducted a noticed public hearing, and considered public testimony concerning the Sacramento Urban Forest Plan.

#### **BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

##### **SECTION 1.**

The City Council has considered all of the evidence submitted into the administrative record, including Resolution 2025-0193 approving the environmental review for the Sacramento Urban Forest Plan as a subsequent project under the Master EIR for the 2040 General Plan.

##### **SECTION 2.**

Based on the evidence contained in the administrative record, the City Council finds as follows:

- A. Preparation of the Sacramento Urban Forest Plan included outreach to provide for the involvement and input of residents, businesses, other public agencies, and civic, educational, and other community groups. The public review draft of the Sacramento Urban Forest Plan was referred out for public feedback and all comments received were considered.

- B. The Sacramento Urban Forest Plan is a policy and guiding document consistent with the 2040 General Plan and serves to guide Sacramento in its long-term growth and development. The Sacramento Urban Forest Plan is a subsequent project of the 2040 General Plan.
- C. The Sacramento Urban Forest Plan will serve as a 20-year guiding document for the City's vision and goals related to trees and will direct staff work planning.

### **SECTION 3.**

Approval and Implementation. Based on the administrative record and the foregoing findings, the Sacramento Urban Forest Plan is approved.

### **SECTION 4.**

The City Manager or designee is authorized to establish a working group with City staff and key tree careholders. The working group will review and jointly develop ways to effectively implement the Sacramento Urban Forest Plan strategies, policies, and actions, subject to City approval.
